Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Positive Beginnings, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Note 1 – Description of Plan

The following description of the Positive Beginnings, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Positive Beginnings, Inc. (the “Company”) who have completed 3 months of service and are age twenty-one or older. The Plan excludes any employee who is covered by a collective bargaining agreement, is a non-resident alien or is an hourly employee. Participants are eligible for the Company profit sharing contribution upon completion of one year with 1,000 hours of service. Effective July 1, 2019, in order to share in the allocation of profit-sharing contributions, a participant is required to complete 1,000 hours of service in the applicable Plan year and be employed by the Company on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has individually designated trustees who are responsible for oversight of the Plan, determine the appropriateness of the Plan’s investment offerings and monitor investment performance.

The Plan was amended on December 8, 2022, with a retroactive effective date of March 27, 2020, to implement the provisions of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) which affect the Plan and include the coronavirus-related distributions relief provisions; the increased loan limit provisions; the loan repayment extension; and the Required Minimum Distribution waivers for 2020 unless the participant or beneficiary chose to receive the distribution.

Effective July 1, 2022, the Plan sponsor retained The Retirement Advantage, Inc. (TRA) to serve as the Plan’s third party administrator and provide certain additional recordkeeping services. On March 2, 2023, the Plan was amended and restated with a retroactive effective date of July 1, 2022, to adopt the TRA prototype plan documents. There were no changes to the Plan’s provisions resulting from the restatement of the Plan documents. Fidelity Management Trust Company continues to serve as the Plan’s trustee and Fidelity Workplace Services LLC continues to provide recordkeeping services.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Participants may also contribute after-tax in accordance with the Roth provisions of the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a profit-sharing contribution at the sole discretion of the Company’s board of directors which is invested in a portfolio of investments as directed by participants. Profit-sharing contributions are allocated at the end of the plan year. For the year ended June 30, 2024, the Company made a discretionary profit-sharing contribution of \$750,000 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and Company profit-sharing contributions, if any. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. The note interest rate, determined quarterly, is set at prime plus 2%, as defined. Principal and interest is paid ratably through bi-monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or for other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or series of installments payable monthly over a certain period, as defined in the Plan.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$195,514 and \$296,095, respectively. These accounts will be used to pay administrative expenses of the Plan, and any remaining forfeitures shall be used to reduce future Company contributions. For the Plan year ended June 30, 2024, forfeitures totaling \$39,827 were reallocated to participants accounts as additional profit sharing contributions and forfeitures totaling \$105,096 were used to restore to participants' accounts amounts improperly forfeited during the prior year (see Note 10 and also Note 11). Forfeitures were not used to pay administrative expenses of the Plan during 2024.

Recent Regulatory Event

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with various effective dates beginning January 1, 2023 and beyond. These provisions are intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules. Some of the provisions are optional and require the Plan sponsors to amend the Plan to adopt the provision.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers and insurance company. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through the date of the report, which is the date the financial statements were available to be issued. See Note 11 for disclosure of subsequent events.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Money market fund: Valued at cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust (CCT): A stable value collective investment trust which is composed primarily of fully benefit-responsive guaranteed investment contracts (GICs), separate account GICs, and security backed investment contracts. The CCT is valued at the NAV of units of the bank collective trust. The NAV per unit is calculated as of the close of trading on the New York Stock Exchange and is computed by dividing the total fair value of the assets of each fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in each fund and included in the determination of unit value. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Note 4 – Insurance Contracts

The Plan maintains a guaranteed investment contract, the Voya Fixed Account, issued by Voya Retirement Insurance and Annuity Company (Voya). The contract's underlying investment options are considered fully benefit-responsive. As of June 30, 2024 and 2023, the contract value of the guaranteed investment contract was \$895,761 and \$1,989,785, respectively. The Voya Fixed Account is an obligation of Voya's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include: (1) amendments to the Plan documents, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify from exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreements without the consent of the issuer.

Note 5 – Related Party and Party-In-Interest Transactions

Certain investments held by the Plan are managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company, the Plan's trustee. These transactions qualify as exempt party-in-interest transactions.

Fidelity Workplace Services, LLC, an affiliate of Fidelity Management Trust Company, provides recordkeeping services to the Plan and earns income from mutual fund companies for services they provide to the Plan through a revenue sharing arrangement. Fees incurred by the Plan for the investment management and recordkeeping services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Direct payments made by the Plan to third party service providers for administrative services are included in administrative expenses and amounted to \$27,001 during 2024. The Company pays directly any other fees related to the Plan's operations. These transactions qualify as exempt party-in-interest transactions.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 7 – Tax Status

The Plan is structured and follows a prototype non-standardized profit sharing plan with cash or deferred arrangement (CODA) pre-approved by the IRS. The IRS issued an opinion letter dated June 30, 2020, that the prototype non-standardized profit sharing plan with CODA is acceptable in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to examinations for three years.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 9 – Custodian/Trustee Certifications

Certain information disclosed in the accompanying financial statements and supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year), related to the Voya Fixed Account insurance contract held by Voya at June 30, 2024 and 2023, and related investment income for the year ended June 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Voya.

Certain information disclosed in the accompanying financial statements and supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year), related to all other investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

Note 10 – Compliance Matter

During 2023, the Company identified an error in the implementation of a participant's elective deferral election that impacted the participant's 2023 and 2022 deferrals. During March 2024, the Company made a qualified non-elective contribution plus the lost earnings totaling \$1,365 to compensate the participant for the missed deferrals. An employer contribution receivable totaling \$1,000 related to this error is included in the statement of net assets available for benefits as of June 30, 2023.

During 2023, the Plan administrator also identified an error in the amounts forfeited during 2022 from a limited number of terminated participants' accounts who had breaks in service. It was identified that the demographic data provided to the Plan's new recordkeeper when the Plan transitioned service providers during 2022 did not include original hire dates which impacted those participants' vesting and resulted in partially vested balances being improperly transferred from the affected participants' account balance to the forfeiture account. During 2024, the Company reviewed the forfeiture account activity and restored \$105,096 of forfeitures improperly forfeited from participants' accounts.

Note 10 – Compliance Matter (continued)

During 2022, the Company identified a financial reporting error related to the notes receivable from participants balance that transferred to Fidelity when the Company changed service providers. During 2023, the Plan administrator reconciled the notes receivables activity and instructed the third party administrator to make certain corrections to affected participants' notes receivable balances. It was subsequently identified that not all corrections to the notes receivable balances had been processed as of June 30, 2023. These accounts were fully corrected during 2024.

Note 11 – Subsequent Event

In August 2024, the Company reallocated forfeitures totaling \$33,305 as additional employer profit contributions for the June 30, 2023 Plan year and forfeitures totaling \$138,914 as additional employer profit sharing contributions for the June 30, 2022 Plan year. The forfeitures were reallocated to eligible participants as of the applicable Plan year using the same age and salary weighted methodology used to allocate the profit sharing contribution.
