## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the KENCCID 403(b) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the KENCCID 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended June 30, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of Plan**

The following description of the KENCCID 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Kensington Community Corporation for Individual Dignity (the "Organization"). The Organization promotes dignity and choice to empower individuals with intellectual and developmental disabilities to reach their full potential. The Plan's original effective date was July 1, 1995. The Plan was most recently amended and restated effective September 7, 2017. Non-resident aliens, with no earned income from the Organization that constitutes income from sources within the United States, are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The custodian and recordkeeper of the Plan is Principal Trust Company ("Principal"), a member of Principal Financial Group. The Organization is the Plan administrator.

**Eligibility**

The Plan covers eligible employees of the Organization as defined in the Plan document. Eligible employees are immediately eligible to make voluntary salary reduction contributions as of their date of hire. The Plan also provides for a discretionary matching contribution and a discretionary employer contribution. An eligible employee may enter the Plan as an active member on or after the date on which he or she meets all the entry requirements. Entry dates for the discretionary employer and matching contribution are July 1 and January 1. For the discretionary matching and employer contributions, a participant must complete 1,000 hours of service with the Organization in the given Plan year. There is no age requirement for discretionary matching and employer contributions; however, a participant must be employed on the last day of the Plan year in order to share in the discretionary matching and employer contributions, should one be declared.

**Contributions**

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan document. Participants may also make deferrals to the Plan on an after-tax basis in accordance with the Roth elective deferral contributions provisions. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions up to the amount allowable under the Internal Revenue Code. In no event may participant pre-tax or after-tax contributions exceed statutory limitations.

For the Plan year ended June 30, 2024, the Organization did not contribute a discretionary matching contribution nor a discretionary employer contribution to the Plan.

During October 2023, the Organization determined additional employer contributions of \$3,400 were required to be funded to one participant of the Plan who was entitled to receive such contribution related to the 2021 Plan year.

Participants may also contribute amounts representing distributions ("rollovers") from other qualified defined benefit or contribution plans.

**Investments**

Upon enrollment in the Plan, and throughout the Plan year, a participant may direct employee and employer contributions in selected investment options, including registered investment companies (mutual funds) and the Principal Fixed Income Guaranteed Option.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Organization's discretionary matching contributions, if any, as well as allocations of the Organization's discretionary employer contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant

transactions, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

**Vesting**

Participants are immediately fully vested in their elective deferral contributions, employer contributions, rollover contributions and earnings thereon.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant (or beneficiary) may elect to receive the value of the vested interest in his or her account as a lump-sum distribution. If a distribution is not requested and the balance is between \$1,000 and \$5,000, the account balance will be transferred by the Plan administrator to an individual retirement account established on behalf of the participant. In circumstances when a terminated participant has a vested account balance less than \$1,000, the participant's vested account balance shall be distributed in a lump sum. Hardship withdrawals are allowed by the Plan provided they meet the Internal Revenue Service ("IRS") guidelines. A participant may also withdraw all or a portion of their entire account balance upon attainment of age 59 ½.

**Notes Receivable from Participants**

Loans to participants are permitted under the Plan and are treated as a participant-directed investment. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum generally equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have two loans outstanding at any time. Loan transactions are treated as a transfer from (to) the investment fund to (from) the loan fund. Participant loans bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator.

Loans are repayable within five years unless the loan was taken for the purchase of a primary residence, in which case the term of the loan may not exceed 10 years. Loan principal and interest are paid ratably through payroll deductions. The loans are secured by the balance in the participant's account.

**2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and its related activity on a contract value basis (see Note 5).

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions**

Contributions from Plan participants and discretionary matching contributions from the Plan Sponsor, if any, are recorded in the year in which the employee contributions are withheld from compensation. Discretionary employer contributions from the Plan Sponsor, if any, are recorded in the year earned.

**Payments of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses and custodian fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses of maintaining the Plan that are paid directly by the Organization are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation or depreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the custodian of the Plan and a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contract, at contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024.
- The information for all registered investment companies, guaranteed interest contract and participant loans listed in the schedule of assets (held at end of year) as of June 30, 2024 as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at June 30, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

**5. Fully Benefit-Responsive Investment Contract**

At June 30, 2024 and 2023, the Plan has a guaranteed interest contract with Principal in the amounts of \$5,050 and \$1,518, respectively. The Principal Fixed Income Guaranteed Option is a traditional investment contract and meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Principal maintains the contributions in a general account. This is a guaranteed general-account backed group annuity contract, issued by Principal Life Insurance Company. A rate of interest contractually guaranteed by Principal Life Insurance Company is credited to participant account balances. No redemption fees, early withdrawal charges, or market value adjustments are charged on participant transfers of assets into or out of the contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Principal Fixed Income Guaranteed Option at contract value on a daily basis. Direct transfers to competing investment options are not permitted. Any transfers out of the Principal Fixed Income Guaranteed Option must first go through a non-competing investment option and reside there for a minimum of ninety days before transfer to a competing investment option. An employer-level surrender of the Plan's interest or initiated transfer will be subject to either a twelve-month advance notice or a 5% surrender charge, whichever the Plan fiduciary chooses. The Principal Fixed Income Guarantee Option may make available higher guaranteed rates. If these are available and the Plan fiduciary chooses to move a plan's interest to a higher guaranteed rate, a charge of 1.5% of the Plan's interest applies. The minimum interest crediting rate is 1%.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan sponsor believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is remote. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

## **6. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The Organization has adopted a prototype plan document sponsored by Principal Financial Group. The IRS issued an opinion letter, dated March 31, 2017, stating that the form of the prototype plan document was in compliance with the applicable requirements of the Code as of that date. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). Although the Plan has been amended since adopting the prototype plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of Section 403(b) of the Code, and, therefore, believes that the Plan is qualified and the related custodial accounts are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to June 30, 2021.

## **7. Related-Party and Party-In-Interest Transactions**

For the year ended June 30, 2024, fees paid by the Plan to Principal and its related entities amounted to \$25,947. Principal provides recordkeeping services and the Plan invests in registered investment companies and the Principal Fixed Income Guaranteed Option managed by Principal. The Plan also permits notes receivable from participants. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Certain fees incurred by the Plan for investment management services are included in the net appreciation or depreciation in fair value of investments. Fees paid directly from participant accounts, including those for the administration of participant loans, are included in administrative expenses.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated or upon complete discontinuance of contributions, the rights of the participants in the Plan at the date of termination or discontinuance shall be nonforfeitable.

**9. Risks and Uncertainties**

The Plan utilizes various investment options. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**10. Subsequent Events**

As part of the transition of service providers from Principal to Mutual of America as recordkeeper and Mid Atlantic Trust Company as custodian, the Plan was amended and restated effective July 1, 2024.

The Plan has evaluated subsequent events through March 17, 2025, which is the date the financial statements were available to be issued.
