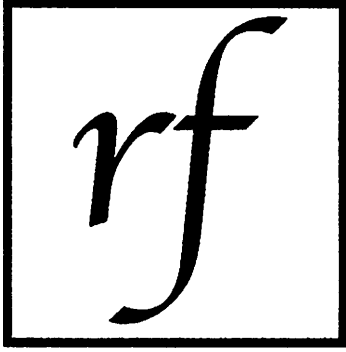

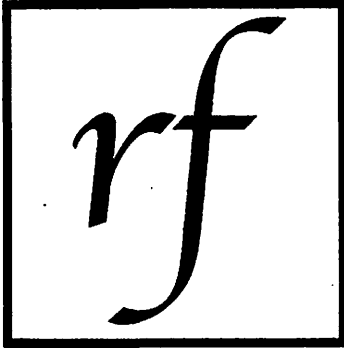

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Crossroads' Turning Points, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024, and 2023, and the related statement of changes in net assets available for benefits for the years ended June 30, 2024, and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Crossroads' Turning Points, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024, and 2023, and for the years ended June 30, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## ***Basis for Opinion***

**Note 1      Description of Plan**

The following description of the Crossroads' Turning Points, Inc. ("CTP") 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of CTP who have sixty days of service and are age 21 or older. Once an employee is eligible to participate in the Plan, they are automatically enrolled at 3% unless a different deferral amount is selected by the employee, or the employee opts out of the automatic enrollment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's custodian is Equitable.

Plan Contributions

For the 2024 calendar year, participants may contribute up to \$23,000 of their pretax annual compensation (\$22,500 for 2023), as defined in the Plan, by means of payroll deductions, subject to certain discrimination tests prescribed by the Internal Revenue Code and other limitations specified in the Plan. In addition, participants may qualify for "catch-up" contributions of an additional \$7,500 if they are age 50 and over (\$7,500 for 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers eighteen mutual funds and a guaranteed interest account as investment options for participants, CTP makes matching contributions equal to 20% of the first 5% of base compensation that a participant contributes to the Plan. 401(k) elective deferrals of over 5% of base pay are not matched.

All or a portion of 401(k) elective deferral contributions may be designed as Roth elective deferral contributions instead of pre-tax elective deferral contributions. Roth elective deferral contributions do not reduce total taxable income or current taxes, but any earning will not be taxes when received as a qualified distribution.

Participant Accounts

Each participant's account is credited with the participant's contributions and CTP's matching contributions, as well as allocations of Plan gains and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in CTP's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. The following summarizes vesting by year of continuous service:

1 Year	0%
2 Years	25%
3 Years	50%
4 Years	75%
5 Years or More	100%

### Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary receives the vested amount credited to the participant's account either in a lump sum, an annuity or, at the participant's election, in fixed periods and fixed installments, subject to minimum distribution requirements. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also withdraw any part of their vested account resulting from elective deferral contributions, matching contributions, and earnings thereon, in the event of hardship due to an immediate and heavy financial need.

### Forfeited Accounts

On June 30, 2024, and 2023, the Plan had forfeited non-vested accounts totaling \$6,099 and \$19,336, respectively. These accounts, when present, are used to reduce future employer contributions and/or plan fees and expenses.

## **Note 2      Summary of Accounting Policies**

### Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with generally accepted accounting principles in the United States (GAAP).

### Use of Estimates

The preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

### Payment of Benefits

Benefits are recorded when paid. On June 30, 2024 and 2023, there were not any benefits processed and approved for payment but not paid.

### Operating Expenses

Certain expenses of maintaining the Plan are paid directly to CTP and are excluded from these financial statements. Specific fees related to the administration of investments are charged directly to the individual participants' accounts and are included in administrative expenses. All other investment-related expenses are included in net appreciations of fair value of investments.

### Contributions

Contributions from employees and CTP are recorded in the period in which CTP makes the payroll deductions from participant earnings.

### Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

### Subsequent Events

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

### **Note 3 Fair Value Measurements**

The Plan uses a framework pursuant to GAAP for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurements) and the lowest priority to unobservable inputs (Level 3 Measurements). The three levels of the fair value hierarchy are described below:

#### Level 1

Unadjusted quoted prices in active markets for identical assets or liabilities that CTP has the ability to access.

#### Level 2

Prices are determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 Input must be observable for substantially the full term of the asset or liability.

#### Level 3

Prices are determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

#### Registered Investment Companies

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to

transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following sets forth by level within the fair value hierarchy, the Plan's investments at fair value as of June 30, 2024, and 2023.

**Note 5 Investment Contract with Insurance Company**

Equitable offers a general account product, Key Guaranteed Portfolio Fund, offered through a group annuity contract. Principal and interest are fully guaranteed by the entire general account assets of Equitable Life Insurance Company. Interest is set quarterly, ranging from 1.10% – 1.25% for the years ended June 30, 2024, and 2023.

The fair value of this investment on June 30, 2024, was \$286,879 and on June 30, 2023, was \$261,058.

This product/contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Equitable, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily withdraw or transfer all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any requires prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **Note 6      Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and. Therefore, management believes that the Plan is qualified and the related trust is tax exempt.

GAAP requires plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in-progress. Generally, Plan tax returns remain open for federal income tax examination for three years from the date of filing.

#### **Note 7      Related-Party Transactions**

All investments were managed by Equitable Life Insurance Company for the years ended June 30, 2024, and 2023. Fees were paid to Equitable for their services.

**Note 8      Plan Termination**

Although it has not expressed any intent to do so, CTP has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**Note 9      Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 10     Reconciliation of Financial Statements to Form 5500**

There were not any reconciling differences as of June 30, 2024, or 2023.

**Note 11     Information Certified by the Plan's Custodian**
