### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Warner Robins Supply Company, Inc. 401(k) Retirement and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 10, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period and year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Warner Robins Supply Company, Inc. 401(k) Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 10, 2023 and December 31, 2022, and for the period and year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.



**NOTE 1 DESCRIPTION OF PLAN**

**Description of the Plan**

The following description of the Warner Robins Supply Company, Inc. 401(k) Retirement and Savings Plan 401(k) Retirement and Savings Plan (the Plan) provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution plan covering all eligible employees of WRBS OPCO, LLC (the Company) originally effective January 1, 1963. The Plan had been amended and restated throughout the years to comply with tax legislation and most recently restated effective June 1, 2022. The Plan excluded union employees or those who were non-resident aliens, as defined by the Plan. The Plan was subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator was responsible for the oversight of the Plan and determined the appropriateness of the Plan's investment offerings and monitored investment performance.

On January 10, 2023, assets in the amount of \$3,246,699, were transferred from this Plan into the Aligned Equity Holdings 401(k) Plan in connection with the purchase of WRBS OPCO, LLC, the Plan Sponsor. Effective January 1, 2023, participants in the Warner Robins Supply Company, Inc. 401(k) Retirement and Savings Plan were eligible to participate in the Aligned Equity Holdings 401(k) Plan.

**Eligibility**

Employees were eligible to participate into the employee and employer discretionary matching portions of the Plan on the first day of the calendar quarter following the first day of employment. Employees were eligible to participate in the employer non-elective portions upon satisfying the eligibility requirements of age 21, have at least one year of service and be employed by the Company as the last day of the year. One year of service as defined by the Plan was the completion of at least 1,000 hours of service.

**Contributions**

Participants could make elective deferrals to the Plan up to the annual deferral limit determined by the Internal Revenue Code (IRC). Participants who had attained age 50 before the end of the Plan year were eligible to make "catch-up" contributions.

The Company could make a discretionary matching contribution based on a percentage of the participant's contribution. The discretionary matching contribution percentage was determined by the Company each year. For the period ended January 10, 2023 there were no discretionary matching contributions. For the year ended December 31, 2022, the discretionary contribution was 25% on each 1% of employee contributions, up to a maximum of 1%. Matching contributions of \$38,519 were made for the year ended December 31, 2022.

Participants could also contribute amounts representing distributions from other qualified plans (rollover). Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain limitations.

**Participant Accounts**

Individual accounts were maintained for each of the Plan participants to reflect the participants contributions and related Company contributions as well as the participant's share of the Plan income. Income was allocated to participants accounts through the change in value. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**Vesting**

Participants were immediately vested in their contributions including actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of service. Notwithstanding the above, a participant was fully vested upon reaching normal retirement age, death, or permanent disability. Otherwise, Company contributions vested as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

**Participant Loans**

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Note terms were up to five years. The notes were secured by the balance in the participant's account with interest at prime +1%. Principal and interest were paid ratably through payroll deductions.

**Payment of Benefits**

A participant could receive the vested portion of the participant's account balance either in a lump-sum distribution or in equal installments upon termination, attainment of retirement age, death, or disability as defined by the Plan. The Plan allowed for in-service distributions if a participant reached age 59½ and hardship distributions subject to Plan provisions. If a participant terminated employment and the participant's account balance did not exceed \$5,000, the Plan administrator would authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account was between \$1,000 and \$5,000, the Plan Sponsor could authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Amounts**

Forfeited balances of terminated participants' accounts could be applied to pay administrative expenses, with the remaining balance available to reduce Company contributions.

**Forfeited Amounts (Continued)**

As of January 10, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0- and \$3,014, respectively. There were no forfeitures used to reduce administrative expenses for the period ended January 10, 2023 or year ended December 31, 2022. Forfeitures totaling \$-0- and \$2,163 were used to reduce Company contributions for the period ended January 10, 2023 and year ended December 31, 2022, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit responsive guaranteed investments contracts, which is reported at contracted value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Earning from investments, with the exception of participant loans, are allocated on a pro rata basis to individual accounts based on the type of investments and the ratio of each participant's individual account balance to the aggregate of participants account balance. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's individual account.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 10, 2023 and December 31, 2022. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through March 17, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2022, and net appreciation (depreciation) in fair value of the investments, interest and dividends for the period ended January 10, 2023 and year ended December 31, 2022 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the insurance company for the Plan.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 10, 2023 and December 31, 2022.

*Pooled Separate Accounts* – Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANY**

The Plan maintains a fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.05%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Effective January 10, 2023, this contract was terminated.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on opinion letters received from the Internal Revenue Service (IRS) on the Plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letters. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by Voya Retirement Insurance and Annuity Company, the insurance company of the Plan. These transactions qualify as party-in interest transactions.
