## INDEPENDENT AUDITORS' REPORT

The Plan Administrator and Participants of the Rockhurst University Retirement Savings Plan  
Kansas City, Missouri

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Rockhurst University Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

# ROCKHURST UNIVERSITY RETIREMENT SAVINGS PLAN

## NOTES TO FINANCIAL STATEMENTS JUNE 30, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the Rockhurst University Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General** – Rockhurst University (the “University”) established the Plan to provide employees with a systematic means of savings and investing for the future. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of the University.

The Plan’s custodian, for the proprietary annuity contracts, is Teacher’s Insurance and Annuity Association and College Retirement Equities Fund (“TIAA-CREF”). TIAA-CREF Trust Company, FSB is the custodian for the remainder of the Plan’s investments. Certain affiliates of the custodians provide participant account recordkeeping services to the Plan. Two West Capital Advisors serves as the investment advisor for the Plan.

**Eligibility** – All permissible employees of the University, as defined in the universal availability standards, are eligible to enroll and begin deferrals immediately upon hire.

**Participant Accounts** – Each Plan participant has an individual accumulation account that consists of that participant’s share of accumulated contributions and investment earnings net of administrative costs, distributions, and investment management fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Contributions** – Participants may contribute up to certain limits prescribed by the Internal Revenue Code (“IRC”) and other limitations specified by the Plan. Participants who are older than 50 years of age, or who have completed 15 years of service with the University may be eligible to make additional contributions, as defined by the Plan.

Through January 31, 2023, the University matched 120% up to the first 5% of the elective deferrals that a participant contributed to the Plan. The Plan suspended matching contributions effective February 1, 2023.

**Vesting** – Employee and employer contributions are immediately fully vested.

**Investments** – Participants direct the employee and employer contributions to a variety of registered investment companies, guaranteed investment contracts, or a pooled separate account.

**Notes Receivable from Participants** – Participants may borrow from their vested account balances with interest charged at a rate equal to prevailing market rates as set by TIAA-CREF, which remains in effect for the duration of the loan. The minimum loan is \$1,000. The loans are secured by the balance in the participant’s account and can’t exceed the lesser of 50% or \$50,000, of the participant’s vested balance. Principal and interest are paid ratably by the participant to TIAA-CREF. Participants may only have two loans outstanding at any time. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence.

**Plan Loans** – Prior to July 1, 2019, participants could borrow against their account balances, with interest charged at a rate set by TIAA-CREF. Participant loans between participants and TIAA-CREF are required to have 110% of the loan’s principal balance deposited in the TIAA Traditional investment option. This serves as collateral for the loan. The loans are funded by TIAA-CREF and interest paid on the loans is earned by TIAA-CREF and not the Plan.

Participants earn interest on their money in the TIAA Traditional investment. The loans outstanding with TIAA-CREF at June 30, 2024 and 2023, were \$57,384 and \$76,723, respectively. The interest rate range as of June 30, 2024, was 4.29% to 6.08%. These loans are not included on the Statement of Net Assets Available for Benefits.

***In-Service Withdrawals*** – Hardship withdrawals are available to Plan participants for reasons as defined in the Plan Document. Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

***Other Income*** – During 2024, the Plan received \$10,408 in revenue sharing payments and \$24,825 was used to pay administrative expenses. As of June 30, 2024 and 2023, the revenue sharing account had a balance of \$89,828 and \$101,374, respectively.

***Payment of Benefits*** – Following retirement or termination of employment, a participant may elect to receive benefits in the form of a lump sum, partial payments, installment payments or annuity contracts. Lump-sum distributions of TIAA investments are subject to a 2.5% surrender charge.

***Plan Expenses*** – Certain expenses may be paid by the University or the Plan. The Plan paid various service providers \$115,883, of which \$50,840 was paid to TIAA-CREF.

***Termination of the Plan*** – Although the University has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants shall become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

***Basis of Accounting*** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully-benefit responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates*** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition*** – The Plan's investments are stated at fair value (except for a portion of the fully benefit responsive TIAA Traditional Annuity, and the TIAA Stable Value fund which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Contributions*** – Contributions are recognized in the year service is rendered by the Participant.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management's Review** – Subsequent events have been evaluated through March 5, 2025, which is the date the financial statements were available to be issued and there were no material events requiring recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

Guaranteed Annuity Contracts – Reported at contract value, which approximates fair value. The contract value is the aggregation of contributions, plus interest, less withdrawals, if any. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA Traditional Annuity's historical crediting rates.

Registered Investment Companies – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The CREF accounts invest primarily in equity securities, fixed-income instruments, and short-term instruments in accordance with each portfolio's investment objectives. Variable annuity investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing. CREF Money Market holdings are generally valued at amortized cost. The CREF accounts can be redeemed on a daily basis.

Pooled Separate Accounts – The investment advisors calculate a unit value (similar to a NAV) of a separate account. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan's investments are reported at fair value as follows at June 30, 2024 and 2023:

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### 5. INFORMATION CERTIFIED BY TIAA-CREF

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA-CREF and TIAA-CREF Trust Company, FSB, the custodians, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of June 30, 2024 and 2023, and for the year ended June 30, 2024.

- Investments, at fair value and contract value
- Net appreciation in fair value of investments
- Notes receivable from participants and related interest

- Interest and dividend income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **6. INSURANCE CONTRACTS**

The TIAA Traditional Annuity is a fixed rate annuity contract that is fully and unconditionally backed by TIAA. The TIAA Traditional Annuity is reported at contract value, which approximates fair value. TIAA issues various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract. One contract type charges a 2.5% withdrawal fee if a participant separates from service and elects to withdraw accumulations within 120 days of separation. The impact of such occurrence on the value of the Plan's accumulations in TIAA Traditional Annuities would be minimal.

The TIAA Stable Value is a fixed rate group annuity contract issued by TIAA. Contributions are deposited into a non-unitized separate account. The contract provides a guaranteed minimum rate of between 1% and 3% (before deductions for contract fees) with the potential for crediting of additional interest above the guaranteed minimum, if approved by the TIAA Board of Trustees. This contract is immediately liquid to a participant for withdrawals and transfers and does not have withdrawal restrictions (except that immediate transfers cannot be made to competing investment options pursuant to the contract's "equity wash" provisions). In addition, transfers into the TIAA Stable Value Fund may not be made for 30 days following a transfer out.

## **7. TAX STATUS**

The University adopted a Volume Submitter 403(b) Plan which received a favorable opinion letter from the IRS on August 7, 2017, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter, however, the University believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan's investments are issued by TIAA-CREF. TIAA-CREF is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

TIAA-CREFF deducts an expense charge from investment income for the investments TIAA-CREF manages in the calculation of a participant's account balance. This expense charge ranged from 0.02% to 1.015% (depending on the type of investment from July 1, 2023 through June 30, 2024) on an annual basis.

Additional fees include investment management fees to Two West Capital Advisors and professional service fees to the auditor and The University for administrative services, which qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions.
