## **1. PLAN DESCRIPTION:**

The Xtek, Inc. Employee Stock Ownership Plan (the “Plan”) is a defined contribution plan covering substantially all full-time employees of Xtek, Inc. (“Sponsor” or the “Company”). The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan. The primary purpose of the Plan is to allow participants to acquire stock ownership interests in the Company. The Plan holds 100% of the common stock of the Company. The Company also elected S-corporation status effective July 1, 2000.

### **Benefits**

The vested portion of a participant’s capital accumulation account will be distributed following the participant’s separation from service. The participant will receive his or her distribution in the form of cash, promissory notes or whole shares of Xtek, Inc. common stock or a combination of these methods. In addition, a participant may elect to have any portion of an eligible distribution paid to an eligible retirement plan via a direct rollover. Prior to July 1, 2009, a participant or beneficiary could elect to transfer the distribution to the Company’s Defined Benefit Pension Plan and distribute the benefit thereunder at the actuarially determined equivalent.

The Company’s administrative committee authorizes the trustee to remit payments of benefits from the trust to participants, spouses and other beneficiaries entitled to such benefits under the Plan.

### **Eligibility**

Generally, full time employees, who have attained the age of 18, are eligible to participate in the Plan on their hire date.

### **Participant accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account will be credited quarterly with their allocable share of Company stock (including fractional shares), and any stock dividends on the Company stock, and at least annually with any forfeitures of Company stock. Only those participants who are eligible employees of the Company on the allocation date will receive an allocation. Allocations are based on a participant’s eligible compensation, relative to total eligible compensation.

### **Contributions**

The Company, at the approval of the Company’s Board of Directors, may make contributions to the Plan. Contributions can be in the form of cash and/or shares of Company stock, as determined by the Company’s Board of Directors. The Plan does not permit employee contributions.

Effective July 1, 2000, the Plan was amended to incorporate a money purchase contribution formula equal to 3% of an eligible participant’s compensation for each plan year. In order to be eligible to receive this contribution, a participant must be a covered employee on the allocation dates of the plan year, or have terminated their service on or after their earliest retirement age or by reason of disability or death, during that Plan year. The Plan provides for quarterly contribution allocations. For the Plan years ended June 30, 2024 and 2023, the Plan had met its funding requirements.

**Vesting**

Participants become 100% vested in their respective capital accumulation accounts after three years of service with the Company or earlier if upon normal retirement age.

**Put option**

The Company shall provide a “put option” to any participant (or beneficiary) who receives a distribution of Company stock. The put option shall permit the participant (or beneficiary) to sell such Company stock to the Company or an affiliate at any time during two option periods, at the then fair market value.

**Diversification**

A participant who has attained the age of 55 and completed at least 10 years of participation in the Plan shall be entitled to elect to withdraw in cash a portion of their balance in the Company stock account, in accordance with Code Section 401(a)(28)(B). Diversification is offered to most eligible participants over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. No withdrawal election shall be permitted if the balance in such Company stock account has a fair market value of \$500 or less, unless and until the balance in the account as of a subsequent allocation date in the election period exceeds \$500.

**Forfeitures**

Employer contributions are forfeited by participants upon termination before becoming vested. Forfeited amounts are allocated to remaining participants in accordance with Plan provisions.

**Voting rights**

Participants are entitled to exercise voting rights attributable to those shares allocated to their accounts and are notified by the trustee prior to the time that such rights are to be exercised. Participant voting rights are exercised through the trustee, subject to provisions described in the Plan document.

**Plan termination**

The Company intends to continue the Plan indefinitely for the benefit of the participants but reserves the right to terminate the Plan at any time by resolution of its Board of Directors. In the event the Plan is terminated, participants become fully vested in their capital accumulation accounts, and Plan assets are distributed to participants in accordance with the Plan agreement.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

The following is a brief description of the significant accounting policies of the Plan.

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Cash equivalents**

Cash equivalents include the Plan's investment in a highly liquid mutual fund. This fund is used primarily as a holding account for distributions.

**Benefits**

Benefits are recorded when distributed.

**Administrative expenses**

The Sponsor pays most Plan administrative expenses and such expenses are excluded from these financial statements. If the Sponsor does not pay such expenses, the trustee shall pay them from the Plan assets.

**Subsequent events**

The Plan has evaluated subsequent events through March 27, 2025, the date the financial statements were available to be issued.

#### 4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

- Level 1        Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2        Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3        Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in methodologies used at June 30, 2024 and 2023.

*Common stock:* The fair value of the Xtek, Inc. common stock held by the Plan is valued based on an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and estimated fair value of the company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company.

*Cash and cash equivalents:* The carrying value approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, no provision for income taxes has been included in the Plan's financial statements.

**6. RISKS AND UNCERTAINTIES:**

Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that change in the value of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements and supplemental schedules.

**7. RELATED PARTY TRANSACTIONS:**

The Plan invests in Company common stock and, therefore, these transactions qualify as party-in-interest transactions.
