## **1. DESCRIPTION OF PLAN:**

The following description of the Xtek, Inc. Employee Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of Plan provisions.

### **General**

The Plan is a defined contribution plan covering all eligible employees of Xtek, Inc. (the “Company” or “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### **Eligibility**

Generally, full-time employees are immediately eligible to participate in the Plan after attaining age 18.

### **Contributions**

Subject to certain limits, participants may contribute a portion of their compensation to the Plan, including catch-up contributions for participants who have attained the age of 50. Participants are also permitted to deposit into the Plan distributions from other qualified plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may make discretionary matching contributions up to 50% of the first 5% of eligible compensation that a participant contributes to the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

### **Participant accounts**

Each participant account is credited with the participant contributions, related matching contributions, if any, and an allocation of Plan earnings. Allocations of Plan earnings are based upon the performance of the investment funds chosen by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions, catch-up contributions and rollover contributions as adjusted for earnings and losses thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

### **Notes receivable from participants**

Participants may borrow from their funded accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of the account. The loans are secured by the balance in the participant's account. The loan interest rate is 1% above the prime rate, as defined. Loans are payable within five years except for those used to acquire a principal residence. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

Upon termination of service, distribution shall be made to the participant or beneficiary in a single lump sum payment. A participant who has attained age 59 ½ or is determined by the administrator to have incurred a hardship may elect in writing to make a cash withdrawal, subject to Plan provisions, of up to 100% of the participant's account balance. Benefits are recorded as paid.

**Forfeited accounts**

Employer matching contributions are forfeited should a participant terminate employment before becoming fully vested. Forfeited amounts are used to reduce employer contributions or reduce Plan expenses. Forfeiture balances are immaterial as of June 30, 2024 and 2023.

**Transfers in**

The Plan allows for the transfer in of diversification distributions made from the Xtek, Inc. Employee Stock Ownership Plan ("ESOP"). A participant, who has attained the age of 55 and completed 10 years of participation in the ESOP, is entitled to make diversification withdrawals from the ESOP.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See further discussion of fair value in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments the plan administrator deems the participant loan to be in default. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. The Plan is charged for custodial, administrative and recordkeeping fees.

**Excess contributions payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**Subsequent events**

The Plan has evaluated subsequent events through March 27, 2025, the date the financial statements were available to be issued.

**3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust, the trustee, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of June 30, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023.

**4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the quoted daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Money market funds are valued at the cost which approximates fair value.

*Collective stable value trust fund:* The collective stable value fund is composed primarily of fully benefit-responsive investment contracts. The fund is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of June 30, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

**5. TAX STATUS:**

The Plan adopted a non-standardized pre-approved profit sharing plan document which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan has since been amended. While the Company has not obtained its own determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan is exempt from income taxes.

**6. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that change in the value of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements and supplemental schedules.

**7. PLAN TERMINATION:**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 % vested in their accounts.

**8. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS:**

Certain Plan investments held in 2023 were units of a collective trust managed by Matrix Trust Company and OneAmerica. Matrix Trust Company is a trustee and OneAmerica is the recordkeeper, as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan is credited for rebates that the trustees receive from mutual funds. These fee credits are included in total additions on the statements of changes in net assets available for benefits. The trustees charge the Plan for custodial, administrative and record keeping fees, including amounts paid to a third-party investment advisor. These fees are included in administrative expenses on the statements of changes in net assets available for benefits.

**9. DELINQUENT CONTRIBUTIONS:**

During 2021, participant contributions were transferred late to the Plan. The Plan Administrator has made the appropriate corrections.
