Management, having determined it is permissible in the circumstances, has elected to have the audits of RSM Puerto Rico 1081.01 Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2024 AND 2023

A. DESCRIPTION OF PLAN:

The following description of RSM Puerto Rico 1081.01 Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (1) *General.* The Plan is a defined contribution plan covering all full-time employees of RSM Puerto Rico (the Company or Plan Sponsor). Participants must have twelve months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (2) *Contributions.* Participants may contribute up to the maximum amounts permitted by Puerto Rico tax regulations. The Plan allows for participant directed investments and after-tax contributions. Contribution from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Plan also provides that employees who have met the requirements to be eligible to participate in the Plan will be automatically enrolled in the Plan. As part of automatic enrollment, the participant should be deemed to have made a before-tax deferral election of 2% of compensation. The deemed election may be changed or revoked by the covered employee at any time subsequent to automatic enrollment. The Plan provides for the Plan Sponsor's discretionary and profit sharing contributions (as defined) which may be increased or decreased from year to year. A pro-rata share of the profit sharing contribution is allocated to non-participants, based on an agreed upon percentage. An active participant account is created with the contribution. (See note J.)
- (3) *Participant Accounts.* Each participant's account is credited with the participant's contributions, other voluntary contributions, and transfers from other qualified plans, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (4) *Vesting.* A participant vests in employer contributions at a rate of 20% incrementally after the second year until reaching 100% after six years. A participant in the Plan whose employment terminates for any reason before his or her death, attainment of age 60, or total and permanent disability is entitled to receive the vested portion of his or her employer contributions account, adjusted for plan earnings or losses thereon. A participant is entitled to receive 100% of the participant's own contributions, adjusted for plan earnings or losses thereon.
- (5) *Payment of Benefits.* On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in periodic installments. No in-service distributions are allowed before age 59 ½, except for hardship distributions as permitted by tax regulations.

A. DESCRIPTION OF PLAN (CONTINUED):

(6) *Forfeitures.* Under the provisions of the Plan, unvested employer contributions are subject to forfeiture at the time a participant has a separation of employment. Unallocated forfeitures are invested in the Key Guaranteed Portfolio Fund and such forfeitures and related earnings, if any, can be used at the discretion of the Retirement Plan Committee. The Plan held forfeitures of \$26,190 (2024) and \$18,753 (2023).

(7) *Frozen assets.* The Plan contained assets categorized as “Frozen Employer Money” amounting to \$1,353,019 in 2023. These assets were transferred from a predecessor money purchase plan to the current plan. On May 30, 2023, at a meeting of the RSM Puerto Rico Pension Plan Committee, consensus was reached so that the funds in the Money Purchase Employee Deferral (Frozen Employer Money) of employees, in the RSM Puerto Rico 1081.01 Retirement Plan be made available for distribution in accordance with the provisions established in the plan. The funds were 100% vested for all qualifying employees.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by Puerto Rico tax regulations are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

C. PARTIES-IN-INTEREST:

UBS Trust Company of Puerto Rico as trustee; Empower Retirement Company and Great-West Life & Annuity Insurance Company (GWL&A) as record keepers and custodian of the plan assets; Pension Plus, Inc. as administrators; and the RSM Puerto Rico 1081.01 Retirement Plan Committee, as trustee, are each considered a party-in-interest to the Plan.

In addition, investment in certain mutual funds and the Key Guaranteed Portfolio Fund are considered parties-in-interest as these are issued or managed by GWL&A. Transactions in such investments are exempt from the prohibited transactions rules of ERISA.

D. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN:

The following information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by GWL&A, the custodian.

E. FAIR VALUE MEASUREMENTS:

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the funds are traded.

Key Guaranteed Portfolio Fund (KGPF): The KGPF is a stable value general account product offered through a group annuity contract. Participant principal and interest are fully guaranteed by the entire general account assets of GWL&A. The credit interest rate is reset quarterly. Bonds invested in the general account are investment grade in quality and are diversified across a range of fixed income assets. The KGPF is benefit responsive for participant-initiated transactions. The fair value of the investment contract equals the contract value presented in the financial statements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

F. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions' accounts. Any unallocated assets of the Plan shall be allocated to participants' accounts and distributed in such a manner as the Company may determine.

G. TAX STATUS:

The Puerto Rico Treasury Department has determined and informed the Company by letter dated March 28, 2017, that the Plan and related trust are designed in accordance with applicable sections of the 2011 Puerto Rico Internal Revenue Code (PRIRC), as amended. The Plan Sponsor and management believe that the Plan is currently designed and being operated in compliance with the applicable Puerto Rico income tax laws and regulations, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. Additionally, as long as the Plan is qualified under Puerto Rico income tax laws and regulations, participants will not be taxed on salary-deferred contributions or on investment earnings on such contributions at the time such contributions and investment earnings are received by the custodian, but will be subject to tax thereon at such time as they receive distributions from the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Puerto Rico Treasury Department. The plan management has analyzed the tax positions taken by the Plan, and concluded that as of June 30, 2024, no uncertain positions are taken or are expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax years in progress.

H. ADMINISTRATIVE EXPENSES:

The Plan Sponsor is assuming certain administrative expenses of the Plan. In addition, certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

I. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. SUBSEQUENT EVENTS:

Management has evaluated subsequent events through March 25, 2025, the date which the financial statements were available for issue.

With an effective date of January 1, 2025, the Board of Directors of the Plan Sponsor authorized and approved the elimination of automatic enrollment and automatic 2% deduction. The service requirement for eligibility has also been removed, and effective date of entry will be the first of the month following the employee's hire date and the employee contribution will be only in percentage, eliminating the fixed amounts.
