### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Nor-Cal Beverage Co., Inc. Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 25, 2024 (Plan Terminated) and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through July 25, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of July 25, 2024 and December 31, 2023, and for the period from January 1, 2024 through July 25, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Terminated Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Board of Directors of Nor-Cal Beverage Company, Inc., the Plan's Sponsor, voted on August 29, 2023 to terminate the plan and management determined liquidation is imminent. As a result, the Plan used the liquidation basis of accounting in presenting the July 25, 2024 and December 31, 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. **Note 1: Description of Plan**

The following description of the Nor-Cal Beverage Co., Inc. Employee Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was a participant-directed defined contribution plan established effective May 1, 1995, for eligible employees of Nor-Cal Beverage Company, Inc. (the Company). This Plan was available to all eligible employees of the Company who had attained 90 days of service and are age 18 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On August 29, 2023, the Board of Directors of the Company voted to terminate the Plan in connection with an anticipated sale of the Company. In January 2024, the Company was sold to an unrelated third party. As of the termination date, all future participation in the Plan was frozen, employer contributions and allocations were ceased, and all participant accounts became fully vested. The Plan was fully liquidated on July 25, 2024.

**Contributions**

Participants elected to have amounts withheld from their paychecks and contributed to the Plan by the Company. Participants who had attained age 50 before the end of the Plan year were eligible to make catch up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan included an automatic enrollment provision whereby newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rates set initially at 3% of eligible compensation. Additionally, the Plan had an escalation clause that increased automatically enrolled participants' deferrals annually by 1% until a deferral rate of 12% was reached unless they affirmatively elected not to participate.

The Plan also provided for discretionary Company matching contributions. The Company could contribute and allocate to each participant's account a percentage of the participant's elective deferral contributed. The Company set such percentages prior to the end of the Plan year. The Company matching contributions were 35% of the participant contributions for the period January 1, 2024 through July 25, 2024 (Plan Terminated).

Each participant's account was credited with the participant's own contributions, an allocation of the Company's contributions, and an allocation of net earnings from investments and changes in investment values and administrative expenses. Allocations were based on each participant's contributions, earnings, or account balances, as defined by the Plan. The benefit to which a participant is entitled was limited to the benefit that can be provided from the participant's account.

**Vesting**

Participants were always fully vested in their own contributions and vested in Company contributions as follows: 20 percent after the second year of credited service, increasing by 20 percent for each year of service thereafter. After six years of service participants were fully vested in Company contributions. For vesting purposes, employees must have had at least 1,000 hours of service during any Plan year to be credited with a year of service. As of the effective date of the termination of the Plan, all participants became fully vested in company contributions.

**Forfeitures**

Contributions by the Company that were forfeited by participants upon termination were used by the Company to fund future Company matching contributions. At July 25, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$4,500, respectively. For the period from January 1, 2024 through July 25, 2024 (Plan Terminated), forfeitures of \$14,055 were used.

**Payment of Benefits**

Withdrawals were allowed in the event of termination, disability, death, attainment of age 59½, or financial hardship. Upon termination of service, a participant was to receive the value of the vested interest in his or her account as a lump sum distribution or over a period not to exceed the life expectancy of the participant and his or her beneficiary. Terminated participants with vested balances less than \$5,000 were paid in a single lump sum.

**Administrative Expenses**

The Company, as Plan sponsor, paid certain administrative expenses on behalf of the Plan. Participant's accounts were adjusted for fees pertaining to termination processing and were charged for expenses incurred by the custodian in the performance of their duties.

**Notes Receivable from Participants**

Notes receivable from participants consisted of promissory notes received from participants in exchange for the distribution of cash from the Plan. A participant was allowed to borrow a minimum of \$1,000, up to one half of the vested balance of their Plan account, up to a maximum of \$50,000. Loans had to be repaid over no more than a five-year period with the exception of a loan for the participants' principal residence that may have a repayment period beyond five years. Principal and interest was paid ratably through payroll deductions. Notes receivable from participants were stated at the principal amount outstanding, which approximates fair value.

**Note 2:**      **Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared using the liquidation basis of accounting.

**Investment Valuation and Income Recognition**

Investments were reported at fair value and contract value as certified by the Plan's custodian. Fair value was the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and insurance company. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and are expensed when they were incurred. No allowance for credit losses has been recorded as of July 25, 2024 or December 31, 2023. If a participant ceased to make loan repayments and the Plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

**Subsequent Events**

In preparing the accompanying financial statements, management has considered events that have occurred after July 25, 2024, through February 20, 2025, the date these financial statements were available for issuance. As of such date, management was not aware of any subsequent events requiring additional disclosure.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at July 25, 2024 (Plan Terminated), and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 through July 25, 2024 (Plan Terminated), was obtained by management and agreed to or derived from information certified as complete and accurate by Annuity and Life Insurance Company of America (Empower) (the custodian of the Plan).

**Note 4: Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 25, 2024 (Plan Terminated) and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information. There are no unfunded commitments or redemption restrictions as of July 25, 2024 (Plan Terminated), and December 31, 2023.

**Note 5:**      **Guaranteed Investment Contract With Insurance Company**

The Plan entered into a benefit-responsive guaranteed investment contract with Empower. Empower maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Trust Company, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator did not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed interest contract issuer may not terminate the guaranteed interest contract at any amount less than the contract value.

The guaranteed interest contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate was based on a formula agreed upon with the issuer, but it may not be less than 1.5%. Such interest rates were reviewed on a semi-annual basis for resetting.

**Note 6:**      **Tax Status**

On September 22, 2022, the IRS stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan had not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognizes tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7: Party-In-Interest Transactions**

Certain Plan investments included shares of registered investment company funds managed by Empower. As Empower was the custodian and trustee of the Plan, transactions with this entity qualified as exempt party-in-interest transactions.
