## Independent Auditor's Report

To the 401K Committee  
Edelstein & Company 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Edelstein & Company 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of September 26, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period January 1, 2024 through September 26, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 26, 2024 (in liquidation) and December 31, 2023 (ongoing), and for the period January 1, 2024 through September 26, 2024 (in liquidation), stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting*

As further discussed in Note 1 and 5 to the financial statements, the Plan's sponsor, announced in May 2024 the merger with another firm, thus, terminating the Plan effective May 31, 2024, and liquidating the Plan's assets on September 26, 2024. As a result of the Plan's sponsor's merger, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### *Responsibilities of Management for the Financial Statements*

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Note 1 - Description of the Plan**

The following description of the Edelstein & Company 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan was a defined contribution plan covering all full-time employees of Edelstein & Company, LLP (the "Company") who were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Management was responsible for oversight of the Plan. The Company determined the appropriateness of the Plan's investment offerings, and monitors investment performance.

##### **Administration**

The Company supervised and managed the operations and administration of the Plan. Certain employees of the Company served as Plan Administrators of the Plan. The Plan had contracted with Ascensus Trust Company ("Ascensus") to serve as the Custodian. The Angell Pension Group, Inc. ("APG") was the third-party administrator ("TPA") of the Plan.

##### **Plan Termination**

In May 2024, the Plan's sponsor announced the merger with another firm to be effective on June 1, 2024. As a result of this merger, the Plan was terminated effective May 31, 2024, and all contributions would cease as of that date. Plan management fully liquidated the Plan as of September 26, 2024.

As a result of the termination, in accordance with accounting principles generally accepted in the United States of America ("GAAP"), the financial statements are presented on the liquidation basis of accounting for periods after December 31, 2023 (see Note 5).

##### **Eligibility**

For the purpose of participant contributions, an eligible employee could enter the Plan upon hire and attainment of the age of 21. An employee was eligible to participate on the first day of the calendar quarter following completion of the eligibility requirements. The Plan did not perform automatic enrollment and participants could enroll online upon reaching eligibility.

Participants were eligible for employer matching upon joining the Plan and were eligible for profit-sharing contributions upon completion of one year of service.

##### **Contributions**

Prior to the Plan termination, each year, participants could contribute up to 100% of pre-tax or post-tax (including Roth) annual compensation, as defined in the Plan agreement, subject to certain limitations of the Internal Revenue Code (the "IRC"). The Company had a discretionary matching contribution. During period ended September 26, 2024 (in liquidation) and year ended December 31, 2023 (ongoing), each participant received a discretionary matching contribution equal to 25% of the participants' salary deferrals up to 6% of the participants' eligible compensation.

The Company could also contribute discretionary profit-sharing contributions. Contributions to the Plan under the profit-sharing provisions were made at the discretion of the Company from the Company's current or accumulated profits. Annual profit-sharing contributions could not exceed 15% of the aggregate earnings of all participants during the year or exceed maximum amounts deductible by the Company under the IRC. Profit sharing contributions and forfeitures were proportionately allocated to each participant's account based upon integration levels and on the relationship of each

participant's compensation to the total compensation of all participants for such year. During the period from January 1, 2024 through September 26, 2024 (in liquidation), the Company made \$226,143 of profit-sharing contributions to the Plan.

Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions up to \$7,500 in 2024. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service ("IRS") limitations.

#### **Participant accounts**

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

#### **Investments**

Participants directed the investment of their contributions into various investment options offered by the Plan. Company contributions were automatically invested in the funds as the employee directed. The Plan offered mutual funds as investment options for the participants.

#### **Vesting**

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after six years of credited service or, if while employed, attained the age of sixty-five or higher, died or became disabled. One year of service was earned in each fiscal plan year in which an employee completed at least 1,000 hours of service. Following the termination of the Plan, all participants became 100% vested in their account balances.

#### **Notes receivable from participants**

Prior to the Plan termination, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan term could not exceed five years except for a home loan for which the term was determined by the Plan Administrator in a nondiscretionary manner. The loans were secured by the balance in the participant's account. The loan interest rate, determined quarterly, was set at the prime rate, as defined (8.5% and 8.5% at September 26, 2024 (in liquidation) and December 31, 2023 (ongoing), respectively). Principal and interest was paid ratably through monthly or bi-weekly payroll deductions. Upon termination of the Plan, all participant loan balances were repaid.

#### **Payment of benefits**

Prior to the Plan termination, withdrawals were permitted when a participant terminated employment, retired, became disabled or deceased. In-service withdrawals were also permitted for certain financial hardships or when a participant attained age 59 ½. Benefits were payable in lump sum payments, equal installments or partial payments as outlined in the Plan agreement. The Plan also allowed for hardship distributions based on proven financial need, as defined by the IRS. In the event that the vested accrued benefit was less than \$5,000, the Plan Administrator might have made a single payment without the election or request of the participant. Upon the death of a participant, the vested balance of the participant's account was distributed to the participant's beneficiary. Upon termination of the Plan, all participants were able to direct the distribution of their accounts.

#### **Forfeited accounts**

Prior to the Plan termination, when a participant was terminated, nonvested contributions were forfeited. At September 26, 2024 (in liquidation) and December 31, 2023 (ongoing), forfeited nonvested accounts totaled \$0 and \$40,947, respectively. These accounts were used to pay Plan expenses and reduce future employer contributions. There was \$48,173 in forfeited amounts used to reduce employer contributions during the period from January 1, 2024 through September 26, 2024 (in liquidation).

#### **Note 2 - Summary of accounting policies**

##### **Basis of accounting**

In accordance with GAAP, due to the termination of the Plan effective May 31, 2024 (see Notes 1 and 5), the financial statements of the Plan for the period from January 1, 2024 through September 26, 2024 (in liquidation) were prepared on the liquidation basis of accounting. The financial statements of the Plan as of and for the year ended December 31, 2023 (ongoing) were prepared on the accrual basis of accounting.

##### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") required management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

##### **Investment valuation and income recognition**

Investments were reported at fair value (except for life insurance policies which are reported at their cash surrender value). Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodian, TPA and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

##### **Notes receivable from participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. At December 31, 2023 (ongoing), no allowance for credit losses had been recorded. If a participant did not make loan repayments and the Plan Administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan agreement.

##### **Payments of benefits**

Benefits were recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

#### Subsequent events

The Plan has evaluated subsequent events through January 20, 2025, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at September 26, 2024 (in liquidation) and December 31, 2023 (ongoing).

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

For the period ended September 26, 2024 (in liquidation), there were no transfers between Levels 1 and 2 and no transfers in or out of Level 3.

#### **Note 4 - Related party transactions and party-in-interest transactions**

Parties-in-interest are defined under Department of Labor ("DOL") Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Contracted services provided by Ascensus and APG qualify as party-in-interest transactions. Administrative expenses were \$45,913 for the year ended September 26, 2024 (in liquidation). The Company paid directly any other fees related to the Plan's operations.

Certain participants of the Plan had outstanding loans (notes receivable from participants) with the Plan at September 26, 2024 (in liquidation) and December 31, 2023 (ongoing). These loans were considered party-in-interest transactions. Total notes receivable from participants at September 26, 2024 (in liquidation) and December 31, 2023 (ongoing) were \$0 and \$48,910, respectively.

#### **Note 5 - Plan termination**

As discussed in Note 1, the Plan terminated effective May 31, 2024, subject to the provision of ERISA. The participant directed net assets were distributed to participants effective September 26, 2024.

#### **Note 6 - Tax status**

The IRS had determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with applicable sections of the IRC. Although the Plan had been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan was designed, and operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan was qualified, and the related trust was tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 - Administrative expenses

Administrative costs of originating and maintaining participant loans, as well as check processing fees, were deducted from the participant's account. Additionally, certain expenses of administering the Plan were deducted from Plan assets.

#### Note 8 - Risks and uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 9 - Certified investments

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments at fair value and notes receivable from participants held at September 26, 2024 and December 31, 2023, and investment income and interest income on notes receivable from participants for the period from January 1, 2024 through September 26, 2024 and the year ended December 31, 2023, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Ascensus Trust Company and Newport Trust Company, LLC, the trustees of the Plan.
