This letter is written because I believe there is reasonable cause for not having filed 5500 forms for 2021, 2022, and 2023 for the above 401k plan through ADP.

In December 2021 I notified ADP I wished to terminate the plan. I was under the impression ADP would take care of any forms and/or actions necessary to finalize the termination. Although I may have received correspondence from ADP concerning the 5500 forms, I did not realize it was MY responsibility to file them. For this, I apologize.

Today, I received a notice from the IRS (copy attached) fining me for not filing a 5500 form for **December 2023**. Had I received such a notice for 2021 or 2022 I would have taken action previously.

I am now in the process of removing all existing employee accounts from the ADP plan through American Century Investments so the plan can be officially closed. None of this was explained to me in 2021 when I requested termination.

Please inform me of any necessary actions need to finalize this termination and minimize the penalties from the IRS.
