## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
Asbestos Workers Locals 80 and 51 Supplemental Pension Fund

### Opinion

We have audited the accompanying financial statements of the Asbestos Workers Locals 80 and 51 Supplemental Pension Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Asbestos Workers Locals 80 and 51 Supplemental Pension Fund as of June 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.


### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Asbestos Workers Locals 80 and 51 Supplemental Pension Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. 

### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED JUNE 30, 2024 AND 2023

#### NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the Asbestos Workers Locals 80 and 51 Supplemental Pension Fund (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

**General** - The Plan was established by an Agreement and Declaration of Trust which was entered into on February 21, 1994, by the Board of Trustees (Trustees). The Plan is a defined contribution profit sharing plan covering all eligible members of the Locals 80 and 51 of the International Association of Heat and Frost Insulators and Asbestos Workers. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides a supplemental Defined Contribution Pension Benefit which supplements the defined benefit pension benefit provided by the National Asbestos Workers Pension Plan. All participating employers conduct business in West Virginia and surrounding states.

Employees of Locals 80 and 51 and non-collectively bargained employees of contributing employers are also eligible to participate in the Plan, provided certain length of service and other requirements are met.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. The participant may also elect benefits to be paid in installments in accordance with the Plan documents.

For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution as follows:

1. Participant has not actively worked in the insulation industry in the geographic area of the Plan for at least six months.
2. Participant's employer terminates participation under the collective bargaining agreement.

**Contributions** - Contributions are made by the Plan on behalf of the participants under the terms of the collective bargaining agreement(s) between Asbestos Workers Locals 80 and 51 and signatory employers, or pursuant to some other written agreement that requires the employer to make contributions to the Plan on the participants' behalf.



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Participant Accounts** - An individual account is established for each employee covered by the Plan. Each participant's account is credited with contributions made by their employer based on the number of hours worked each month, net earnings or losses on the self-directed investment of their assets, an allocation of Plan's operating expenses, and an allocation of any outstanding delinquencies incurred by employers.

**Vesting** - Participants are immediately vested in the contributions plus actual earnings thereon.

**Forfeitures** - After six months of not working in covered employment, if the Fund Office cannot locate a participant to receive a mandatory distribution (\$1,000 or less), the participant's individual account will be provisionally forfeited to the Plan to pay administrative expenses.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

**Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investments Valuation and Income Recognition** - Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements and Note 9 for a discussion of contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employer Contributions Receivable** - This amount represents employer contributions received shortly after the close of the Plan year and therefore an allowance for doubtful accounts is not necessary. It does not include any additional amounts that may be due from delinquent contributing employers.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Administrative expenses are paid by the Plan.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Uninsured Cash Balances** - The Plan maintains the majority of its cash at one financial institution. The balance is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. As of June 30, 2024, the Plan had no cash balances in excess of FDIC insurance coverage. The Plan has not experienced any losses in its cash balances.

**Reclassifications** - Certain reclassifications have been made to conform to current year financial statement presentation. These reclassifications had no effect on the net assets available for benefits.

**New Accounting Pronouncement Adopted** - During the year ended June 30, 2024, the Plan adopted the provisions of Accounting Standards Update (ASU) 2016-13, *Financial Instruments - Credit Losses* (Topic 326). This ASU replaced the incurred loss methodology with an expected loss methodology that is referred as the current expected credit loss (CECL) methodology. The ASU requires nonprofit entities to immediately recognize the estimated expected credit losses over the life of a financial instrument, including employer contributions. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events. The Plan adopted the ASU effective July 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

## NOTE 3. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE 4. RELATED PARTY TRANSACTIONS/PARTY-IN-INTEREST**

The Fund pays certain investment and administrative fees directly to service providers, including the Prudential Retirement Insurance and Annuity Company, the recordkeeper for the Fund. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

#### **NOTE 5. PLAN TERMINATION**

Although they have not expressed any intent to do so, the Trustees have the right under the Plan to terminate the Plan or discontinue contributions, subject to the provisions set forth in ERISA. In the event of any termination of the Plan, or upon complete or partial discontinuance of contributions, the account of each affected participants shall remain fully vested. In the event of the termination of the Plan, the assets then remaining, after providing for the expenses of the Plan and for the payment of any accumulated shares theretofore approved, shall be distributed among the participants. Each participant shall receive their individual account balances after payment of any remaining plan expenses. No part of the assets shall be returned to any employer or inure to the benefit of any employer. A reasonable effort will be made to contact every participant. Those who cannot be located, or those for whom no claim is made for payment of their accumulated share within a time certain following the notification by registered mail to the last known address, shall have their individual account balance placed in a federally insured savings account. An attempt will also be made to contact the designated beneficiary in an attempt to locate the participant.

#### **NOTE 6. TAX STATUS**

The Internal Revenue Service (IRS) has made a favorable determination, by letter dated September 10, 2015, the Plan's tax status and has notified it that it is exempt from federal income taxes pursuant to Internal Revenue Code Section 401 (a). No change in the Plan's tax status is anticipated.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

#### **NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. The Plan minimizes concentrations of risk by hiring professionals to manage and evaluate investments and by diversifying the holdings in its investment portfolio, which limits the amount of credit exposure to any one issuer. Due to the level of risk associated with certain investment securities, it is at least

reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## **NOTE 8. LITIGATION**

Based on advice of the Plan's counsel, there is no current litigation either threatened or pending which would have a material adverse effect on the Plan's financial position for the year ended June 30, 2024.

## **NOTE 9. PRUDENTIAL GUARANTEED INCOME FUND**

The Plan's insurance company contract, the Prudential Guaranteed Income Fund, is a fully benefit responsive insurance contract. Under this contract, participants may direct all or a portion of their contributions to this investment. The participant's account is credited with deposits and interest less withdrawals and fees. Interest is using a single portfolio rate approach. Under this method, a single rate is applied to all contributions to the account regardless of the timing of the contributions. The minimum crediting rate under this contract is 1.90% and is reviewed on a semi-annual basis for resetting. Generally, there are not any events that limited the ability of the Plan to transact at contract value within 90 days.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because of this the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents including complete or partial plan termination or merger with another plan, changes to the Plan's prohibition on competing investment options, bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the plan or the failure of the trust to qualify for exemption from the federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, or a material amendment to the agreement without the consent of the issuer. The Plan's administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.



## **NOTE 10. RESTRICTIONS ON HARDSHIP DISTRIBUTIONS**

Hardship withdrawals are limited to one application in a 12-month period. If a second request for hardship withdrawal is received within the 12-month period due to extenuating circumstances, sufficient proof of financial hardship for the requested distribution will be required prior to submission to the chairman and co-chairman of the Trustees for final determination.

## **NOTE 11. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through March 19, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
