## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **1 – DESCRIPTION OF THE PLAN**

### ***General***

403(b) Thrift Plan of Fall River Deaconess Home (the "Plan") is a defined contribution plan that was established on July 1, 1991 for the benefit of employees of Fall River Deaconess Home (the "Organization"). The Plan is funded by contributions from its participants and the Organization and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***Eligibility for Participation***

All employees are eligible to make voluntary deferral contributions to the Plan. To be eligible for employer matching and base contributions, employees must be 21 years old and complete one year of service.

### ***Employee Elective Deferred Contributions***

Employees participating in the Plan may elect to defer a specific dollar amount or percentage of their annual earnings as their contribution to the Plan, subject to the limitations described in the Internal Revenue Code. Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document.

### ***Employer Matching Contributions***

The Organization makes matching contributions to the Plan equal to the lesser of 50% of each participant's elective deferral or 1.5% of the participant's salary.

### ***Employer Base Contributions***

The Organization makes base contributions to the Plan equal to 3% of the participant's salary.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer's contributions is based on a graded vesting schedule whereby the employee is fully vested after 6 years of service.

### ***Participant Accounts***

Accounts are maintained for each participant. Accounts are increased for contributions, transfers and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

### ***Investment Options***

The Plan was established with Mutual of America Life Insurance Company ("Mutual of America") as its custodian. Upon enrollment into the Plan, a participant may direct employee and employer contributions in whole number percentages into a variety of investment options.

**1 – DESCRIPTION OF THE PLAN (continued)**

***Notes Receivable from Participants***

A participant may borrow from his/her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his/her vested account balance. Mutual of America requires that 120% of the outstanding note balance be maintained as collateral in the participant's Mutual of America Interest Accumulation Account. The notes bear interest at a rate that is 3% higher than the interest rate credited to the participant's Mutual of America Interest Accumulation Account and is paid by the participant to Mutual of America as a cost of the loan. Principal and interest is paid ratably, mainly through payroll deductions.

Notes receivable from participants are not deducted from participants' accounts and, therefore, not reported on the Statements of Net Assets Available for Benefits (see Note 5).

***In-service Withdrawals***

In-service withdrawals may only be made under the following circumstances:

- Hardship as defined in the Internal Revenue Code and the Plan Document
- Attainment of age 59½

***Retirement Benefits***

The normal retirement age under the Plan is age 65. Certain participants may be eligible for early retirement subject to the provisions in the Plan document. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement benefits.

***Payment of Benefits***

Upon termination of service from the Organization, a participant may elect to receive his/her account balance in the form of a single lump sum, installments or any other forms of settlement available from the manager of the investment fund in which the participant's account or portion thereof is invested. Upon termination of service at the Organization, a participant with an accumulated balance of \$5,000 or less will receive a distribution of the balance at the discretion of the Organization.

***Timing of Distributions***

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the custodian.

As of June 30, 2024 and 2023, there were no distributions payable to participants.

***Administrative Expenses***

Substantially all administrative expenses incurred by the Plan are paid by the Organization. However, certain administrative expenses are paid by the Plan.

***Forfeited Accounts***

Forfeitures may be used to reduce future employer contributions. As of June 30, 2024 and 2023, forfeitures available for future use totaled \$10,015 and \$59, respectively.

## **1 – DESCRIPTION OF THE PLAN (continued)**

### ***Participant-Directed Contributions, Withdrawals and Transfers***

The election to allocate contributions between the investment options, and any decision to change such allocation, is made by each participant as permitted by the custodian. Withdrawals and transfers are recorded at the time such transactions take place.

## **2 – SUMMARY OF ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investments***

The Plan presents in the accompanying Statements of Changes in Net Assets Available for Benefits, investment income (loss), which consists of the realized gains and losses, unrealized appreciation (depreciation) on its investments, and interest and dividend income.

Investments are carried at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and, for money market instruments, includes amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Each participant's assets are jointly invested and the return on assets is allocated monthly among the participants and recorded as income or loss. The basis of allocation is the unit of participation method. Under this method, contributions and income result in an increase in units of participation while benefits paid and losses result in a decrease in units of participation.

### ***Payment of Benefits***

Benefits are recorded when approved and processed for payment.

### ***Risks and Uncertainties***

The Plan provides for various investment options in various mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

## **2 – SUMMARY OF ACCOUNTING POLICIES (continued)**

### ***Subsequent Events***

The Plan Administrator evaluated events that occurred after June 30, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued March 11, 2025, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

## **3 – INFORMATION CERTIFIED BY CUSTODIAN**

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's custodian and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained certifications from the custodian that such information is complete and accurate.

## **4 – FAIR VALUE MEASUREMENTS**

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

### **Separate Account Funds**

Separate Account Funds invest assets in an underlying fund, and the name of the Separate Account Fund reflects the name of the corresponding underlying fund. Separate Account Funds are valued based on accumulation units. Accumulation unit values for the funds are determined as of the close of business on each valuation day. The dollar value of an accumulation unit for each fund of the Separate Account will vary based on changes in net asset values of the underlying funds and expenses of the underlying funds. Investments consist solely of investments in mutual funds registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### 4 – FAIR VALUE MEASUREMENTS (continued)

#### General Account Funds (Interest Accumulation Account)

The General Account is credited with a contractual rate of return. The General Account assets are carried at amortized cost, or contract value, which is deemed to be fair value for an insurance company general account. The general account is valued at contract value (book value) basis. Funds that are transferred to another funding vehicle or investment may be subject to market value adjustment.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5 – NOTES RECEIVABLE FROM PARTICIPANTS (continued)**

Notes receivable amounts are not deducted from the participants' accounts but rather are made directly by Mutual of America to participants and, therefore, the notes receivable from participants are not part of the Plan's assets, and therefore, are not reported on the Statements of Net Assets Available for Benefits as a note receivable. Each note is secured by the participant's balance in the Mutual of America Interest Accumulation Account. Each participant's balance in this account must be at least 120% of the loan balance for the life of the note. Repayments including principal and interest are made bi-weekly. The notes bear interest at a rate that is 3% higher than the interest rate credited to the participant's Mutual of America Interest Accumulation Account and is paid by the participant to Mutual of America as a cost of the loan.

**6 – PLAN TERMINATION**

Although it has expressed no intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, participants will become 100% vested in their aggregate account balances and will be entitled to a lump-sum distribution.

**7 – INCOME TAX STATUS**

The Organization has adopted the Mutual of America Prototype 403(b) Thrift Plan Basic Plan Document No. 09 for its Plan document. Mutual of America obtained an advisory letter from the Internal Revenue Service indicating its Prototype 403(b) Thrift Plan Basic Plan Document No. 09 is acceptable under Internal Revenue Code Section 403(b). The Plan has been amended since receiving the advisory letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**8 – PARTY-IN-INTEREST TRANSACTIONS**

Plan investments consist of shares of various accounts managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the custodian of the Plan's assets and, therefore, these transactions qualify as party-in-interest.

In addition, the Plan paid Mutual of America Life Insurance Company for administrative services during the years ended June 30, 2024 and 2023.

The Organization provides certain administrative services at no cost to the Plan. The Organization also pays for certain administrative costs of the Plan.
