




- Plan Year August 1 through July 31.
- Compensation Total compensation paid during Plan Year.
- Years of Service Service for eligibility, benefits and vesting based upon entire period of service. The 1000 hours of service method is used in measuring this service.
- Accrued Pension Actuarial equivalent of the balance of the Participant's Cash Balance Account as of Valuation Date projected to his Normal Retirement Date.
- Actuarial Equivalence Based on the interest rate of 4% and mortality in accordance with the 1994 Group Annuity Reserving table projected to 2002.
- Cash Balance Account Hypothetical account established for each participant. Each plan year, the account is credited with participant's Contribution Credit in accordance with the plan. Account accumulates guaranteed earnings based on the interest rate of 4%.
- Contribution Credit Contribution formula varies by participant.  
  
Contribution amounts this year range from 1.52% to 60.61% of expected compensation.

Eligibility Employees become eligible upon attainment of age 21 and completion of 1 year of service, and enter the plan on the August 1 or February 1 following completion of the eligibility requirements.

However, non-voting physicians are excluded from the Plan.
