## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Humboldt Senior Resource Center 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Humboldt Senior Resource Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was originally established on July 1, 2009 as a defined contribution plan established to provide eligible employees of Humboldt Senior Resource Center Incorporated (the Company) (the Plan Sponsor) with retirement, death and disability benefits. The Plan was restated effective January 1, 2019 and became subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 403(b) of the Internal Revenue Code (IRC).

Participant Eligibility, Contributions and Vesting - Employees are eligible to participate in the Plan except for the employees who are non-residents aliens that do not receive earned income from the Company which constitutes income from sources within the United States. Participants may begin deferring a portion of their compensation into the Plan on the first day of each calendar month following a 30-day notice period. The Plan sponsor is offering an automatic enrollment feature. Unless affirmatively elected otherwise, automatic enrollment provisions apply to all newly eligible employees who have not turned in a wage deferral arrangement. The newly eligible employees are subject to an initial deferral contribution of three percent (3%) of their compensation for each pay period after eligibility. All eligible employees may make a rollover contribution even if not yet a participant in the Plan. The Plan allows participants to designate contributions as Roth contributions. Contributions to the Plan are limited to the maximum amount allowable under the provisions of the IRC.

The Company is allowed to make discretionary matching contributions. Eligible employees must be at least 18 years old, worked at least 800 hours during the year and be employed on the last day of the year. The following classes of employees are not eligible for matching contribution: (a) employees who are non-residents aliens who do not receive earned income from the Company which constitutes income from sources within the United States, (b) union employees and (c) leased employees. Participants will be included in the match calculation on the first day of the plan quarter following eligibility. The Company elected to make the matching contributions for the year ended June 30, 2024, equal to 3% of the eligible compensation. The employer matching contribution for the year ended June 30, 2024 was \$161,925.

Participants are immediately vested in their contributions plus actual earnings made thereon. The employer's contributions and earnings shall vest in accordance with the following schedule:

In addition, the Company's contribution is fully vested when a participant becomes totally disabled or dies. Forfeiture accounts can be used to reduce future employer contributions or pay plan expenses. As of June 30, 2024 and 2023, the forfeiture account had a balance of \$2,466 and \$2,265, respectively.

**NOTE 1 - DESCRIPTION OF PLAN (Continued)**

Investment Options - Participants exercise control over the types of investments made on their behalf, provided that such accounts are invested in investment funds designated by the Plan. Participants may invest in any one or more investment funds and change their investment options at any time.

Payment of Benefits - Upon retirement (age 65), termination, disability or death, a participant or their beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Additionally, participants may take in-service distributions upon reaching age 59 ½ or due to hardship. Upon termination, automatic lump-sum distributions are required for balances of less than \$5,000. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 73.

Notes Receivable from Participants - Loans are not permitted.

Participant Accounts - Each participant's account is credited with the employee's payroll contributions, the employer's contributions, and Plan earnings and losses. Allocations to participants' accounts are based on participant compensation or account balances in accordance with the provisions of the Plan.

Administration - The Company is the plan administrator and has engaged the services of Peery & Associates, Inc. (Peery) as a Third Party Administrator to handle daily administration of the Plan. The Plan's assets are managed by the custodian Newport Trust Company (Newport) through June 22, 2023 and the custodian Ascensus Trust Company (Ascensus) commencing June 23, 2023. The custodians, appointed by the Plan Sponsor, execute investment transactions and hold Plan investment assets. The plan administrator reviews the performance of the various available investments and makes decisions on the addition or deletion of an investment fund.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America. Contributions from participants are recorded when withheld. Benefit payments and expenses are recorded when paid.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for various investment securities. These securities are exposed to various risks such as interest rate, market fluctuations and credit risks. Further, due to the level of risk associated with these securities and the level of uncertainty related to changes in the values of investment securities, it is possible that changes in the various risk factors in the near term would materially affect the participants' account balances and the amounts reported in the accompanying financial statements.

Valuation of Investments - Investments in interest-bearing cash and mutual funds are stated at fair value determined by quoted market prices. Purchases and sales of investments are recorded on a trade-date basis. Net change in fair value of investments consists of the change in unrealized appreciation or depreciation during the year and the realized gain or loss of sold investments during the year. Acquisition costs are included in the cost of investments and sales are recorded net of selling expenses.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments.

Subsequent Events - Subsequent events were evaluated through March 13, 2025, the date the financial statements were available to be issued.

**NOTE 3 - CERTIFIED INFORMATION**

In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information certified by Ascensus regarding the current value of assets held as of June 30, 2024 and 2023, and transactions entered into during the Plan year were used in the preparation of the accompanying financial statements and supplemental schedule. **NOTE 4 - FAIR VALUE MEASUREMENTS**

Generally accepted accounting principles establish a hierarchy to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest ranking to fair values determined using unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest ranking to fair values determined using methodologies and models with unobservable inputs (Level 3). Observable inputs are those that market participants would use in pricing the assets based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumption about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 – Values are unadjusted quoted prices for identical assets or liabilities in active markets accessible at the measurement date.

Level 2 – Inputs included in quoted prices for similar assets or liabilities in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads and yield curves.

Level 3 – Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the Plan's best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at June 30, 2024.

*Interest-bearing cash:* Valued at the closing price at year end.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TAX STATUS**

The Plan adopted a volume submitter 403(b) plan with a cash or deferral arrangement which has received a favorable opinion letter from the IRS, which states that the Plan is designed in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan's tax filings are subject to audit by various taxing authorities.

**NOTE 6 - PLAN TERMINATION AND MODIFICATION**

The Plan Sponsor intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate and/or modify the Plan at any time by resolution of its Board of Directors and subject to the provision of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Ascensus, the custodian of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. The Plan has Premier Financial Group (Premier) as an advisor. During 2024, the Plan incurred \$5,921, \$7,441 and \$4,000 of administrative fees to Ascensus, Premier and Peery, respectively.
