## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the HPC Foods, Ltd.  
401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of HPC Foods, Ltd. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the fiscal years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HPC Foods, Ltd. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the fiscal years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of HPC Foods, Ltd. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Basis of Accounting**

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the HPC Foods, Ltd. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (1) **General** - The Plan is a defined contribution plan covering substantially all employees of HPC Foods, Ltd. and HPC Properties, Ltd., collectively referred to as the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (2) **Participation** - Employees twenty-one years or older become eligible upon completion of one year of service, with one thousand hours or more during the year.
- (3) **Contributions** - Participants may elect to defer compensation amounts not to exceed limitations set forth by the Internal Revenue Code (IRC). The Company may contribute a discretionary matching contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For Plan years ended June 30, 2024 and 2023, the matching contribution was equal to 25% of the employee's deferred contribution, not to exceed \$400 per participant in each Plan year.

The Company may also contribute a discretionary profit-sharing contribution amount to the Plan each year. During the fiscal years ended June 30, 2024 and 2023, Company profit sharing contributions, including forfeitures, were approximately \$69,300 and \$68,500, respectively.

- (4) **Participant accounts** - Each participant's account is credited with the participant's contributions, the Company's matching contribution, and allocations of the Company's discretionary profit-sharing contribution as well as allocations of Plan earnings or losses. Allocations are based on the participant earnings, account balances, or specific participant transactions, as defined. Individual service fees are charged to the accounts of participants related to their use of certain Plan features. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (5) **Vesting** - Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100% vested after six years of credited service.
- (6) **Payment of benefits** - On termination of service due to retirement, death, disability, or other events, a participant may elect to receive either a lump-sum distribution of the participant's entire vested account balance or have their distributions as a direct rollover to an eligible retirement plan or individual retirement account (IRA). Participants with amounts in excess of \$5,000 (increased to \$7,000 effective January 1, 2024) may elect to defer the receipt of the distribution of the benefits until their normal retirement date.
- (7) **Forfeited accounts** - Termination of employment for reasons other than retirement, disability, or death results in a forfeiture of the non-vested portion of the participant's account balance. Forfeitures are used to pay administrative expenses, reduce matching and discretionary employer contributions, and reallocate to eligible

participants. At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$3,745 and \$4,809, respectively. Employer contributions will be reduced by \$3,745 and \$4,809 from forfeited nonvested accounts for fiscal years ended June 30, 2024 and 2023, respectively.

- (8) **Plan termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the ERISA. In the event of Plan termination, all participants would become fully vested.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

- (1) **Basis of accounting** - The financial statements of the Plan have been prepared using the modified cash basis of accounting. Under the modified cash basis, income is recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred, except for net appreciation in fair value of investments and employer contributions which are reflected on the accrual basis.
- (2) **Use of estimates** - The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (3) **Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies, utilizing information provided by the custodian. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the settlement date. Interest and dividend income are recorded on the cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the fiscal year.

- (4) **Payment of benefits** - Benefits are recorded when paid.
- (5) **Administrative expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses.
- (6) **Subsequent events** - Management has evaluated subsequent events through March 31, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required adjustment of or disclosure in the financial statements.

**NOTE C - CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest for the fiscal years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by AdvisorTrust, Inc. (the custodian of the Plan).

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2** Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3** Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to 12 months' notification in order to ensure that securities liquidations are carried out in an orderly business manner.

**NOTE E - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits (modified cash basis).

**NOTE F - TAX STATUS**

On June 30, 2020, the Internal Revenue Service stated that the Pre-approved plan adopted by the Plan, as then designed, qualifies under IRC Section 401(a). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company has indicated it will take any necessary steps, if any, to maintain the Plan's qualified status.

**NOTE G - PARTY-IN-INTEREST TRANSACTIONS**

AdvisorTrust, Inc. is the custodian of the Plan assets, Professional Capital Services, LLC is the recordkeeper of the Plan, SI Group Certified Pension Consultants provides third party administrative services, and Tao Investments Hawaii provides investment-related services. These transactions qualify as party-in-interest transactions. The Company pays substantially all administrative expenses related to these party-in-interest transactions.
