Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Career Path Services 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of Career Path Services 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

- a. **General** – The Plan is a defined contribution plan covering substantially all employees of Career Path Services (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An employee automatically becomes a participant in the elective deferral portion of the Plan on their first day of employment with the Company.
- b. **Contributions** – Participants make voluntary contributions to the Plan through payroll deductions of up to the Internal Revenue Service (IRS) maximum allowable contribution. Each plan year, employees of the Company who have reached 18 years of age and completed one year (1,000 hours) of continuous service are eligible to participate in the employer contribution portion of the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company may elect to contribute an amount determined annually. Participants may direct contributions to any of the available options offered by the Plan. Participant contributions may be either on a pre-tax (traditional) or post-tax (Roth) basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).
- c. **Participant accounts** – Each participant’s account is credited with the participant’s contributions and allocations of 1) the Company’s contribution, and 2) plan earnings and losses and is charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- d. **Vesting** – Participants are 100% vested in participant deferrals. For employer contributions, vesting occurs as follows:

- e. **Payment of benefits** – For in-service distributions (distributions while still employed with the Company), participants are allowed to 1) take distributions from their vested account balance once they reach age 59.5; 2) distribute any of their rollover contribution account balances; and 3) take distributions due to qualified hardships, provided that certain requirements specified in the plan document are met. For after-termination distributions, participants may take a distribution of their account balance immediately after their employment is terminated. Participants' nonforfeitable account balances less than \$1,000 shall be distributed in a lump-sum payment. Balances \$1,000 or greater, but less than \$5,000, shall be converted to an IRA. Benefits are distributed according to provisions set forth in the plan document.
- f. **Administration of the Plan** – The Plan is administered by the Company in the form of an investment committee. Plan assets are invested in accordance with the employee's instructions. Records of participant account activity are processed and maintained by Randall & Hurley, Inc., and Great-West Life & Annuity Insurance Company (dba Empower Retirement). Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
- g. **Forfeited accounts** – Forfeitures are used first to pay reasonable administrative expenses and then to reduce nonelective employer contributions. Forfeitures of \$4,849 and \$21,872 were used to pay Plan expenses during the years ended June 30, 2024 and 2023, respectively. Amounts held in forfeiture available to be used to pay administrative expenses and then to reduce nonelective employer contributions at June 30, 2024 and 2023, were \$129,372 and \$105,509, respectively.
- h. **Notes receivable from participants** – Notes receivable from participants are not available under the Plan.

Note 2 – Summary of Significant Accounting Policies

- a. **Basis of accounting** – The accounting records of the Plan are maintained on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.
- b. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Note 2 – Summary of Significant Accounting Policies (Continued)

c. **Investment valuation and income recognition (continued)** –

Purchases and sales of shares are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. **Payment of benefits** – Benefits are recorded when paid.

e. **Administrative expenses** – Administrative expenses are paid by either the Plan or the Plan's sponsor as provided by the plan document.

f. **Subsequent events** – Subsequent events have been evaluated through February 24, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Level 1 – Mutual funds are valued at the net asset value of shares held by the Plan at year end.

Level 2 – Fixed annuities are insurance contracts that are valued daily by the annuity provider by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Level 3 – The Plan had no investments that are classified as Level 3 for the years ended June 30, 2024 or 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 5 – Tax Status

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code (IRC) and, accordingly, the Trust's net investment income is exempt from income taxes. The Plan has obtained a favorable determination letter from the IRS. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related Trust is tax-exempt as of the financial statement dates. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the Plan could be subject to income tax if certain issues were found by the IRS that could result in the disqualification of the Plan's tax-exempt status; however, there are currently no audits for any tax periods in progress.

Note 6 – Related-party and Party-in-interest Transactions

The plan administrator is an employee of the plan sponsor. There are no transactions between the parties other than contributions to the Plan. Certain plan investments are shares of mutual funds managed by Empower Retirement, which performed record keeping and administrative services for the Plan. Randall & Hurley, Inc., is the Plan's third-party administrator. Pedey Investment Management Group (a service of DA Davidson & Co.) is the Plan's investment advisor. Anastasi, Moore & Martin, PLLC, is the Plan's auditor. Therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 7 – Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
