Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Chemlogix 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 26, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period ended June 26, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Chemlogix 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 26, 2024 (in liquidation) and December 31, 2023 (ongoing), and for the period from January 1, 2024 through June 26, 2024 (in liquidation), stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Chemlogix 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Note 1 to the financial statements, the Employer, by consent of its sole member, exercised its right to terminate the Plan effective April 1, 2024, and management determined liquidation is imminent. Accordingly, the Plan changes its basis of accounting from the going concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Chemlogix 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

NOTES TO FINANCIAL STATEMENTS

For the Period Ended June 26, 2024 (in Liquidation) and the Year Ended December 31, 2023 (Ongoing)

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Chemlogix 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering all employees of Chemlogix, LLC (the “Company”) who had six months of service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The trustees and plan administrator were responsible for oversight of the Plan, appropriateness of the Plan’s investment offerings, and monitored investment performance. Effective January 1, 2022, the Company amended the Plan and through a revised adoption agreement elected various safe harbor provisions. Such election had removed the vesting associated with all employer contributions and eliminated the discretionary match. All other provisions had remained the same.

Plan Termination

Effective April 1, 2024, the Employer, by consent of its sole member, exercised its right to terminate the Plan subject to the provisions of ERISA. All balances were distributed to the participants pursuant to their instructions. Accordingly, the Statements of Net Assets Available for Benefits for the Plan reflect zero balances as of June 26, 2024.

Contributions

Each year, participants could contribute up to the maximum limits allowable by the Internal Revenue Code (IRC) of pretax annual compensation, as defined by the Plan. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Company made a matching contribution equal to 100% of a participant’s first 3% of contributions plus 50% of contributions greater than 3% but less than 5%. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account was credited with the participant’s contributions and the Company matching contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

Vesting

Participants were vested immediately in their contributions and the employer matching contribution plus actual earnings thereon.

NOTE 1 - DESCRIPTION OF THE PLAN - CONTINUED

Notes Receivable from Participants

Participants were able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was based on the rates available for similar loans from commercial lending institutions, as defined. Principal and interest were paid ratably through bimonthly payroll deductions. Loans must have been repaid within a five-year period.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant would receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant would receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan allowed for hardship distributions if certain criteria were met.

Forfeited Accounts

At June 26, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$680, respectively. These accounts were allocated to be used in the following order: (1) used to offset plan expenses; (2) used to reduce future employer contributions; and (3) reallocated to participants, as specified in the plan agreement. Also, in 2024, \$680 of administrative expenses were offset from forfeited non-vested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared on the going concern basis of accounting as of December 31, 2023, in accordance with accounting principles generally accepted in the United States of America. As a result of the Plan's management approving a plan of dissolution, the Plan adopted the liquidation basis of accounting for the period of January 1, 2024 through July 26, 2024. This basis of accounting is considered appropriate when liquidation of a plan is imminent. See Note 1 for Plan Termination.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition - continued

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Net appreciation included the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowance for credit losses had been recorded as of June 26, 2024 and December 31, 2023. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Contributions

Contributions from plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Payment of Benefits

Benefits were recorded when paid or when distributions were made.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through March 22, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 26, 2024 and December 31, 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of participation units held by the Plan at year end. The NAV, as provided by the custodian, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

NOTE 4 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by Principal Life Insurance Company. Principal Life Insurance Company was the custodian for the Plan and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred and paid directly by the Plan for the investment manager services were included in administrative expenses on the statement of changes in net assets available for benefits.

NOTE 5 - PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Principal Life Insurance Company was removed as the Plan's custodian following the final distribution of Plan assets.

NOTE 6 - TAX STATUS

The Plan had adopted a non-standardized pre-approved profit-sharing plan with CODA sponsored by Principal Life Insurance Company. The non-standardized pre-approved profit-sharing plan had received an opinion letter from the IRS dated June 30, 2020, as to the non-standardized pre-approved profit-sharing plan's qualified status. Although the Plan had been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believed the Plan was designed and was being operated in compliance with the applicable provisions of the IRC and, therefore, believed the Plan was qualified, and the related trust was tax exempt.

Accounting principles generally accepted in the United States of America required plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at June 26, 2024 and December 31, 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the period January 1, 2024 through June 26, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company (the custodian of the Plan).

NOTE 9 - OPERATIONAL DEFECTS

During the year ended December 31, 2023, it was discovered that certain of the Plan's provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant and employer contributions as per the plan agreement was not properly applied when calculating contribution amounts for those that received vacation pay and the compensation used to calculate employer contributions. The plan administrator determined the affected participants and deposited \$1,320 into the Plan during 2023, to make the affected participants and the Plan whole, plus lost earnings. In addition, it was discovered that forfeitures were withheld from participants that received benefit payments during the year ended December 31, 2023. The plan administrator determined that \$2,479 was forfeited during 2023, and therefore a receivable and corresponding liability were recorded to correct the distributions.
