**NOTE A - DESCRIPTION OF PLAN**

The following brief description of Eakes Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan, which became effective October 6, 1987, and was most recently re-stated October 1, 2021, is a defined contribution plan covering all employees of Eakes, Inc. (the Company). Employees are eligible to participate in elective deferrals after three months of service, with Plan entry on the first day of the quarter after meeting the service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Elective Contributions.** Each year eligible employees may make pre-tax salary and Roth reduction contributions to the Plan not to exceed Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 27 mutual funds and one collective trust as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at four percent of eligible compensation and their contributions are invested in a designated target date fund that matches their retirement date based on their birthday until changed by the participant.

**Employer Contributions.** The Company may make a discretionary matching contribution or discretionary nonelective contribution on behalf of each eligible participant. Discretionary matching contributions are determined each Plan year and are based on elective deferrals. Nonelective contributions are based on a uniform percentage of participant compensation. Any discretionary contributions made are on behalf of all participants with at least one year of eligible service (1,000 hours) and who were employed on the last day of the Plan year. For the years ended September 30, 2024 and 2023, the Company made a matching contribution of 150% of the first \$250, 100% of the next \$500, and 50% of the next \$1,750 that a participant contributed to the Plan, provided they met the stated employment and service requirements. During the year ended September 30, 2024, the total matching contribution was \$340,581. The Company did not elect to make a discretionary nonelective contribution for the year ended September 30, 2024.

**Participant Accounts.** Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are vested immediately in their salary deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A year of service is any plan year during which an employee is credited with 1,000 hours of service. A participant is 20% vested after one year of service, 40% after two years, 60% after three years, 80% after four years and 100% after five years of credited service.

**NOTE A - DESCRIPTION OF PLAN - CONTINUED**

**Payment of Benefits.** On separation of service due to death, disability, retirement, or termination, a participant may elect to receive a cash distribution in the form of: (a) a lump sum or (b) installments over a period not more than his or her assumed life expectancy. Distributions may be made to a participant who has not separated from service upon reaching normal retirement age of 59½. Distributions may be made as soon as administratively feasible at the participant's election.

Termination of employment prior to normal retirement requires distribution if the account balance does not exceed \$5,000. The participant can elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if underage 59½. If no election is made, the benefit will be rolled over to an IRA. If the account balance is less than \$1,000, the distribution will be paid in cash. If the vested account balance is greater than \$7,000, the participant may defer distribution until normal retirement age or further defer to age 73.

Hardship withdrawals are permitted for the purposes specified by the Internal Revenue Code. Withdrawals cannot exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal from accounts that are fully vested.

**Forfeited Accounts.** Forfeiture accounts are used to pay administrative expenses, as an additional contribution, or to reduce the Company's contributions. At September 30, 2024 and 2023, these accounts totaled \$4,969 and \$9,062 respectively. During the year ended September 30, 2024, \$8,655 of forfeitures were used to reduce employer contributions.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition.** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**Investment Valuation and Income Recognition. - Continued**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Transfers between levels shall occur at the actual date of the event or change in circumstances that caused the transfer. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

Investments measured at net asset value (NAV) per share (or its equivalent using the practical expedient in FASB's fair value measurement guidance) are not required to be categorized in the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in net assets includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Employer Contribution Receivable.** Employer contribution receivable is measured at the amount owed to participants by the Company at September 30, 2024 and 2023.

**Payment of Benefits.** Benefits are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for the administration of the Plan are the responsibility of the Plan. If incurred directly by the Plan, these expenses are included in administrative expenses on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation of fair value of investments.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**NOTE C - FAIR VALUE**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used during the years ended September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust:* Valued at NAV, based on the market value of the underlying investments.

**NOTE C - FAIR VALUE - CONTINUED**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D – INVESTMENT IN COLLECTIVE TRUST**

The Plan holds units of participation in the Reliance Trust Company Stable Value Fund Collective Investment Trust Series (the Trust), which is invested solely in the MetLife Group Annuity Contract 25053 for the years ended September 30, 2024 and 2023. The Trust provides for the collective investment of defined contribution plans. The underlying assets of the MetLife Group Annuity Contracts are primarily in a pool of investment contracts that are issued by insurance companies and in contracts that are backed by bond funds. The issuers' ability to meet these obligations may be affected by economic developments in their respective companies and industries.

The Trust allocates its assets in proportion to each plan's beneficial interest in the Trust. At September 30, 2024 and 2023, the Plan's interest in the net assets of this Trust was less than .01 percent.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE F - TAX STATUS**

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan of Union Bank & Trust Company, which received a determination letter from the IRS dated June 30, 2020, stating that the Plan was designed in accordance with provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

For the years ended September 30, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's Federal Returns for September 30, 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE H - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended September 30, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Union Bank & Trust Company (the trustee of the Plan).

**NOTE I - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan receives custodial services from Union Bank & Trust Company and its affiliates, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan also pays for recordkeeping services. The Plan made direct payments to Union Bank & Trust Company for services of \$76,863 for the year ended September 30, 2024. The Plan has amounts due to the party-in-interest totaling \$19,460 and \$17,428 for the years ended September 30, 2024 and 2023, respectively.

**NOTE J - SUBSEQUENT EVENTS**

The Plan was amended effective January 1, 2025, to allow a higher catch-up limit for participants ages 60-63. The increased catch-up limit is the greater of: (a) 150% of the normal age 50 catch-up contribution; or (b) \$10,000 (indexed in future years). Effective December 29, 2025, qualified long-term care distributions are allowed.

Subsequent events have been evaluated through the audit report date, the date the financial statements were available to be issued.
