Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan of HMS School for Children With Cerebral Palsy (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of the 403(b) Thrift Plan of HMS School for Children With Cerebral Palsy (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective July 1, 2008, as restated January 15, 2020. The Plan covers all employees of HMS School for Children with Cerebral Palsy (the School), excluding nonresident aliens with no United States source of income and employees who are eligible to make salary reduction contributions to another plan of the School. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The School's Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year, as well as participants who have worked for the School for at least 15 years, are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participant contributions to the Plan are recorded in the period that payroll deductions are made from participants. Participants direct the investment of their contributions into various investment options offered by the Plan. The School makes contributions to eligible participants who have attained 21 years of age, who normally work more than 20 hours a week, and who have one year of service, which is defined as 1,000 hours of credit service by the plan document. For purposes of eligibility, an eligible participant's service with an organization in the nonprofit health or social service field or with a nonprofit educational institution within the three-year period immediately before employment with the School will be counted towards the minimum service requirement provided the participant has worked 1,000 hours with such organization. The School contributes a matching contribution equal to the lesser of (a) 50% of eligible participants' salary deferrals during the year or (b) 3% of eligible participant compensation as defined by the plan document. The School also contributes a base contribution equal to 15% of eligible compensation for eligible participants who have attained age 50 and who had 10 years or more of service with the School as of December 31, 2007 or 5% of eligible compensation for all other eligible participants, as defined. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan includes an Eligible Automatic Contribution Arrangement feature for all employees who became participants on or after April 1, 2018 and shall be deemed to have directed the School to make a salary reduction contribution on their behalf effective as of the first pay period beginning on or after the later of (i) the Entry Date that they begin or resume participation in the Plan or (ii) the day they satisfy the eligibility requirements. Eligible participants who were automatically enrolled and had not opted out using the 90-day opt-out withdrawal provision of the arrangement had to make salary reduction contributions of 1% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and the School's matching contribution, as well as the School's base contribution and the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the School's contributions is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants are also 100% vested after attainment of early retirement age, normal retirement age, death or disability.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of lump sum payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeited accounts will be used to pay administrative expenses or to reduce future School contributions. During 2024, \$3,795 of forfeitures were used to reduce School contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The School's Board of Trustees determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through March 27, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Pooled separate accounts are valued based upon the unit values of such pooled accounts held by the Plan at year-end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

The interest accumulation account holds a nonbenefit-responsive guaranteed investment contract and is reported at fair value, which approximates contract value. Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with the historical crediting rates.

4. Concentrations

As of June 30, 2024 and 2023, the Plan had investments of \$7,127,925 and \$7,430,790, respectively, that were concentrated in two funds.

5. Guaranteed Investment Contract

The Plan entered into a guaranteed investment contract held in an interest accumulation account with Mutual of America Life Insurance Company (Mutual), the custodian of the Plan. Mutual maintains contributions in an unallocated fund to which it adds interest of 1%. If changed, the new rate applies only to funds deposited from the date of change. At the direction of the Plan's fund administrator, a single premium to buy an annuity for a retiring employee is withdrawn by Mutual from the unallocated fund. Purchased annuities are contracts under which Mutual is obligated to pay benefits to named employees or their beneficiaries. The premium rates for such annuities to be purchased in the future and maximum administration expense charges against the fund are also guaranteed by Mutual.

Funds under the guaranteed investment contract that have been allocated and applied to purchase annuities (that is, Mutual is obligated to pay the related benefits) are excluded from the Plan's assets.

6. Information Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Mutual, the Custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of June 30, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of June 30, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended June 30, 2024.

7. Related-Party and Party in Interest Transactions

Certain plan investments are managed by Mutual, the Custodian, and therefore, these transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the School. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their School contributions.

9. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

11. Delinquent Participant Contributions

For the year ended June 30, 2023, the School did not remit certain participant contributions to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions totaled \$87 in 2023, of which \$66 were corrected in 2023 outside of the DOL Voluntary Correction program. The remaining \$21 was corrected after June 30, 2024 outside of the DOL Voluntary Correction program. Additionally, the School has compensated participants for lost earnings resulting from the delay in contributions.
