## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Mountain Island Charter School 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023 and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **1. Plan Description**

The following description of the Mountain Island Charter School 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan that operates under Section 403(b) of the Internal Revenue Code covering all employees of Mountain Island Charter School (the "School" or "Sponsor"). Employees are eligible to participate immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may contribute amounts up to the allowable deferral limit defined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective April 1, 2021, all new employees are auto-enrolled at 3 percent unless they elect otherwise. The School may make discretionary matching contributions to all eligible participants each pay period as determined annually by the Plan Administrator. During the plan year, the matching contribution formula was 100 percent up to 3 percent of eligible compensation that a participant contributes to the Plan. Contributions are subject to certain regulatory limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the School's contributions, and allocations of plan earnings and losses. Allocations of Plan earnings and losses are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct all contributions into selected investment options as made available and determined by the Plan Administrator. The Plan currently offers separate accounts and a fixed insurance contract as investment options. Participants have daily access to their investment balances. Investment elections and any changes are self-directed by the participants.

#### ***Notes Receivable from Participants***

Participants may borrow from their fully vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 2 percent, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

#### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or due to other reasons; a participant or, when applicable, a designated beneficiary, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum or installment. Hardship distributions are available if a participant satisfies certain conditions. The Plan also allows for in-service distributions upon attaining age 59 ½.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon and become 100% vested in employer contributions after completing 1 year of service.

### ***Forfeiture Accounts***

At June 30, 2024 and 2023, forfeited non-vested accounts amounted to \$6,701 and \$2,951, respectively. Any account balances may be used to reduce future School contributions or to pay for Plan expenses. Forfeitures of \$313 were utilized during the Plan year to pay for plan expenses.

### ***Administrative Expense***

Certain administrative expenses are paid by the School and are therefore excluded from these financial statements. Investment related expenses paid by the Plan are included in net appreciation of fair value of investments. Administrative fees for certain participant requested services are charged directly to the participant accounts.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The investments of the Plan are reported at fair value other than the guaranteed investment contracts. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date (the exit price). The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor and insurance company.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of June 30, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Participant loans in the amount of \$4,589 were deemed defaulted during the Plan year ended June 30, 2024, and recorded as distributions.

### **Payment of Benefits**

Benefit payments are recorded upon distribution.

### **3. Unaudited Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement and American United Life Insurance Company ("AUL") have certified that the following date included in the accompanying financial statements is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedules.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at June 30, 2024 and 2023.

*Separate Accounts:* The fair values of participation units held in separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the separate accounts invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these separate accounts are consistent with each of the mutual funds identified in the name of the fund. Each of the separate accounts provides for daily redemptions by the Plan with no advance requirements and has redemption prices that are determined by the fund's net asset value per unit as a practical expedient and are therefore not included in the fair value hierarchy. As the separate accounts do not file as direct filing entities, the underlying registered investments are reported on the Form 5500.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There are no investments that fall within the fair value hierarchy as of June 30, 2024 and 2023. The following table presents the fair value of the Plan's assets as of June 30, 2024 and 2023:

(a) The separate accounts each invest in a single, open-ended mutual fund which is generally identified in the name of the separate account. The investment strategies of these separate accounts are consistent with each of the mutual funds identified in the name of the fund.

## 6. Investment Contracts

The Plan has a fully benefit-responsive guaranteed investment contract with Empower and one with AUL. Both entities maintain the contributions in a general account of the entity. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are both fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value, which approximates fair value. Contract value, as reported to the Plan by Empower and AUL, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The contract value of the investment contracts at June 30, 2024 and 2023 are as follows:

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, the amounts credited to the accounts of the participants shall be distributed to the participants or their beneficiaries under the terms of the Plan agreement.

### **8. Income Tax Status**

The Plan has received an opinion letter dated November 22, 2017, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan is amended from time to time. The Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

### **9. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **10. Non-Exempt Transactions**

During the plan year ended June 30, 2024, employee withholdings amounting to \$191,679, were not remitted to the Plan within the appropriate time frame by the School. These transactions constitute prohibited transactions as defined by ERISA. The School remitted these contributions to the Plan during the Plan year. Lost earnings were paid to the Plan in March 2025.

### **11. Related Party Transactions**

Certain Plan investments are registered investments and investment contracts managed by AUL and Empower, the contract holders, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.
