Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Criterion Child Enrichment, Inc. Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1 – DESCRIPTION OF THE PLAN

General

Criterion Child Enrichment, Inc. Defined Contribution Retirement Plan (the "Plan") is a defined contribution plan that was established on July 1, 1985 for the benefit of employees of Criterion Child Enrichment, Inc. (the "Organization"). The Plan is funded by contributions from the Organization and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrator is the President of the Organization.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Eligibility for Participation

Employees with one year of service totaling 1,000 or more hours during the Plan year and who have attained the age of twenty-one years are eligible to participate in the Plan.

In addition, employees must contribute to the Criterion Child Enrichment, Inc. Tax-Deferred Annuity (TDA) Plan during the Plan year and be employed on the last day of the Plan year in order to participate in the Plan.

Contributions

Contributions to the Plan are made by the Organization on behalf of each eligible participant on an annual basis. The Organization will contribute the lesser of each participant's contributions to the Criterion Child Enrichment, Inc. Tax-Deferred Annuity (TDA) Plan or 5% of base compensation for all eligible participants who are employed by the Organization at the end of the Plan year. The Organization will also make a contribution for each eligible participant who separated from employment during the Plan year as a result of retirement, disability or death.

Employee contributions are limited to rollovers and transfers from other qualified retirement plans.

Vesting

Prior to July 1, 2007, employees vested in 100% of their participant accounts upon five years of credited service. Effective July 1, 2007, employees vest in 100% of Plan contributions made for Plan years commencing on or after July 1, 2007, upon three years of credited service or at normal retirement age, death or disability, if earlier. Rollover and transfer contributions are always 100% vested. Participants who are involuntarily terminated due to the closing of a location or a program of the Organization shall be treated as fully vested. The portion of a terminating employee's account that is not vested is forfeited and deposited into the Repurchase Fund Account. The amounts deposited into the Repurchase Fund Account must be used to offset future contributions.

Participant Accounts

Accounts are maintained for each participant. Accounts are increased for contributions, transfers and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

Investment Options

In accordance with investment elections specified by each participant, contributions to the Plan may be invested in a variety of investments offered by Teachers Insurance and Annuity Association of America (“TIAA”) and College Retirement Equities Fund (“CREF”).

A portion of the Plan’s investments are also invested in the Brighthouse T-Flex Fund, which is an investment contract offered by Brighthouse Life Insurance Company (“Brighthouse”) that provides a guaranteed rate of return but does not guarantee principal. As of June 30, 1997, participants could no longer direct contributions to this fund.

TIAA, CREF and Brighthouse are the Plan’s custodians.

Notes Receivable from Participants

As described below, the custodians allow notes receivable from participants in the form of Participant Loans and Plan Loans.

Participant Loans

Participants may borrow a Participant Loan from his/her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participant Loans are secured by the balances in their accounts and bear interest at rates commensurate with local prevailing lending rates in accordance with the Plan’s Participant Loan policy. Principal and interest is paid ratably through payroll deductions.

Participant Loans, if any, are deducted from participants’ accounts and reported on the Statements of Net Assets Available for Benefits as notes receivable from participants.

Plan Loans

Participants may borrow a Plan Loan from his/her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, 45% of his/her combined TIAA and CREF accounts, or 90% of his/her TIAA Traditional Annuity Account. Participants are required to set aside an amount equal to 110% of the amount of their loans in their TIAA Traditional Annuity Account as security for the loans and may not make a withdrawal from such funds securing the loans. Plan Loans bear interest at a commercially reasonable rate established by the Plan Administrator or under the terms of the applicable funding vehicle. Principal and interest is paid directly by the participants to the custodians.

Plan Loans are not deducted from participants’ accounts and, therefore, not reported on the Statements of Net Assets Available for Benefits. However, if a Plan Loan from a participant goes into default, then the related collateral is reported as a Plan asset and included in the Plan Loan Default Fund, which is reported in investments, at contract value, on the Statements of Net Assets Available for Benefits.

In-service Withdrawals

In-service withdrawals may only be made under the following circumstances:

- Hardship as defined in the Internal Revenue Code and in the Plan document
- Disability

Retirement Benefits

The normal retirement age under the Plan is age 65. Certain participants may be eligible for early retirement subject to the provisions in the Plan document. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

Payment of Benefits

Upon termination of service from the Organization, a participant may elect to receive the vested portion of his/her account in the form of a single lump sum or any other form of settlement available from the manager of the investment fund in which the participant's account or portion thereof is invested.

Timing of Distributions

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the custodians.

As of June 30, 2024 and 2023, there were no distributions payable to participants.

Administrative Expenses

Substantially all administrative expenses incurred by the Plan are paid by the Organization.

Forfeited Accounts

At June 30, 2024 and 2023, cumulative forfeited non-vested accounts totaled \$2 and \$83, respectively. These amounts represent the balance of the Repurchase Fund Account that must be used to offset future contributions and are carried as assets of the Organization.

Participant-Directed Contributions, Withdrawals and Transfers

The manner of electing to allocate contributions between the investment options, and any decision to change such allocation, is made by the participant as permitted by the custodians. Withdrawals and transfers are recorded at the time such transactions take place.

2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

Investments are reported at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and, for money market instruments, includes amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Investments (continued)

The Plan invests in a fixed rate annuity contract (TIAA Traditional Annuity), which is not considered to be fully benefit responsive. As required by GAAP, the Statements of Net Assets Available for Benefits present the fair value of the investment in the fixed rate annuity contract. See Notes 4 and 5 for additional information.

Each participant's assets are jointly invested and the return on assets is allocated monthly among the participants and recorded as income or loss. The basis of allocation is the unit of participation method. Under this method, contributions and income result in an increase of units of participation while benefits paid and losses result in a decrease of units of participation.

Payment of Benefits

Benefits are recorded when processed and approved for payment.

Risks and Uncertainties

The Plan provides for various investment options in various accounts that are investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan Administrator evaluated events that occurred after June 30, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued, March 27, 2025, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

3 – INFORMATION CERTIFIED BY CUSTODIANS

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's custodians and furnished to the Plan Administrator and includes all Plan assets (except for the effects of employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained certifications from the custodians that such information is complete and accurate.

4 – FAIR VALUE MEASUREMENTS

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

CREF Variable Annuity Accounts

These accounts invest principally in equity securities, fixed-income instruments, and short-term instruments in accordance with each portfolio's investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value each day, which are published by National Association of Securities Dealers Automated Quotations ("NASDAQ").

TIAA Pooled Separate Account

The Pooled Separate Account invests in the TIAA Real Estate Account ("REA"), which consists of real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day and are published by NASDAQ.

TIAA Access Annuity Accounts

The TIAA Access Annuity Accounts consist of a variable annuity product that is funded through TIAA Separate Account VA-3 ("VA-3"), a separate investment account of TIAA, which is registered with the U.S. Securities and Exchange Commission as an investment company under the Investment Company Act of 1940. VA-3 invests in proprietary and nonproprietary mutual funds through various subaccounts. Subaccount unit values are calculated daily and are published by TIAA. The underlying investments are generally valued using market quotations obtained from independent pricing services.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Brighthouse Investment Contract

This account is reported at contract value which Brighthouse has indicated approximates fair value based upon comparable assets.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

TIAA Insurance Investment Account

The TIAA Insurance Investment Account consists of the non benefit responsive TIAA Traditional Annuity Account and is reported at contract value. The contract value of the TIAA Traditional Annuity Account equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals and transfers, if any. The TIAA Traditional Annuity Account is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable; however, contract value provides a reasonable approximation of fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The TIAA Traditional Annuity is a fixed annuity contract that is fully and unconditionally guaranteed by TIAA. During the accumulation phase, the TIAA Traditional Annuity provides a guarantee of principal, a guaranteed minimum rate of interest between 1% and 3% and the potential for additional interest, if declared by TIAA.

Additional interest, when declared remains in effect for the “declaration year”, which begins each March 1. Additional interest is not guaranteed for future years. When the contract value accumulation (plan asset) of the TIAA Traditional Annuity is converted to an annuity (plan withdrawal) based on life expectancy, the present value of the stream of payments is equal to the accumulation. The crediting rate is supported by the investment performance of a large, diversified portfolio (TIAA’s General Account), is correlated with the highest quality debt security yields, and is adjusted for contract liquidity. The TIAA Traditional Annuity is fully and unconditionally guaranteed and backed by the claims-paying ability of TIAA.

6 – NOTES RECEIVABLE FROM PARTICIPANTS

As described in Note 1, Participant Loans, if any, are deducted from participants’ accounts and reported on the Statements of Net Assets Available for Benefits as notes receivable from participants. There were no Participant Loans outstanding at June 30, 2024 and 2023.

7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, all affected participants will become vested in their accounts.

8 – INCOME TAX STATUS

The Angell Pension Group, Inc. ("APG") obtained an opinion letter from the Internal Revenue Service indicating its volume submitter prototype plan document is a qualified form of a plan under Internal Revenue Code Section 401(a). The Organization has adopted APG's volume submitter plan document as its plan document. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments consist of shares of various accounts managed by TIAA, CREF and Brighthouse. TIAA, CREF and Brighthouse are the custodians of the Plan's assets and, therefore, these transactions qualify as party-in-interest.

The Organization provides certain administrative services at no cost to the Plan. The Organization also pays for certain administrative costs of the Plan.
