## Independent Auditors' Report

To the Plan Administrator  
South Shore Mental Health Center, Inc. Tax Sheltered Annuity Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the South Shore Mental Health Center, Inc. Tax Sheltered Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Basis of Accounting**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**Note 1 – Description of the Plan**

The following brief description of the South Shore Mental Health Center, Inc. Tax Sheltered Annuity Plan (the “Plan”) is provided for general information purposes only. More complete information is provided within the plan documents.

*General*

The Plan is a contributory tax-sheltered annuity plan established July 1, 1981. The plan is sponsored by South Shore Mental Health Center, Inc. d/b/a Aspire Health Alliance (the “Company”), a not-for-profit organization described in Section 501(c)(3) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Company is the Plan Administrator. In general, the Plan Administrator manages the operations of the Plan subject to the terms and provisions of the Plan.

Great-West Life & Annuity Insurance Company, an affiliate of Empower Retirement (“Empower”) and Lincoln National Life Insurance Company (“Lincoln”) are the custodians of the Plan’s assets.

*Eligibility*

Employees of the Company become eligible to participate in the Plan upon hire. Employees become eligible for matching employer contributions after one year of service. A year of service is generally defined as 1,000 hours per year except that with respect to fee-for-service employees, this requirement is a minimum of 600 clinical units in an eligibility computation period. Leased employees and any employees who are regularly scheduled to work less than 20 hours per week are not eligible for matching employer contributions.

*Contributions*

Each employee may elect to make an annual pre-tax contribution to the Plan up to the maximum annual deferral amount allowed by the Internal Revenue Code (“IRC”). The annual deferral percentage is subject to certain limitations specified by Internal Revenue Service (“IRS”) regulations. The Plan provides for a discretionary employer matching contribution decided by the Board of Directors each year.

Participants aged 50 and over are permitted to make catch-up contributions. Participants may contribute rollovers from other qualified plans, which do not count against the IRC maximum. The Plan also permits participants with at least 15 years of service with the Company to make additional elective deferrals.

*Participant accounts*

Each participant’s account is credited with the participant’s contributions and an allocation of Company contributions, Plan earnings (losses), and Plan expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon.

Vesting in the Company’s matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Generally, a participant is 100% vested after 3 years of credited service.

*Benefits*

Participants in the Plan are entitled to receive benefits at normal retirement age (65), termination of employment, death or disability. Participants may elect to receive benefits based on the vested balance in their accounts as either, (a) a lump-sum cash payment, (b) various annuities or (c) installment payments. Participants with account balances greater than \$5,000 may leave the account with the Plan until age 72 (if born after June 30, 1949) or age 70-1/2 (if born before July 1, 1949), at which time, another option must be elected. The Plan allows for (a) hardship withdrawals and (b) in-service withdrawals upon the participant reaching age 59-1/2.

*Notes receivable from participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, and, as of June 30, 2024, bear interest at rates ranging from 4.25% to 9.50%. The term of the note may not exceed 5 years or 15 years in the case of a loan used to acquire a participant's principal residence. Principal and interest are paid ratably through payroll deductions.

*Forfeited accounts*

Any forfeitures that result from participants who terminate employment before they are 100% vested in their matching accounts may be used to either reduce employer contributions or to pay eligible administrative expenses of the Plan.

**Note 2 – Summary of significant accounting policies**

*Basis of accounting*

The Plan prepares its financial statements and supplemental schedule on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, contributions and expenses are not recognized until received or paid, respectively.

*Accounting estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

*Administrative expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

*Investment valuation*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See discussion under "*Fair Value Measurements*" for a description of valuation methodologies used for assets measured at fair value.

*Income recognition*

Purchases and sales of securities are reflected on a trade-date basis. Gain or loss on sales of investments is based on average cost. The Plan reports the net appreciation (depreciation) in the fair value of its investments in the Statements of Changes in Net Assets Available for Benefits, which consists of realized and unrealized gains or losses. Interest income is recorded, as earned, on an accrual basis. Dividend income is recorded on the ex-dividend date.

*Guaranteed investment contracts*

Guaranteed investment contracts held by a defined contribution plan are required to be reported at contract value which is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

*Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

*Payment of benefits*

Benefits are recorded when paid.

**Note 4 – Fair value measurements**

The Fair Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the Net Asset Value ("NAV") of shares held by the Plan at year end.

All of the Plan's investments at June 30, 2024 and 2023 are classified as Level 1, within the fair value hierarchy.

**Note 5 – Guaranteed investment contracts**

The Plan has benefit responsive guaranteed investment contracts with Empower and Lincoln. Empower and Lincoln maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The investment contract is considered a "traditional" contract, meaning that the Plan owns the contract itself and not the underlying assets for the investment contract.

Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for the portion of net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by Empower and Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value. Transfers and partial withdrawals from the fixed accounts are generally limited to 20% of a participant's fixed account balance per year. Full withdrawals from the fixed accounts may be made for death, separation from service, hardship, and small account balances. Full withdrawals from the fixed accounts for other reasons are limited and generally must be made in five installment payments over five years.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1% to 3%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that would cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**Note 6 – Plan termination**

Although it has not expressed any intent to do so, the sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 7 – Tax status**

The Plan has not obtained a private letter ruling or determination letter from the Internal Revenue Service stating that the plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). However, the Plan Administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements under Section 403(b) of the IRC and is, therefore, exempt from Federal income taxes under Section 501(a).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by Federal or State tax authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**Note 8 – Parties-in-interest**

Affiliates of the custodians of the Plan sponsor investments and provide recordkeeping services to the Plan. These investments and the administrative fees associated with the recordkeeping services qualify as party-in-interest transactions.

**Note 9 – Risks and uncertainties**

The Plan's investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, changes in the values of investment securities can occur in the near term and those changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 10 – Subsequent events**

The Plan has evaluated all events and transactions through March 11, 2025, the date the financial statements were available to be issued. There were no events or transactions that occurred that would require recognition or disclosure in the financial statements.
