Opinion

We have audited the financial statements of the Brethren Village Group Medical Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended June 30, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Brethren Village Group Medical Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a self-insured welfare benefit plan that provides medical and prescription drug benefits to covered persons who are employees of Brethren Village (the Organization). The Organization provides payments for the benefit of the Plan. Employees may be required to pay for a portion of the cost of the benefit. The Plan is funded through a trust arrangement administered by The Benecon Group, LLC. The Plan's human resources staff administers the Plan and the V.P., Human Resources is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

All employees who work at least 30 regularly scheduled hours per week are eligible for coverage. Coverage under the Consolidated Omnibus Budget Reconciliation Act is available for terminations as defined in the plan document.

Contributions

Participants are required to contribute to the Plan to fund a portion of the cost of their medical benefits through payroll deductions. Amounts required to be contributed by participants are determined annually by the V.P., Human Resources in accordance with the plan document. The remainder of the funding required to pay benefits under the Plan is paid by the Organization.

Stop Loss Coverage

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance covers the Plan's obligations if all claims exceed a fixed dollar amount.

Self-Insured Benefits

All plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's trust assets. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants was retained by the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, incurred but not reported claims payable and disclosure of contingent assets, liabilities and benefit obligations. Actual results could differ from these estimates.

Payment of Benefits

Health claim payments are recorded when paid by the third-party claims processor, and are included in health claims paid, net in the accompanying Statement of Changes in Net Assets Available for Benefits. Amounts due to health claims processors that have yet to be reimbursed by the Plan are recorded as health claims payable in the accompanying Statements of Benefit Obligations.

Stop Loss Refunds

Premiums paid by the Plan are recorded as stop loss premiums paid in the accompanying Statement of Changes in Net Assets Available for Benefits. Stop loss refunds, which are recorded as a reduction in health claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits totaled \$152,231 during the year ended June 30, 2024, of which \$11,320 is recorded as a receivable on the accompanying Statements of Net Assets Available for Benefits at June 30, 2024.

Claims Incurred but not Reported

Plan obligations at June 30, 2024 and 2023 for medical claims incurred by active participants but not reported are calculated by an actuary using historical claims information provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Administrative Expenses

Substantially all administrative expenses of the Plan, including, but not limited to, costs related to claims processing, legal, accounting and certain recordkeeping services are paid from plan assets. These expenses are recorded in the Statement of Changes in Net Assets Available for Benefits as administrative expenses. All other administrative expenses are paid by the Organization on behalf of the Plan and are excluded from these financial statements.

Interest-Bearing Cash

Interest-bearing cash includes demand or similar deposits with banks and/or financial institutions.

Subsequent Events

Subsequent events were evaluated through April 2, 2025, the date the financial statements were available to be issued. See also Note 9.

3. Concentrations

At June 30, 2024 and 2023, the Organization maintained its interest-bearing cash at one financial institution. Such balances are insured by the Federal Deposit Insurance Corporation up to \$250,000.

4. Related-Party and Party in Interest Transactions

The Plan's cash account is held by UMB Bank, N.A. the custodian of the Plan. Transactions in such asset accounts qualify as party in interest transactions, which are exempt from the prohibited transaction rule.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Organization or be used for purposes other than for the exclusive benefit of the Plan's participants.

6. Tax Status

The Plan is funded through the Retirement Community Health Plan of Pennsylvania (RCHPP) nonqualified trust under Internal Revenue Code (IRC) 419(a). The trust established to fund the benefits files Form 1041 U.S. Income Tax Return for Estates and Trusts and may be subject to income tax. RCHPP is a nonprofit corporation. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely the Plan would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

Claims incurred but not reported are calculated based on historical trends of claims reported but not settled and claims that have been incurred but not reported. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.
