We have performed an audit of the financial statements of U.K.S.M.-W., M.P.A. Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. PLAN DESCRIPTION

The following description of the U.K.S.M.-W., M.P.A. Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement or summary plan description for a more complete description of the Plan's provisions.

#### General

The Plan was established January 1, 1995, restated September 7, 2017 and most recently amended March 4, 2021. The Plan is a defined contribution plan covering full time employees of University of Kansas School of Medicine – Wichita Medical Practice Association (Association). There are no service or age requirements for purposes of elective deferrals. Employees may participate in contributions other than elective deferrals upon completion of one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Principal Trust Company served as the Plan's asset custodian and Principal Life Insurance Company served as the Plan's record keeper.

#### Contributions

Participants may contribute up to 100% of their annual compensation as defined in the Plan, subject to certain IRC limitations. Employees have the option to designate all or any portion of their future elective contributions as 403b pretax or Roth after tax elective deferral contributions. The Association contributes a safe harbor matching amount. The Plan's safe harbor employer match is 200% of elective deferral contributions that are not over 2% of compensation, plus 150% of elective deferral contributions that are in excess of 2% but not more than 5% of compensation.

#### Vesting

Participants are immediately vested in their contributions (including rollover contributions), employer contributions, plus actual earnings thereon.

#### Participant accounts

Each participant's account is credited with a) the participant's contribution, b) the employer's contribution, and c) earnings on the participant's account.

#### Investment options

Participants may direct their accounts to be invested in any of the investment options offered by the Plan. Participants may change their investment options daily.

### 1. PLAN DESCRIPTION (continued)

#### Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed 5 years, except for loans used for the purchase of a principal residence, and must provide for payments to be made not less frequently than bi-weekly. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate of local prevailing rates. Participants are charged for any related loan fees.

#### Payment of benefits

Withdrawal benefits may be paid upon the following: retirement (age 65), early retirement (age 55 with 5 years of service), death, disability, termination of employment, or financial hardship. A participant may elect to receive benefit payments in the form of a life annuity, in installments or as a lump-sum.

#### Forfeitures

All participant balances are fully vested, therefore there are no forfeited nonvested accounts.

### 2. SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Valuation of investments and income recognition

Mutual funds are presented at estimated fair value as provided by Principal Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are valued at contract value as estimated by Principal Trust Company. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

All financial instruments held by the Plan are participant directed investments.

### 2. SIGNIFICANT ACCOUNTING POLICIES (continued)

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

#### Excess Contributions Payable

Amounts payable to the employer for contributions in excess of amounts allowed by the Plan are recorded as a liability with a corresponding reduction to employer contributions. Excess contributions payable will be used to reduce future employer contributions.

#### Payment of benefits

Benefits are recorded when paid.

#### Operating expenses

Substantially all expenses of maintaining the Plan are paid by the Association.

### 3. INVESTMENTS/FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

#### *Level 1*

Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

#### *Level 2*

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### *Level 3*

Inputs that are unobservable inputs for the asset or liability.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amount reported in the statement of net assets available for benefits.

### 4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

#### Guaranteed Interest Contract

The Principal Life Insurance Fixed Income contract is a fully benefit-responsive group annuity contract issued by the Principal Life Insurance Company. Under the terms of the annuity contract, the Composite Crediting Rate is declared 30 days prior to the beginning of the respective deposit period. The methodology for calculating the interest crediting rate is defined in the annuity contract. The rates are determined from rates that are net after fees. Under the terms of the existing contract, the Composite Crediting Rate is currently reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate.

By definition, the guaranteed interest contract is an insurance contract. As a result, the Plan may transact according to the terms defined in the contract at any time. The terms and methods under which the contract may transact are defined in the annuity contract. Accordingly, the contract defines those events limiting the Plan's ability to transact at contract value with participants. The contract defines the circumstances and amounts for which the contract may be terminated by the Plan. Under terms of the contract, the issuer, Principal Life Insurance Company, has the right to no longer receive deposits. However, the circumstances for termination of the contract are still subject to provisions of the contract.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

### 4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (continued)

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

### 5. PLAN TERMINATION

Although it has expressed no intent to do so, the Association reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination and the Trustee shall liquidate all assets of the Trust and continue to administer the Trust in accordance with its provisions until all obligations have been satisfied.

### 6. RELATED PARTY TRANSACTIONS

Certain investments held by the Plan as of June 30, 2024 and 2023, are managed or sponsored by Principal Life Insurance Company or its affiliates. Principal Trust Company, an affiliate of Principal Life Insurance, served as asset custodian for the Plan. Additionally, Principal Life Insurance Company provided administrative services to the Plan.

The Association pays the majority of the Plan's administrative expenses on behalf of the Plan.

### 7. TAX STATUS

The Plan has adopted a non-standardized prototype plan sponsored by Principal Financial Group. The IRS determined and informed the prototype plan by letter dated March 31, 2017 that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

The Plan is required to operate in conformity with the code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statement.

### 7. TAX STATUS (continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions generally for up to three years after filing; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it has not taken any uncertain tax positions that would subject the Plan to a tax liability or asset.

### 8. INFORMATION CERTIFIED BY ASSET CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian has certified that the following data included in the financial statements and supplemental schedule is complete and accurate.

The following information was certified by Principal Trust Company as of June 30, 2024 and 2023 and for the year ended June 30, 2024:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended June 30, 2024
- Schedule H, Line 4i – schedule of assets (held at end of year), June 30, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 9. SUBSEQUENT EVENTS

Subsequent events were evaluated through December 31, 2024 which is the date the financial statements were available to be issued.
