INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of
Building Service 32BJ Legal Services Fund:

Opinion

We have audited the financial statements of the Building Service 32BJ Legal Services Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, which comprise the statements of net assets available for benefits and benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, information regarding the net assets available for benefits and benefit obligations of the Building Service 32BJ Legal Services Fund as of June 30, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Building Service 32BJ Legal Services Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Building Service 32BJ Legal Services Fund's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. PLAN DESCRIPTION AND FUNDING

The following description of the Building Service 32BJ Legal Services Fund (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan’s summary plan description for a complete description of the Plan’s provisions.

General

The Plan is a multiemployer employee welfare benefit plan and was established under the terms of collective bargaining agreements between 32BJ SEIU (the “Union”), the Realty Advisory Board on Labor Relations, Inc. and certain employers. The Plan provides certain legal benefits and representation to eligible participants employed in the building service industry and their eligible dependents, who are covered under collective bargaining agreements or participation agreements covering the participant, as well as to retirees and their spouses if the retiree is receiving retirement benefits under Program A, Program B or Program C of the Building Service 32BJ Pension Fund or under the 32BJ School Workers Pension Fund.

The Plan is administered by a Board of Trustees (the “Trustees”) with equal representation by the employers and the Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Benefits

The Plan provides legal benefits and representation to eligible participants and their eligible dependents for covered legal matters. Eligibility for benefits depends upon the particular collective bargaining agreement or participation agreement. Generally, an active employee is eligible for benefits if the participant works more than two days a week for the same contributing employer and completes the applicable waiting period. Retirees and their spouses are eligible, on a limited basis, for certain areas of coverage when the retiree commences receiving a pension from the Building Service 32BJ Pension Fund (Programs A, B or C) or the 32BJ School Workers Pension Fund. Otherwise eligible dependents of a participant are not eligible for benefits when the situation involves a legal dispute with the participant. Eligible participants and their eligible dependents are covered for thirty days after the participant terminates employment.

Covered legal matters depend upon whether a participant is an active participant or a retiree. All participants are responsible for the first \$500 of necessary and reasonable litigation expenses on all cases except citizenship, relative petition or adjustment of status application, temporary status, green card renewal or deferred action for childhood arrivals case, plus half of all additional necessary and reasonable litigation expenses incurred with regard to a covered legal matter. The Plan pays the other half of necessary and reasonable litigation expenses up to \$6,000 for most legal matters covered by the Plan. For citizenship, relative petition, adjustment of status application, temporary status, green card renewal or deferred action for childhood arrivals cases participants pay a \$100 deductible. After the deductible is met, the Plan will pay all necessary and reasonable litigation expenses up to \$6,000. If any additional expenses are incurred after the Plan has paid the maximum, the participant is responsible for payment. The Plan is not responsible for fines or penalties or for attorneys’ fees to or for an adverse party or imposed by a court order.

Plan Funding

The Plan’s primary sources of income are earnings from investments and contributions made by contributing employers in accordance with collective bargaining agreements or participation agreements, including applicable side letters and addenda. These agreements provide that the employers contribute to the Plan at a fixed rate on behalf of each covered employee.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are significant accounting policies followed by the Plan:

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and benefit obligations, and the disclosure of contingencies, at the date of the financial statements and changes therein during the reporting period. Actual results could differ from those estimates.

Cash Equivalents

Highly liquid investments with a maturity of three months or less, when acquired, are considered cash equivalents.

Employers' Contributions Receivable

The Plan reports as employers' contributions receivable any contributions due that relate to work completed on or before June 30. Management of the Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of June 30, 2024 and 2023, there was no allowance for uncollectible amounts established.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by its investment advisors and custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Restricted Cash

Restricted cash is received from participants and held in escrow for subsequent disbursements on behalf of the participants in connection with certain legal services program benefits.

Property and Equipment

Property and equipment are capitalized at cost and presented net of accumulated depreciation and amortization. Expenditures for maintenance and repairs are expensed as incurred, while the cost of additions and improvements that extend the useful life of the asset are capitalized.

Depreciation and amortization are provided on the straight-line method over the estimated useful lives of the related assets. The estimated useful lives are as follows:

Recognition of Benefits

Benefits are recognized when paid.

Expenses

Expenses incurred in connection with the administration of the Plan are recorded as deductions on the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation in fair value of investments. Benefits paid for legal services represent those costs directly related to legal services provided on behalf of eligible participants and beneficiaries. Administrative expenses represent costs not directly related to legal services but are associated with the general operation of the Plan.

Recently Adopted Accounting Standards

In June 2016, the Financial Accounting Standards Board (“FASB”) issued an Accounting Standards Update (“ASU”) 2016-13, Financial Instruments – Credit Losses (Topic 326), amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective July 1, 2023, using the modified retrospective approach. Upon adoption, there was no cumulative-effect adjustment to the opening balance of net assets.

Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after June 30, 2024 for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through March 5, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.

3. BENEFIT OBLIGATIONS

The legal services program payable represents amounts due for expenses incurred and reported as of June 30, 2024. Active participants’ continuing eligibility represents the Plan’s estimated liability for legal services to be provided during the thirty-day period after a participant leaves employment. The amounts reported as postretirement benefit obligations represent the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to June 30, 2024. The actuarial present value of the expected postretirement benefit obligations is determined by the Plan’s independent actuary, in accordance with accepted actuarial principles.

There is no obligation for the Trustees to provide payment over and beyond the amounts in the Plan collected and held for such purpose. The Trustees have the right to change or discontinue the types and amounts of benefits under the Plan and the eligibility rules including the rules for extended or continuing eligibility, including retiree benefits.

For measurement purposes, the legal cost trend rate used in the actuarial valuation was 3% as of June 30, 2024 and 2023. The effect of a 1% increase in the assumed legal cost trend rates would cause the postretirement benefit obligations at June 30, 2024 and 2023 to increase by \$28,530,862 and \$24,961,873 respectively.

The significant actuarial assumptions used in the valuation as of June 30, 2024 and 2023 were as follows:

- Per capita legal expenses – \$85 for 2024 and \$66 for 2023 per person (including administrative expenses) and assumed to increase 3% per year
- Discount rate – 5.35% for 2024 and 5.00% for 2023
- Postretirement mortality rates

 - Healthy – Headcount-weighted Pri-2012 Blue-Collar Employee and Annuitant Mortality Tables (sex-specific) projected forward generationally using Scale-MP 2021 from 2012 for 2024 and 2023.
 - Disabled – Headcount-weighted Pri-2012 Blue-Collar Employee and Annuitant Mortality Tables (sex-specific) projected forward generationally using Scale-MP 2021 from 2012 for 2024 and 2023.
 - 32BJ School Workers Pension Fund participants
 - Healthy – Headcount-weighted Pri-2012 Blue Collar Employee and Annuitant Amount-Weighted Mortality Tables (sex specific) with generational projection using Scale MP-2021 from 2012 for 2024 and 2023.
 - Disabled – Headcount-weighted Pri-2012 Blue-Collar Employee and Annuitant Mortality Tables (sex-specific) projected forward generationally using Scale-MP 2021 from 2012 2024 and 2023.

In developing the benefit obligation as of June 30, 2024, the following change in actuarial assumptions was made from the assumption used for the June 30, 2023 valuation:

- The discount rate was increased from 5.00% to 5.35%.
- Per capita legal cost was updated.
- The retirement rates, disability rates, and mortality rates assumptions for Building Service 32BJ Pension Fund participants were adjusted in line with the Building Service 32BJ Pension Fund's Actuarial Valuation and Review as of July 1, 2023.

These actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

4. RISKS AND UNCERTAINTIES

Due to various risks (e.g., interest rate, market, credit) associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported on the statements of net assets available for benefits.

Financial instruments that potentially subject the Plan to concentrations of credit risk include cash, accounts receivable and investments. While management of the Plan attempts to limit any financial exposure by maintaining accounts at high quality financial institutions, cash and investment balances exceed the federally insured limit of \$250,000 and \$500,000, respectively. Any loss incurred or lack of access to such funds could have a significant adverse impact on the Plan's financial condition results of operations, and cash flows. The Plan has not experienced any losses on such federally insured accounts. Credit risk associated with accounts receivable is considered limited due to the large number of employers that make up the receivable balance and the historically high collection rate of receivables.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of the relevant observable inputs and minimize the use of the unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. During the years ended June 30, 2024 and 2023, there were no transfers in or out of level 3.

The following is a description of the valuation methodology used for assets measured at fair value. The valuation methodologies were not changed during the years ended June 30, 2024 and 2023.

Mutual Funds: Shares in mutual funds are valued based on closing quoted market prices in active markets in which the securities are traded.

Depreciation and amortization expense for the years ended June 30, 2024 and 2023, amounted to \$198,986 and \$186,577, respectively, and is included in benefits paid for legal services and administrative expenses on the statements of changes in net assets available for benefits.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan shares office, payroll, certain computer equipment and software and certain administrative expenses with affiliated funds and the Union. Shared expenses are allocated in proportion to the benefit derived by each entity based on an analysis of the related expenses. The Plan's share of allocated expenses totaled \$4,375,041 and \$3,541,925 for the years ended June 30, 2024 and 2023, respectively. The Plan pays building operating expenses under a space sharing arrangement with the Building Service 32BJ Health Fund (the "Health Fund"). The Plan's share of these expenses totaled \$1,755,290 and \$1,786,866 for the years ended June 30, 2024 and 2023, respectively, and is included in benefits paid for legal services on the statements of changes in net assets available for benefits.

Amounts due to and from affiliates are noninterest bearing and due on demand.

The Plan holds certain mutual funds managed by Vanguard Fiduciary Trust Company, the Plan's custodian. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA and the Internal Revenue Code (the "IRC").

8. EMPLOYEE BENEFIT PLANS

Defined Benefit Plans

Certain employees who are represented by the Office & Professional Employees International Union, Local 153 ("Local 153") under a collective bargaining agreement are covered under the Local 153 Pension Fund upon meeting the eligibility requirements. The pension benefit is based on age and years of service. Non-represented employees are covered under the Building Service 32BJ Pension Fund upon meeting the eligibility requirements. Pension benefits are based on age and years of service.

The risks of participating in these multiemployer plans are different from single-employer plans in the following aspects:

- a. Assets contributed to a multiemployer plan by one employer may be used to provide benefits to employees of other participating employers.

- b. If a participating employer stops contributing to a multiemployer plan, the unfunded obligations of a multiemployer plan may be borne by the remaining participating employers.
- c. If the Plan chooses to stop participating in a multiemployer plan, the Plan may be required to pay the multiemployer plan an amount based on the underfunded status of the multiemployer plan, referred to as withdrawal liability.

The Plan's participation in multiemployer pension plans for the years ended June 30, 2024 and 2023 is outlined in the following table. The "EIN/Pension Plan Number" column provides the Employer Identification Number ("EIN") and the three-digit plan number. The 2023 and 2022 Pension Protection Act ("PPA") zone status, for the years beginning July 1, 2023 and 2022 for the Building Service 32BJ Pension Fund and January 1, 2023 and 2022 for the Local 153 Pension Fund, is based on information reported on the Form 5500 for that year. Among other factors, plans in the red zone are generally less than 65% funded or projected to have a deficit in their funding standard account within four years, plans in the yellow zone are less than 80% funded and plans in the green zone are at least 80% funded. The "RP Implemented" column indicates whether a rehabilitation plan ("RP") has been implemented. The last column lists the expiration date of the collective bargaining agreement to which Plan contributions are subject.

There were no changes that affect the comparability of the Plan's contributions for the years ended June 30, 2024 and 2023. The Plan contributed less than 5% of total Plan contributions to the Local 153 Pension Fund for the years ended December 31, 2023 and 2022 and the Building Service 32BJ Pension Fund for the years ended June 30, 2024 and 2023.

The Plan also contributed \$1,246,751 and \$1,323,499 in 2024 and 2023, respectively, on behalf of its employees, to the Health Fund. The Health Fund provides health benefits to its participants.

Defined Contribution Plan

Employees of the Plan who meet eligibility requirements participate in the Building Service 32BJ Supplemental Retirement Savings Plan ("SRSP"), a defined contribution plan. Under the SRSP, employees may elect to have a portion of their compensation directed into the SRSP on a pre-tax basis. The Plan contributes at a fixed rate per week or a percentage of compensation in accordance with the employees' respective collective bargaining agreement or participation agreement. Employees are immediately vested in both their voluntary and employer contributions plus actual earnings and losses thereon. The Plan contributed \$249,163 and \$223,566 for the years ended June 30, 2024 and 2023, respectively, on behalf of covered employees.

9. TAX STATUS

The Plan is a tax exempt entity under Section 501(c)(9) of the IRC. The Plan obtained a favorable determination letter dated March 13, 1997, in which the Internal Revenue Service (the "IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken and recognize an income tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has evaluated the tax positions taken by the Plan and concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. In addition, there have been no tax-related interest or penalties for the periods presented in these financial statements.

10. PLAN TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect. However, in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall continue to satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner that will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants and their beneficiaries or for the payment of administrative expenses of the Plan. The Trustees have the right to change or discontinue the types and amounts of benefits under the Plan and the eligibility rules, including the rules for extended or continuing eligibility, including retiree benefits.
