Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of June 30, 2024 and Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions for the year ended June 30, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

1. Description of Plan

General

The following description of the Custom Group Industries 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

The Plan is a contributory defined contribution plan covering all eligible employees. The Plan excludes nonresident aliens and those employees covered by a collective bargaining agreement. The Plan requires a 60 day probationary period prior to eligibility to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

Participants may contribute any amount up to the maximum percentage or dollar amount as permissible by the Internal Revenue Service (IRS). Additionally, eligible participants may rollover retirement benefits from other qualified defined benefit or contribution plans. New employees are automatically enrolled in the Plan with a deferral rate of 3% after the 60-day probationary period, unless they have elected otherwise.

The Plan allows both pre-tax and Roth contribution options.

Plan Sponsor Contributions

The Plan Sponsor has the right to make a discretionary matching contribution as well as a discretionary profit-sharing contribution to eligible participants. For the years ended June 30, 2024 and 2023, the Plan Sponsor elected to match up to 50% of the first 6% of compensation that a participant contributes to the Plan. These discretionary matching contributions totaled approximately \$146,000 and \$172,000 for the years ended June 30, 2024 and 2023, respectively. There were no discretionary profit-sharing contributions made during the Plan years ended June 30, 2024 and 2023.

Participant Accounts

Each participant's account is credited with (a) the participant's contributions, (b) the Plan Sponsor's contribution (if any) and (c) an allocation of investment income and is reduced by participant withdrawals. Allocations are based on participant earnings as a percent of total earnings. Each participant has the right to direct the investment of their elective deferrals, the discretionary matching contributions and any additional profit-sharing amounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Plan Sponsor qualified matching and discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on the following vesting schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 years or more	100%

Participants who die or become disabled while employed by the Plan Sponsor become fully vested in their account balance.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000, minus the highest outstanding loan balance in the last 12 months, or (b) one-half of the fair market value of the participant's vested account balance. Each loan is secured by the participant's account and bears interest equal to the prime rate for the second business day of the month of the inception of the loan plus 1%. Participants may have no more than two loans outstanding at any time.

Payment of Benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount, elect to rollover the balance directly into another qualified plan, or annual installments equal to the required minimum. Benefit payments to participants are recorded upon distribution.

Withdrawals

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum payment equal to the value of the participant's vested interest in his or her account. The normal retirement age for the Plan is age 59.5 and early retirement is not available. Withdrawals are recorded when paid. Hardship and in-service withdrawals are permitted by the Plan under certain circumstances. Participants who terminate employment with a vested account balance less than \$5,000 receive an involuntary cash-out distribution.

Administrative Expenses

The Plan allows the costs of administering the Plan to be shared between participants and the Plan Sponsor. Any administrative expenses paid by the Plan Sponsor are not material to these financial statements. Certain transaction fees are charged by the recordkeeper or the trustee directly to Plan participant accounts.

1. Description of Plan (continued)

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Based on the discretion of the Plan Sponsor, these forfeited amounts can be used to reduce the Plan Sponsor's contributions to the Plan. During the years ended June 30, 2024 and 2023, the Plan Sponsor used \$20,215 and \$5,558 of forfeitures to reduce Plan Sponsor matching contributions. The unallocated forfeiture balance totaled \$3,979 and \$5,245 at June 30, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounting records and financial statements of the Plan are maintained on the accrual basis of accounting, which recognizes additions to and deductions from net assets when the contributions are withheld, income is earned and liabilities are incurred.

Investment Valuation and Income Recognition

The Plan's investments are held and invested by Newport Trust Company, the trustee of the Plan. Asset values are based upon the latest quoted prices as provided by the trustee. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investments are valued daily.

Investments in registered investment companies are recorded at fair value, determined in accordance with the *Fair Value Measurements and Disclosures* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Participant loans are valued at their outstanding balance, which approximates fair value. The T. Rowe Price Stable Value Fund is a collective investment fund that is principally comprised of investments in guaranteed investment contracts and synthetic guaranteed investment contracts and is valued at the net asset value (see Note 4), which is used as a practical expedient to estimate the fair value.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and related notes. Accordingly, actual results could differ from those estimates.

Reclassifications

Certain reclassifications were made to the prior year financial statements to conform to the current year presentation.

Subsequent Events

The Plan has evaluated subsequent events through March 28, 2025, the date the financial statements were available to be issued.

3. Investments

For the years ended June 30, 2024 and 2023, the Plan Administrator elected the method of compliance permitted under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under this election, all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at June 30, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividend income, and administrative expenses for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Newport Trust Company, the trustee.

4. Fair Value Measurements

Investments are recorded at their estimated fair value, in accordance with the provisions of FASB ASC's *Fair Value Measurements and Disclosures* topic. This topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this topic are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds – registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common and collective trust fund – registered investment company: Valued at net asset value (NAV) based on the fair value of the fund's underlying investments plus the contract value of the fully benefit-responsive wrapper contracts, using information reported by the Administrator. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. As a practical expedient, the Plan measured and presented its investment in the T. Rowe Price Stable Value Fund at NAV as reported by the Administrator as of June 30, 2024 and 2023, respectively. The fund seeks to preserve principal investment while maximizing income.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan, established as a non-standardized form of a pre-approved plan, is designed to comply with the applicable requirements of the Internal Revenue Code and is, therefore, not subject to tax under present income tax law. The pre-approved plan provider, Newport Group Inc., has received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan’s qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving this letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

During the year ended June 30, 2024, the Plan Sponsor failed to remit certain participant elective deferral contributions and loan repayments totaling \$22,759 to the Plan in a timely manner. The Plan Sponsor funded these late remittances to the Plan during the year ended June 30, 2024. Subsequent to year end, lost earnings on the late remittances were calculated and totaled \$105. The corrective contribution is anticipated to be remitted into the participant accounts in April 2025. These matters were deemed to be “self-corrected” under the IRS SCP; therefore, the Plan Sponsor believes that no formal corrective notification to the IRS or the DOL was required. The Plan’s Administrator believes the necessary steps were taken to properly correct the error in order to maintain the Plan’s qualified status and operate in compliance with the IRC.

5. Tax Status (continued)

The FASB issued guidance on accounting for uncertainty in income taxes. During the years ended June 30, 2024 and 2023, management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan Administrator believes the Plan is operating in compliance with the Internal Revenue Code and has taken the necessary steps to maintain the Plan’s qualified status. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years prior to June 30, 2021.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

7. Related Party Transactions

Newport Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services, which are not material, are charged directly to participant accounts. These fees are not prohibited as they are payments for reasonable compensation for the operation of the Plan.
