### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Legal Aid Bureau, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying, financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying, financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ### 1. DESCRIPTION OF THE PLAN

The following description of the Legal Aid Bureau, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

Legal Aid Bureau, Inc. and its related entities (together, Maryland Legal Aid or Plan Sponsor) adopted the Plan to afford eligible employees an opportunity to increase their security at retirement through their own savings and through employer contributions during their periods of active employment while the Plan remains in effect. The Plan is a defined contribution plan in which substantially all employees of Maryland Legal Aid and Maryland Center for Legal Assistance may participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated effective July 1, 2016.

Eligible participants can participate in the Plan and make salary reduction contributions to the Plan as soon as administratively practicable following date of hire. Additionally, eligible participants receive the employer basic and matching contributions of the Plan on or after January 1 or July 1 after the date he or she is credited with at least one year of service, as defined by the Plan document. Effective January 1, 2023, eligible participants will receive the employer basic contribution upon hire. For the employer match contribution, it's the same as last year's report, following one year of service, eligible participants will receive the match on or after January 1 or July 1.

#### Recent Legislation

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

#### Participant Contributions

Each pay period, participants may defer up to 85% of their "compensation" (as defined by the Plan), up to the limits specified in the Internal Revenue Code. Participants may make either pre-tax or Roth elective deferrals.

### 1. DESCRIPTION OF THE PLAN (continued)

#### Participant Contributions (continued)

Participants who have attained age 50 before the end of the taxable year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan consisting of distributions from other qualified defined benefit or defined contribution plans, including direct rollovers of designated Roth contributions. Participants' elective contributions, as well as Maryland Legal Aid contributions, are invested in the Plan's investment funds as directed by the participants. If any participant fails to make an investment election, the participant's account is invested in a qualified default investment alternative selected by the Plan Administrator.

#### Basic Employer Contributions

Basic employer contributions are made at the discretion of the Board of Directors and remain at the approved level until changed by the Board of Directors. For the year ended June 30, 2024, the basic contribution was 5% of each eligible participant's compensation, which amounted to \$1,414,838.

#### Matching Employer Contributions

A matching contribution may be made by Maryland Legal Aid to an employer matching contribution account of each participant who has satisfied the requirements of initial or subsequent eligibility and makes a salary reduction contribution for the applicable pay period. The amount of any matching contribution for a plan year is determined at the discretion of the Board of Directors and may take into account years of service. For the year ended June 30, 2024, employer matching contribution was according to the schedule below:

1 - 9	50% of salary reduction contributions not to exceed 2% of compensation
10 - 19	50% of salary reduction contributions not to exceed 3% of compensation
20 - 29	50% of salary reduction contributions not to exceed 4% of compensation
30 or more	50% of salary reduction contributions not to exceed 5% of compensation

All contributions are subject to certain limitations. For the year ended June 30, 2024, matching contributions amounted to \$185,107.

### 1. DESCRIPTION OF THE PLAN (continued)

#### Qualified Non-Elective Contributions

Maryland Legal Aid did not make qualified non-elective contributions (QNECs) for the year ended June 30, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Maryland Legal Aid's contributions and (b) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant contributions, earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately 100% vested in their contributions and related earnings. Participants who were both participants and employees as of August 4, 2011 are 100% vested in Employer Matching and Employer Basic Contributions. Participants who were not both participants and employees of Maryland Legal Aid as of August 4, 2011 shall become vested in Employer Matching and Employer Basic Contributions according to the schedule below.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at reasonable rates, as determined by the Plan Administrator. Principal and interest are paid through payroll deductions.

#### Payment of Benefits

Benefits are payable upon normal retirement, disability, death or termination of employment prior to retirement. In-service distributions and hardship withdrawals are permitted, subject to Plan document provisions. Participants may receive account distributions in the form of a lump sum payment as defined in the Plan document.

#### **1. DESCRIPTION OF THE PLAN (continued)**

##### **Administrative Expenses**

All expenses of maintaining the Plan are paid directly by the Plan, unless paid by Maryland Legal Aid. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation/depreciation of the fair value of investments.

##### **Forfeited Accounts**

Forfeitures are used first to pay Plan expenses and then to reduce employer contributions. During the year ended June 30, 2024, \$39,563 was used to pay Plan expenses, while \$1,191 was used to offset employer contributions. As of June 30, 2024 and 2023, there were \$0 and \$922, respectively, in forfeited non-vested accounts.

##### **Plan Termination**

Although it has not expressed any intent to do so, Maryland Legal Aid has the right to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become 100% vested in their employer contributions.

#### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for Putnam Stable Value Fund. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in a common collective trust (CCT) that invests in guaranteed investment contracts. As required, the statement of net assets available for benefits presents the fair value of the investment in the CCT. The contract value approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

##### **Contributions**

Employee and employer contributions are recorded in the period that the Plan Sponsor makes payroll deductions from the participant's earnings. Discretionary match is made on a per pay period basis.

##### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

##### **Subsequent Events**

The Plan evaluated subsequent events and transactions through March 27, 2025, the date these financial statements were available for issue, and has determined that no material subsequent events that would affect the information presented in the accompanying financial statements or require additional disclosure.

#### 3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest on notes receivables from participants for the year ended June 30, 2024 were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Charles Schwab Bank, the custodian of the Plan.

#### 4. INVESTMENTS

##### Fair Value Measurements

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

#### Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2024 and 2023.

*Mutual funds:* Valued at the current trading value of shares held by the Plan at year end.

*Common collective trust:* Valued at the net asset value (NAV) of units of the common collective trust (CCT) held by the Plan at year end. The CCT invests in high-quality guaranteed investment contracts (“GICs”) and similar contracts issued by insurance companies, banks and other financial institutions. The CCT also invests up to 75% of its assets in security-backed investment contracts (“SBICs”), including separate account products of insurance companies.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain custodian, recordkeeping and investment advisor fees are paid from Plan assets. These transactions qualify as exempt party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Certain fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment.

#### 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, which could materially affect the amounts reported in the statements of net assets available for benefits.

#### 7. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed Maryland Legal Aid by a letter, dated February 8, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for fiscal years prior to 2021.
