Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fitzmaurice Community Services, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTES TO FINANCIAL STATEMENTS
June 30, 2024 and 2023

1. Description of Plan

The following description of the Fitzmaurice Community Services, Inc. 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a contributory defined contribution plan under Internal Revenue Code Section 403(b) of Internal Revenue Code. The Plan covers all eligible employees of Fitzmaurice Community Services, Inc. (Organization) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

All employees who normally work more than 20 hours per week are eligible to participate upon hire. If an employee does not make an affirmative or negative election to participate, they will be automatically enrolled in the Plan at an initial period elective deferral of 3% of compensation, with their contributions invested in a designated fund until changed by the participant. Participant elective deferrals automatically increase 1% annually up to a maximum of 6% of compensation. Participants must opt out of the increase yearly if they are contributing less than 6%.

Contributions

There are several types of contributions that can be added to a participant’s account: an employee salary deferral contribution, an employee Roth elective deferral, an employer QACA safe harbor matching contribution, and an employer non-elective matching contribution.

Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan up to the maximum limits of the Internal Revenue Code (“IRC”). Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions to the Plan are recorded in the period that payroll deductions are made from participants.

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. Participants may change their deferral election at times (per pay period) throughout the year as defined in the plan document.

The employer elected to make a QACA safe harbor matching contribution of 100% of employee contributions up to 6% of participants’ eligible compensation. The employer may also make, at the sole discretion of its Board of Directors, additional employer non-elective contributions. There were no employer non-elective contributions for the years ended June 30, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, any rollover contributions, and allocations of (a) the Organization's QACA safe harbor contribution (b) the Organization's non-elective contribution and (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately and fully in their salary deferral account and rollover account regardless of the number of years of service.

Employees are credited with a year of service for each plan year during which they have at least 1,000 hours of service. The vested interest in participant accounts upon termination from employment, other than by retirement, disability, or death, vest as disclosed below.

The vested interest in the QACA safe harbor matching contribution account is dependent upon the years of credited service, as follows:

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not take loans from their Roth deferrals or earnings, thereon. The loans are secured by the balance in the participant's account and bear interest at fixed rates. Principal and interest is paid ratably through payroll deductions over a period of up to five years. A participant may have a maximum of 5 loans outstanding at any time.

Forfeitures

Forfeitures of terminated participants' nonvested accounts may first be applied to pay administrative expenses under the Plan which would otherwise be paid by the Organization. Forfeitures not used to pay administrative expenses shall be applied to reduce the earliest Organization contributions made after the forfeitures are determined. Upon their application, such forfeitures shall be deemed to be Organization contributions.

Forfeited nonvested accounts at June 30, 2024 and 2023 amounted to \$47,196 and \$9,240, respectively. During the year ended June 30, 2024, \$-0- of forfeitures were utilized to offset employer contributions and \$11,140 were utilized to offset plan expenses. During the year ended June 30, 2023, \$13,678 of forfeitures were utilized to offset employer contributions and \$15,023 were utilized to offset plan expenses.

Payment of Plan Benefits

If a participant terminates employment for any reason other than death or total and permanent disability prior to normal retirement age (65) and the value of the participant's vested account balance is less than \$5,000, the vested portion is distributed automatically. The Plan allows participants to make hardship withdrawals from pre-tax and Roth deferrals.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold, as well as held during the year.

Investment Fees

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Benefit Payments

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosure*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the years ended June 30, 2024 and 2023, were obtained or derived from information supplied to the plan administrator who has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and certified as complete and accurate by Ascensus Trust Company, the custodian of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental Schedule of Assets (Held at End of Year).

5. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

6. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the plan's tax counsel believe that the terms of the Plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service (IRS) and in a letter dated January 1, 2018, the IRS noted the form of the Plan is acceptable under Section 403(b). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions with Parties in Interest

Certain routine plan administrative expenses are incurred and/or paid by the plan sponsor. Notes receivable from participants also qualify as exempt transactions with parties-in-interest. Other than the aforementioned, the Plan has no agreements or transactions with parties in interest.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

Management has evaluated subsequent events through February 28, 2025 the date the financial statements were available to be issued, and has determined that no material subsequent events exist that require recognition or disclosure
