To Whom it may concern:

Today I filed a 5500SF for 2021 for Maddox-Joiner, Inc., 401K Plan

The business was sold in November, 2020, and Paychex was our payroll processing Company. We were under the impression Paychex filed the 5500SF for the Year ending 2021.

On November 11, 2024, we received a notification that the return was not filed for The year ending 2022. We sent a reply back under section 2 stating the Company was sold in November 2020, thinking no return was due for 2022.

On January 23, 2025 we received another notice asking for information regarding The transfer of the plan to SDRG, Inc. We replied to that notice.

On February 17, 2025, we received another notice and under Section 2 reported the Plan was terminated or merged into a new plan. A letter accompanied the return Notice and a copy of the 5500SF Paychex sent me and advised me it was filed In 2021.

On April 1, 2025, we received a notice No. 1393 advising us they could not process The material we sent and we needed to do the efast filing. They returned the documents I sent in.

After speaking to Paychex several times and to the efast support people, I was advised By efast support to file a return for the period ending 2021. I have done this and hope this will solve the confusion.

I am also attaching a letter I wrote on February 24, 2025.

I am respectfully requesting a pardon of all penalties and fees due to the confusion This has caused. We were a small business and unaware that the proper paper work Did not get filed until we received the notice on November 11, 2024. We have Been trying to resolve this matter, but due to our inexperience and dependence on Paychex, we perhaps confused things. There are no monies due that were not paid, it Is just the filing of the 5500SF tax return confusion.

Thank you for your consideration in this matter.
