Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Vista Life Innovations 403(B) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Notes to Financial Statements

June 30, 2024

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Vista Life Innovations 403(b) (the “Plan”) is provided for general information purposes only and is not intended to be a complete description of the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a 403(b) defined contribution plan, which was formed effective July 1, 2000, and is sponsored by Vista Life Innovations, Inc. (the “Employer”). The Plan is a voluntary defined contribution savings plan available to employees of the Employer. Employees are eligible to participate in the Plan upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute a portion of their eligible compensation to the Plan. The Plan allows participating employees to designate all or a portion of their deferrals as Roth contributions. Participants that are age 50 or older may elect to defer additional amounts (age-50 catch-up contribution) to the Plan. A participant’s total deferral in any taxable year may not exceed a dollar limit which is set by law. Participants may also contribute amounts representing distributions from other eligible plans.

For each Plan year, the Employer shall contribute to the Plan, on behalf of each participant who is at least 18 years of age and has at least one year of service to the Employer, an Employer Nonelective Contribution equal to 1% of eligible compensation. In addition, the Employer shall make matching contributions in accordance with the schedule below, for a maximum total Employer contribution of 3% of eligible compensation inclusive of the Employer Nonelective Contribution:

0% or less than 2% of their eligible compensation	0% of eligible compensation
3% of their eligible compensation	0.5% of eligible compensation

6% or more of their eligible compensation	2.0% of eligible compensation

Participant Accounts

Each participant’s account is credited with the participant’s contributions, rollover contributions and Employer contributions, as well as allocations of Plan earnings and expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants may direct the Employer to invest their contributions in a variety of investment options allowed by the Plan. All investment are participant directed.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Withdrawals

Withdrawals prior to the age of 59 ½ are allowed only at termination of employment. In-service withdrawals are permitted upon attainment of age 59 ½ subject to limitations under the Plan document.

Vesting

Participants are fully vested in their account balances with the Plan at all times.

Notes Receivable from Participants

Participant loans from Teachers Insurance and Annuity Association of America (“TIAA”) and College Retirement Equities Fund (“CREF”) (collectively, “TIAA and CREF”) (the “Trustees”) are permitted by the Plan. Participants may borrow from TIAA and CREF \$1,000 up to a maximum of 50% of their vested account balances or \$50,000, whichever is less. Loans bear a reasonable rate of interest comparable to the interest rate charged on similar commercial loans by persons in the business of lending money. The participant must repay any loan by periodic level payments of principal and interest over a reasonable period of time not to exceed five years. Loans made for the purchase of a principal residence may be repaid over a longer term. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

On termination of employment, a participant is entitled to the full value of all the participant’s contributions to the Plan, all vested Employer contributions and all related earnings. There are various options available for distributions. For vested account balances under \$5,000, lump sum distributions or direct rollovers will be made. Distributions or direct rollovers of vested account balances of more than \$5,000 cannot be made before the participant’s normal retirement date without the participant’s written consent. In addition, during employment, a participant may withdraw all or a portion of their vested account balance, to the extent necessary, to meet a qualifying financial hardship, or for childbirth and adoption expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan Administrator determines the Plan’s valuation policies, utilizing information provided by TIAA and CREF. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Employer pays certain administrative expenses incurred in the administration of the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Certain other expenses, including loan set-up fees and other transactional costs, are charged to the participant accounts, and included in administrative expenses. Investment-related expenses are included in net appreciation/depreciation in fair value of investments.

Subsequent Events

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended June 30, 2024 through March 4, 2025, the date on which financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account: Stated at NAV as reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. The net asset value is used as a practical expedient to estimate fair value.

NOTE 4 - GUARANTEED INVESTMENT CONTRACT

The Plan has a benefit-responsive guaranteed investment contract with TIAA totaling \$1,358,616 and \$1,292,591 at June 30, 2024 and 2023, respectively. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

NOTE 4 - GUARANTEED INVESTMENT CONTRACTS (CONTINUED)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include 1) an uncured violation of the Plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, 4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 - CERTIFIED INFORMATION

Certain information related to investments, at fair value, investments, at contract value and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including total investments, at fair value, total investments, at contract value and notes receivable from participants at June 30, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained or derived from information supplied to the Employer and certified as complete and accurate by TIAA and CREF, the trustees of the Plan.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various money market funds and other investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Substantially all of the costs and expenses incurred in connection with the operations of the Plan are paid by the Employer. TIAA and CREF, the trustees, manage the Plan investments. Therefore, these transactions qualify as party in interest transactions and are denoted as such on the supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) as of June 30, 2024.

The Plan provides for participant loans. Transactions in such investments qualify as party in interest transactions as defined by ERISA.

NOTE 8 - INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with sample language provided by the Internal Revenue Service (“IRS”) in Revenue Procedures 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
