## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Oregon Health & Science University Foundation Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**Notes to Financial Statements**

---

**1. Description of Plan**

The following brief description of Oregon Health & Science University Foundation Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a noncontributory defined-contribution plan intended to comply with Section 401(a) of the Internal Revenue Code (IRC). The Plan was originally established on July 1, 1989 and was restated on July 1, 2021. The Plan sponsor and Plan Administrator is the Oregon Health & Science University Foundation (the Foundation). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

At June 30, 2024 and 2023, the custodians of the Plan were Teachers Insurance and Annuity Association of America (TIAA), College Retirement Equities Fund (CREF), and Reliance Trust Company (Reliance).

**Eligibility** - An employee must be a qualified employee and have completed 1,000 or more hours of service during the year to be eligible. Employees covered by a collective bargaining agreement that does not provide for participation in the Plan, certain nonresident aliens who have no earned income from sources within the United States, and leased or temporary employees are not qualified and therefore not eligible. Substantially all employees of the Foundation, who have satisfied the eligibility requirements, are covered by the Plan. Entry dates for the Plan occur on January 1 and July 1 of each year.

**Contributions** - Contributions to the Plan are made by the Foundation and are equal to 12 percent of an employee's eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

**Participant Accounts** - Each participant's account is credited with the Foundation contributions and actual earnings thereon. Deducted from each participant's account are any distributions made to the participant and allocation of the Plan's expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions and earnings thereon and may change their investment directive at any time.

**Vesting** - Vesting of employer contributions is based on years of service as follows:

Vesting - Continued**

A participant who, while employed by the Foundation or a participating affiliate, dies, reaches normal retirement age, or becomes disabled, becomes fully vested in their account. Participants are fully vested in rollover contributions.

**Notes Receivable from Participants** - Participants may borrow from their accounts up to 50 percent of their vested account balances, but not in excess of \$50,000, through Reliance. Loans are secured by the remaining vested balance of the participant's account and bear a fixed interest rate as determined by the Plan Administrator. The maximum loan term is five years. Principal and interest payments are due in equal payments made no less frequently than the last day of each quarter. At June 30, 2024, the interest rates on outstanding loans ranged from 3.25 to 8.5 percent and the loans mature through 2029. Principal and interest is generally paid ratably through bi-weekly payroll deductions.

**Plan Loans** - Loans were available to participants through TIAA, subject to certain limitations. Plan loans are issued directly from the funds owned by TIAA and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's TIAA Traditional Annuity account balance is reserved, or held in collateral, to cover the outstanding loan amount for the period of time the loan is outstanding (*Note 5*). At June 30, 2024 and 2023, the only outstanding plan loans are in default. Investments underlying defaulted loan balances are held in the Plan Loan Default Fund and are reflected in the statements of net assets available for benefits until a distribution event occurs.

At June 30, 2024 and 2023, participants had outstanding plan loan balances due to TIAA of \$93,487 and \$88,819, respectively.

**Forfeited Accounts** - At June 30, 2024 and 2023, there were \$134 and \$78,091, respectively, in forfeitures available to reduce future contributions. In 2024 and 2023, employer contributions were reduced by \$88,915 and \$140,484, respectively, from forfeited nonvested accounts.

**Payment of Benefits** - Benefits are payable upon retirement, disability, or death, in the form of an annuity or a lump-sum payment. Hardship withdrawals are not permitted. The Plan provides for automatic distribution of vested account balances below \$5,000 in the form of a lump-sum payment.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting** - The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** - The preparation of financial statements, in conformity with GAAP, requires Plan management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments in shares of registered investment companies, variable annuity accounts, pooled separate accounts, and non-benefit responsive fixed annuity contracts are reported at fair value (*Note 4*). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies using information provided by the custodians.

The Plan's investment in fully benefit responsive fixed annuity contracts are reported at contract value (*Note 5*).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related expenses are recorded as administrative fees and are expensed when they are incurred. No allowance for credit losses has been recorded. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant to be in default, the receivable balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** - Benefits paid to participants are recorded when paid.

**Administrative Fees** - Certain expenses incurred maintaining the Plan are paid directly by the Foundation and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Income Tax Status** - Effective July 1, 2021, the Plan adopted a pre-approved basic plan document with an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The opinion letter states the Plan is designed in accordance with the applicable requirements of the IRC and, therefore, the Plan Administrator believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Subsequent Events** - The Plan has evaluated subsequent events through March 28, 2025, the date the financial statements were available to be issued.

**3. Certified Information**

Certain information related to investments held at June 30, 2024 and 2023, disclosed in the accompanying financial statements and ERISA-required supplemental schedule, and net investment income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company and TIAA and CREF (the custodians of the Plan).

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at June 30, 2024 and 2023.

**4. Fair Value Measurements - Continued**

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

- The fair values of shares in registered investment companies are determined by obtaining quoted market prices on nationally recognized securities exchanges.
- The fair value of the Plan's interest in variable annuity accounts (CREF accounts) is determined based on each account's daily net asset value (NAV) as reported on the active market on which the accounts are traded or listed. The NAV represents the basis for current transactions and is therefore a readily determinable fair value.
- The TIAA Real Estate Account, which is a pooled separate account, is a single account that invests primarily in real estate holdings. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. Participants redeeming units from the TIAA Real Estate Account may only do so once per calendar quarter. Units of the pooled separate account are valued using the NAV of units held by the Plan and are valued at the closing price reported on the active market on which the individual securities are traded or listed.
- Investments in TIAA Traditional Annuity non-benefit responsive fixed annuity contracts are contract based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs (Level 3). The fair value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fixed Annuity Contracts (Unaudited)**

The TIAA Traditional Annuity within the Plan Loan Default Fund contains no liquidity restrictions and is considered to be fully benefit responsive. Accordingly, contract value is the relevant measurement attribute as this is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the plan by TIAA, represents contributions made under each contract, plus earnings, less participant withdrawals and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and interest at a specified rate as stated in each contract.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan document (including complete or partial Plan termination or a merger with another plan); 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; 3) bankruptcy of the Plan sponsor; 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or 5) the premature termination of the contract. The Plan Administrator does not believe any events which would limit the Plan's ability to transact at contract value with the participants are probable to occur.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may differ under each contract. Examples of such events include the following: 1) an uncured violation of the Plan's investment guidelines; 2) a breach of material obligation under the contract; 3) a material misrepresentation; 4) a material amendment to the agreements without the consent of the issuer.

The Plan's investment (at contract value) in the Plan Loan Default Fund was \$93,487 and \$88,819 at June 30, 2024 and 2023, respectively.

**6. Transactions with Parties-in-Interest**

The Plan invests in annuity contracts and custodial accounts that are sponsored or managed by the Plan's custodians. These investments and investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

The Foundation is the Plan sponsor and pays for certain administrative expenses on behalf of the Plan. These transactions qualify as party-in-interest transactions.

Participants in the Plan are permitted to borrow funds from their vested balance at Reliance as described in *Note 1*. In addition, participants in the Plan have pledged their account balance in order to secure a plan loan from TIAA as described in *Note 1*. These transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest earned are described in *Note 2*.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to ERISA provisions. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
