NOTES TO FINANCIAL STATEMENTS

NOTE A DESCRIPTION OF THE PLAN

General

The following description of the Community Resources for Independence, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Community Resources for Independence, Inc. (Company) for the benefit of its employees who have at least one year of service and are age 21 or older. Additionally, long-term, part-time employees may participate in the Plan's salary deferral feature after being credited with at least 500 hours of service in each of three consecutive 12-month periods. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Certain employees are the trustees of the Plan. Charles Schwab Trust Bank serves as Plan custodian.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100 percent of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employer matching contributions to the Plan are discretionary and are determined by the Plan Sponsor with respect to each year. For the years ended June 30, 2024 and 2023, the employer matching percentage was 100 percent of employee salary deferral amounts on the first 4 percent of eligible compensation. The Company also makes safe harbor employee contributions in the amount of 3 percent of eligible compensation for all eligible participants. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor employer contributions plus earnings thereon. Vesting in the Company's matching and profit-sharing contributions is based on years of continuous service. A participant is fully vested after three years of continuous service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the vested interest in their account.

Forfeited Accounts

At June 30, 2024 and 2023, forfeited nonvested accounts totaled \$7,684 and \$3,447, respectively. These accounts will be used to reduce future employer contributions. Also, employer contributions were reduced by \$9,176 and \$32,675 from forfeited nonvested accounts in the years ended June 30, 2024 and 2023, respectively.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of June 30, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

NOTE C CERTIFICATION OF PLAN CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the custodian of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of June 30, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended June 30, 2024 and 2023.
- Investment information (excluding notes receivable from participants) included in the accompanying schedule of assets (held at end of year) as of June 30, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

NOTE D RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments include a money market fund managed by Charles Schwab (a related entity of Charles Schwab Trust Bank). Charles Schwab Trust Bank is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Company pays directly certain other fees related to the Plan's operations.

The Plan paid \$6,899 and \$7,470 of recordkeeping fees to Conrad Siegel Actuaries during the years ended June 30, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

NOTE E PLAN AMENDMENT

During 2022, the Plan was retroactively amended to formally incorporate the various provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE) and the Coronavirus Aid, Relief, and Economic Security Act (CARES), some which had previously been operationally implemented. These retroactive amendments are generally effective as of January 1, 2020. These provisions included allowing qualified individuals to take coronavirus-related distributions up to \$100,000 from their vested account balance and allowed participants to repay this amount any time over a three-year period. It also waived any required minimum distributions due in 2020 or for the 2020 calendar year and changed the beginning date for required minimum distributions from 70½ to 72 years of age. In addition, this amendment included provisions that allow long-term, part-time (LTPT) employees who are credited with at least 500 hours of service during each of three consecutive 12-month periods to participate in the Plan for the purpose of making elective deferral contributions. This is effective for 12-month periods beginning after January 1, 2021. Years of vesting service for these LTPT employees will be credited for each computation period with at least 500 hours, including computation periods prior to January 1, 2021.

NOTE F DISCLOSURES ABOUT FAIR VALUE OF PLAN ASSETS AND LIABILITIES

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended June 30, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

NOTE G PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE H TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved plan document sponsored by Conrad M. Siegel, Inc. This pre-approved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

NOTE J NONEXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Company remitted all employee contributions and loan repayments to the Plan, contributions and loan repayments of \$14,736 were not remitted within the required time period during the year ended June 30, 2024. The Plan has corrected these late remittances by calculating lost earnings owed to the impacted participants and remitted these lost earnings to the Plan during February 2025.

NOTE K RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE L SUBSEQUENT EVENTS

Subsequent events have been evaluated through March 19, 2025, which is the date the financial statements were available to be issued.

Plan Amendments

In August 2024, Plan provisions were retroactively amended to incorporate various provisions of the SECURE Act 2.0, some of which had previously been operationally implemented. Plan provisions were amended to allow long-term, part-time employees to become eligible for the Plan once 21 years of age and two consecutive 12-month periods of at least 500 hours of service has been reached. Additionally, the Plan provisions were amended to increase the age participants are to begin receiving required minimum distributions in accordance with the regulation.

Effective July 1, 2024, the Plan was amended to modify various provisions of the Plan. The significant provisions modified with this amendment include:

- Changed eligibility for purposes of elective deferral contributions from one year to six months of service.
- Increased the maximum force out threshold for terminated employees from \$5,000 to \$7,000.
