INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators
403(b) Thrift Plan for Employees of Dakota Boys and Girls Ranch
Minot, North Dakota

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of Dakota Boys and Girls Ranch, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan for Employees of Dakota Boys and Girls Ranch's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan for Employees of Dakota Boys and Girls Ranch and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan for Employees of Dakota Boys and Girls Ranch (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering generally all employees of Dakota Boys and Girls Ranch (the Company). The Plan is a 403(b) plan and consists of salary reduction and employer match contribution features. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by individuals appointed by the Company. Third party administrators (Mutual of America Life Insurance Company and Empower Annuity Insurance Company of America) serve as the providers of the Plan, maintain the records of the participant data and either hold or appoint custodians to hold the Plan assets.

Eligibility

All employees are generally eligible to make salary reduction contributions upon hire; there is no minimum age or service requirements. Employees are eligible to receive employer matching contributions after completing at least 1,000 hours of service within a twelve-month period and attaining 18 years of age. Participants will be entitled to receive employer contributions the first day of the month coinciding with or immediately following the date eligibility requirements are met.

Contributions

Employees choosing to enroll in the Plan may select a dollar amount or percentage that is no more than 100% of their compensation for the year. These elective deferrals may not exceed IRS limits.

Employer matching contributions for employees hired after July 1, 2008, are equal to the lesser of 100% of the salary reduction amount contributed or 5% of compensation received during the plan year. For employees hired prior to July 1, 2008, employer matching contributions are equal to the lesser of 100% of the salary reduction amount contributed or 9.5% of compensation received during the plan year.

All contributions are calculated and deposited on a per payroll basis. The Plan also allows a Roth contribution feature.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

Participant accounts

Each participant's account is credited with the participant's contributions and the employer's matching contribution. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained.

Participants' investment options

Participants must direct their salary deferral contributions and Company matching contributions to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting Mutual of America.

Notes receivable from participants

The loan with Great West Life & Annuity Insurance Company is a loan in default and will remain on the statements of net assets available for benefits until the participant triggers a distributable event. No new loans are offered inside the Plan.

Plan loans

Participants may borrow amounts directly from Mutual of America Life Insurance Company. Plan loans may be requested by a participant, using their account as collateral for the Plan loan. A Plan loan is not treated as a distribution from the Plan and is not considered a Plan asset. Therefore, Plan loans are not reported on the statements of net assets available for benefits.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in their employer contributions based on years of continuous service. A participant is 100 percent vested in their employer matching contributions after five years of credited service. An hour of service in a month credits a participant with a complete month of service. Twelve months of service earns a year of vesting.

Payment of benefits

Upon termination of employment, death, disability or retirement, if the value of the participant's account is \$1,000 or more, the participant can withdraw all or part of the vested account or leave all or part of it in the Plan. If the value of the participant's account is less than \$1,000, the participant will receive a single-sum payment at termination of employment. Hardship distributions and in-service distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 ½ to qualify for in-service distributions.

Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

Forfeitures

The non-vested portion of a paid participant's balance is used to reduce the employer's matching contribution. At June 30, 2024 and 2023, there were unallocated assets which consisted of forfeited nonvested accounts of \$10,058 and \$1,623, respectively. Employer contributions were reduced by \$17,635 and \$14,768 of forfeited account assets for the years ended June 30, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared on the accrual basis of accounting.

Basis of presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Plan providers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on an accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and are reflected in the statement of changes in net assets available for plan benefits.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits

Benefits to participants are recorded when paid.

Administrative expenses

The investment funds in the Plan are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements. Other administrative expenses were paid from the Plan's assets.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Income taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

NOTE 3 FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in methodology used at June 30, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the accounts less its liabilities. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan does not have any assets to be classified within the fair value hierarchy table. See investments measured using the net asset value per share practical expedient in the following table.

Bond pooled separate accounts invest in bonds and are designed to provide regular income from interest paid by the bonds they hold.

Growth pooled separate accounts include investments in companies the account manager believes have above-average growth potential. Most underlying holdings are in common stocks. The accounts may make limited use of futures and/or options for the purpose of maintaining equity exposure. These managers are generally willing to pay higher market multiples for the superior growth rates and profitability they anticipate. As a result, stocks in growth portfolios will tend to have higher price/earnings ratios and will generally pay little or no dividends.

Value pooled separate accounts primarily hold stocks that are deemed to be undervalued in price and that are likely to pay dividends.

Blended pooled separate accounts invest primarily in a combination of stocks, bonds, and cash-equivalent investments. Over the long term, they seek growth of both capital and income.

Asset allocation pooled separate accounts provide investors with a portfolio of a mix of stocks, bonds, and cash equivalents, with a variety of objectives.

Target retirement pooled separate accounts seek a high total return with asset allocations tailored to individuals' expected retirement dates. These funds invest in a mix of fixed income, stocks, and alternative assets depending upon the expected retirement date.

Specialty pooled separate accounts consist of real estate pooled separate accounts which include investments that invest indirectly in commercial properties, and commercial real estate developments, real estate loans, and acquisitions.

Money market pooled separate accounts seek a high level of current income as is consistent with the preservation of capital and liquidity. These accounts will invest in short-term securities that are issued or guaranteed by the U.S. Government or its agencies or instrumentalities.

NOTE 5 GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANIES

The Plan has entered into group annuity contracts with Mutual of America Life Insurance Company (Mutual of America) and Empower Annuity Insurance Company of America. The contracts are fully benefit-responsive guaranteed investment contracts that are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Mutual of America Life Insurance Group Annuity Contract

The group annuity contract with Mutual of America includes a guaranteed component referred to as the Interest Accumulation Account and a variable component (separate account).

The Interest Accumulation Account is part of Mutual of America's general account and is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of Mutual of America and not the value of the securities within the issuer's general account. The long-term credit rating of the issuer at June 30, 2024, was "a" as reported by A.M. Best. Payment obligations under the Interest Accumulation Account represent an insurance claim supported by all general account assets. The interest accumulation account does not operate like a mutual fund, variable annuity product or conventional fixed rate individual annuity product. Expenses related to the interest accumulation account are calculated by Mutual of America and incorporated into the interest accumulation account credit rate. Past interest rates credited are not indicative of future interest rates.

The value of the Interest Accumulation Account is equal to the total of all amounts allocated under the contract plus all interest accrued thereon, minus the sum of any withdrawals, transfers, and participant's administrative charges.

The Interest Accumulation Account held at Mutual of America had a contract value of \$1,349,850 and \$1,479,087 at June 30, 2024 and 2023, respectively. Interest earned on the Interest Accumulation Account during the years ended June 30, 2024 and 2023 was \$30,719 and \$14,787, respectively.

Empower Annuity Insurance Company of America Annuity Contract

The group annuity contract with Empower includes a guaranteed component referred to as the fixed annuity and a variable component (separate account).

Empower owns the underlying assets of the group annuity contract in its general account. The Plan owns the group annuity contract for the benefit of its participants. The group annuity contract is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of Empower and not the value of the securities within the issuer's general account. The long-term credit rating of the issuer at June 30, 2024, was "aa" as reported by A.M. Best.

The general fixed account held at Empower had a contract value of \$5,355 and \$5,173 at June 30, 2024 and 2023, respectively. Interest earned on the general account during the years ended June 30, 2024 and 2023 was \$181 and \$175, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 TAX STATUS

The Plan sponsor is a tax-exempt organization under 501(c)(3) of the Internal Revenue Code and has adopted a 403(b) tax-sheltered annuity (TSA) plan. 403(b) plans are not required to receive a favorable determination letter from the Internal Revenue Service indicating that the Plan is qualified under Section 403(b). The Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN LOANS

The loans with Mutual of America Life Insurance Company are held outside of Plan assets and are collateralized by the participants' account balances. The total principal of these loans was \$78,485 and \$79,930 as of June 30, 2024 and 2023, respectively.

NOTE 9 PARTIES-IN-INTEREST

Mutual of America Life Insurance Company and Empower Annuity Insurance Company of America are the providers as defined by the Plan and, therefore, qualify as parties-in-interest. Certain plan investments are shares of pooled separate accounts and annuities managed by Mutual of America Life Insurance Company and Empower Annuity Insurance Company of America, as providers of the Plan, and therefore qualify as party-in-interest transactions. Fees paid by the Plan to the providers for the administrative services amounted to \$1,707 and \$749 for the years ended June 30, 2024 and 2023, respectively.

Mutual of America provides certain administrative services to the Plan pursuant to an Administrative Service Agreement between the Company and Mutual of America. Mutual of America receives reimbursements from mutual fund service providers for services Mutual of America provides to the funds. Mutual of America reverts these reimbursements back to the Plan which are then used to reduce Plan expenses. During the years ended June 30, 2024 and 2023, there were no significant amounts reimbursed from the provider to the Plan.

If the reimbursements received by Mutual of America from such mutual fund service providers exceed the amount owed under the Administrative Service Agreement, Mutual of America will retain the excess amount in the expense holding account until the following quarter when the fees are processed and reviewed once again. During the years ended June 30, 2024 and 2023, there were no excess amounts over the fees assessed by the Administrative Service agreement.

NOTE 10 PLAN TERMINATION AND AMENDMENTS

Although it has not expressed intent to do so, the Employer has the right to amend the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the rights to all participants shall remain nonforfeitable, and participants will become 100 percent vested in their accounts.

NOTE 11 RISKS AND UNCERTAINTIES

Participants have the option to direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 12 SUBSEQUENT EVENTS

Effective July 1, 2024, the Plan became a multiple employer plan (MEP) allowing the Dakota Boys and Girls Ranch Foundation employees to participate in the Dakota Boys and Girls Association Plan.

No other significant events have occurred subsequent to the Plan's year end. Subsequent events have been evaluated through March 7, 2025, which is the date these financial statements were available to be issued.
