Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements

June 11, 2024

1. Description of the Plan

The following description of the USASF, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan available to eligible employees of USASF, LLC and its affiliates (collectively, the Employer) who had one month that included 80 hours of service and had attained age 18. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Employer was responsible for the administration of the Plan and entrusted the maintenance of records and the day-to-day administration to TAG Resources (TAG), who processed transactions through Transamerica Financial Life Insurance Company (Transamerica), the custodian.

The Employer filed for bankruptcy under Chapter 7 of the United States Bankruptcy Code and elected to terminate the Plan effective June 23, 2023 (termination date). In accordance with accounting principles generally accepted in the United States of America, the Plan used the liquidation basis of accounting in presenting the 2024 and 2023 financial statements. The liquidation basis of accounting did not have a significant impact on the Plan's financial statements.

As a result of the decision to terminate the Plan, effective the termination date, no new participants were admitted to the Plan, all participant accounts became fully vested and contributions ceased. The net assets of the Plan were allocated as prescribed by ERISA and its related regulations. Upon termination, any unallocated assets of the Plan were used to pay Plan expenses. The Plan distributed all assets to participants by June 11, 2024.

Contributions

Each year, participants could contribute up to 90% of their pre-tax annual compensation, as defined in the Plan. In addition, participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change the investment options previously elected at any time. Contributions to the Plan ceased in June 2023.

1. Description of the Plan (continued)

Contributions (continued)

Prior to the termination date, the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation.

The Employer could make discretionary matching, nonelective or qualified nonelective contributions to the Plan. During 2024, the Employer did not make any contributions.

Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Employer's discretionary matching, nonelective and qualified nonelective contributions and Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their voluntary contributions and discretionary qualified nonelective contributions plus actual earnings on these contributions. Vesting in the Employer's discretionary matching contribution and discretionary nonelective contribution portion of their accounts plus related earnings thereon was based on years of vesting service in which the participants completed 1,000 hours of service, as follows:

Effective the termination date, all participants were immediately 100% vested in all accounts.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or early retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age could choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permitted in-service and hardship withdrawals under certain conditions.

Forfeitures

Forfeitures were created when participants terminated employment before becoming entitled to their full benefits under the Plan and were considered nonparticipant-directed investments. Forfeitures could be used to pay administrative expenses and to reduce future Employer contributions. During 2024, administrative expenses were reduced by \$26,321 from forfeited non-vested accounts. As of December 31, 2023, forfeited non-vested accounts held in the Transamerica Stable Value Advantage Account totaled \$26,271.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

2. Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for its benefit-responsive investment contract, which is valued at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of June 11, 2024 or December 31, 2023. If a participant ceases to make scheduled repayments and the Plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment recorded. There were no outstanding notes receivable from participants as of June 11, 2024.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through March 31, 2025, the date the financials were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of June 11, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest income from stable value advantage account and interest income on notes receivable from participants for the period ended June 11, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan can access.
- Level 2 Inputs to the methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy for assets and liabilities is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Valued at the net asset value (NAV) which equals the number of shares of the respective underlying fund, multiplied by the closing NAV per share quoted by that fund. The NAV is used as a practical expedient to estimate fair value.

5. Group Annuity Contract

The Plan invested in a fully benefit-responsive investment contract with Transamerica totaling \$126,573 as of December 31, 2023. Transamerica maintained the contributions in a general unallocated account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The effective rate of interest was established every January 1 and July 1 and was based on the daily balance, at a rate that was the daily equivalent of the effective annual rate of interest applicable for the six-month period. There was no guaranteed minimum or maximum interest rate under this contract, no unfunded commitments, and redemption frequency and notice period could occur daily.

5. Group Annuity Contract (continued)

The contract met the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts, because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

6. Related Party Transactions and Party-in-Interest Transactions

Plan investments were in accounts of Transamerica; therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants were also considered to be party-in-interest transactions.

7. Tax Status

The Plan adopted non-standardized pre-approved profit sharing plan which had received an opinion letter dated August 17, 2021, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan was designed and was being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

We are the Court Appointed Accountants for the Chapter 7 Trustee of USASF LLC (“USASF” or the “Debtor”), which filed for protection under Chapter 7 of the United States Bankruptcy Code on August 25, 2023, at which time Don A. Beskrone Esq. was appointed as the Chapter 7 Trustee. All operations and payroll ceased as of the Chapter 7 filing.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. Sect. 704(a)(11), the Trustee is responsible for the liquidation of the Plan Assets of the USASF, LLC 401(k) Plan (“the Plan”).

The 2024 annual informational return was prepared by TAG Resources (“TAG”), the Third Party Administrator (“TPA”), from the best information available; that is, data provided by the Debtor and the Plan Asset Custodian, Transamerica Retirement Solutions (“Transamerica”). Due to the cessation of business and the filing of bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable.

During 2024, as part of the termination and liquidation process, all of the Plan’s remaining funds were distributed to Participants. We are not aware of any complaints from Participants regarding the distribution or disposition of their account balances.

Neither the Trustee, nor the Trustee’s Court Appointed Accountants have any direct knowledge of the transactions recorded by the Debtor, Transamerica, or TAG as reported on this return. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Debtor, Transamerica or TAG.

The Trustee, by his signature on the face of this informational return, has relied on our expertise in preparing the return from the available records, which were limited due to the entity’s cessation of business. However, it is our qualified opinion that this is a complete return based on the financial information available.
