**NOTE 1      DESCRIPTION OF PLAN**

The following description of the Law School Admission Council Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Law School Admission Council, Inc. (LSAC). Employees are eligible to become participants and make deferral contributions to the Plan as soon as administratively possible after their hire date. Employees who are age 26 or older are eligible to receive employer contributions on the first day of the month immediately following the beginning of employment. Employees who are between the ages of 21 and 25 are eligible to receive employer contributions after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Teachers Insurance and Annuity Association - College Retirement Equities Fund (TIAA and CREF) is the custodian and recordkeeper of the Plan.

Contributions

Each year, participants may contribute a portion of their pretax annual compensation, as defined by the Plan, up to an annual limit determined by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan provides for a discretionary employer contribution to be determined by LSAC each year. For the years ended June 30, 2024 and 2023, the discretionary contribution was 6% of employee's annual salary up to the IRS limitations. Employees do not need to contribute to the Plan to receive the employer contribution. Participants also direct the investment of employer contributions. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of contributions from LSAC and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in the contributions from LSAC.

Notes Receivable from Participants

Participants may borrow from their fund accounts no more than the lesser of \$50,000, or 50%, of the present value of their vested balance. The loans are secured by the balance in the participant's account. The interest rate varies depending on investments in which the participant invests. Principal and interest are paid by the participant directly to the Plan.

Prior to July 1, 2020, participants were able to borrow from TIAA and CREF using the assets in their individual accounts as collateral. Under this arrangement, TIAA and CREF has the right to collect the collateral in the event of a default. At June 30, 2024 and 2023, participant loans totaling \$63,675 and \$151,805, respectively, were outstanding under this arrangement.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial payments, installment payments or payments in the form of an annuity contract. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. In 2024 and 2023, the Plan invested in four fixed annuity contracts, two of which are considered fully benefit-responsive. The statements of net assets available for benefits present the investment contracts at contract value, which approximates fair value. The statement of changes in net assets available for benefits is prepared on a contract value basis for fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by investment advisors, the custodian and the recordkeeper. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by LSAC. Expenses that are paid by LSAC are excluded from these financial statements. Investment-related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through March 31, 2025, the date the financial statements were available to be issued.

**NOTE 3      FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023:

*Fixed annuity contracts:* The fixed annuity contracts that are not fully benefit-responsive are valued based on the accumulated cash contributions and interest credited to the Plan's contract, less withdrawals, which approximates fair value. These annuities are not available for sale or transfer on any securities exchange. The fully benefit-responsive contracts are valued as described in Note 4.

*Pooled separate account:* Valued at the unit value reported by the account. The unit value is listed on the National Association of Securities Dealers Automated Quotations (NASDAQ) website and updated overnight for each day that NASDAQ is open. The pooled separate account held by the Plan is deemed to be actively traded.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuity contracts:* The Plan invests in variable annuity contracts with CREF. The CREF accounts are valued at the unit value as reported by the account. The unit values are listed on the NASDAQ website and updated overnight for each day that the NASDAQ is open. The CREF accounts held by the Plan are deemed to be actively traded. All other variable annuity contracts held by the Plan are valued at NAV, which is based on the fair value of the underlying assets of the account. NAV is used as the practical expedient to fair value.

**NOTE 4 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan has five fixed annuity contracts with TIAA and CREF, an insurance company, referred to as the TIAA Traditional Annuity. Participants who choose to invest in this option make contributions that purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. TIAA and CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA and CREF Board of Trustees on a year-by-year basis.

As described in Note 2, because two of the fixed annuity contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive fixed annuity contracts. The statements of net assets available for benefits present the fixed annuity contracts at contract value which approximates fair value. Contract value, as reported to the Plan by TIAA and CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. TIAA Traditional Annuity guarantees principal and credit contracts at a guaranteed minimum interest rate during the accumulation phase—generally 2%, but between 1% and 3% for some contracts. These guarantees of principal and minimum interest rates ensure that each participant's accumulation is protected from loss. In summary, principal balances are credited at a guaranteed minimum interest rate, generally 3% and has the potential for additional interest if declared by TIAA and CREF. Such interest rates are reviewed on an annual basis for resetting. TIAA reviews rates in March of each year, for the LSAC Plan. TIAA traditional average crediting rates for the calendar year 2023 were 4.85%., the crediting rate from March 2024 to February 2025 was 4.75%. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract.

Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the IRC) or the failure of the trust to be tax exempt under Section 501(a) of the IRC.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

The fixed annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds, fixed annuity contracts, variable annuity contracts and a pooled separate account managed by TIAA and CREF. TIAA and CREF are the custodian and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

TIAA and CREF provide certain administrative services to the Plan pursuant to an Adoption Agreement between LSAC and TIAA and CREF. TIAA and CREF receive revenue from mutual funds, fixed annuity contracts, variable annuity contracts and pooled separate account service providers for services TIAA and CREF provide to the funds. This revenue is used to offset certain amounts owed to TIAA and CREF for its administrative services to the Plan.

If the revenue received by TIAA and CREF from such mutual fund, fixed annuity contract, variable annuity contract and pooled separate account service providers exceeds the amount owed under the Adoption Agreement, TIAA and CREF remit the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan sponsor may make a payment to TIAA and CREF for administrative expenses not covered by revenue sharing.

Additionally, the Plan allows participants to take loans against their account balances, which also qualify as exempt party-in-interest transactions. As described in Note 2, LSAC pays substantially all expenses to maintain the Plan.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any such intent, LSAC has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA.

**NOTE 7 TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b).

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 CERTIFIED INVESTMENTS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2024 and 2023, and investment loss for the year ended June 30, 2024, which are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by TIAA and CREF, the custodian and recordkeeper of the Plan.
