## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Chromaflo Technologies Corporation 401(k) and Profit Sharing Plan and Trust, an employee benefit plan subject to the Employment Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of June 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the six month period ended June 30, 2023, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

**A. DESCRIPTION OF PLAN**

The following brief description of the Chromaflo Technologies Corporation 401(k) and Profit Sharing Plan and Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering all full-time employees of Chromaflo Technologies Corporation (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective January 1, 2013, the Plan was amended and restated to incorporate all required changes for plans that fall under Cycle B of the remedial amendment period of the Economic Growth and Tax Relief Reconciliation Act of 2001, as amended, change the service requirement for eligibility for elective deferrals and matching contributions, change the entry dates that an eligible employee becomes a participant in the plan, and provide for a plan year ending December 31.

As of August 1, 2014, the Company changed the Plan trustee from Delaware Charter Guarantee & Trust Company dba Principal Trust Company to Wells Fargo Bank, N.A. The Company also added the ability for participants to make after-tax Roth deferral contributions. The Plan's structure and format, including employer contributions, loans, and distributions remained the same under Wells Fargo Bank, N.A.

As of December 1, 2019, the Company changed the Plan trustee from Wells Fargo Bank, N.A. to Fidelity Management Trust Company. The Plan's structure and format, including employer contributions, loans, and distributions remained the same under Fidelity Management Trust Company.

Effective April 29, 2022, the Plan was amended and restated to reflect statutory changes pursuant to the Bipartisan Budget Act of 2018 (BBA), and Code Section 401(k) and (m) 2019 Final Hardship Regulations and any related guidance. The amendment also removed the Trust Agreement formerly within the Plan document and made it a separate independent Trust Agreement.

*Participation Requirements*

Upon completion of 30 days of service, as defined, all full-time employees are immediately eligible for voluntary 401(k) and employer matching provisions. For purposes of qualified non-elective contributions and profit sharing contributions, certain employees, as defined, are eligible after one year of service, and begin active participation semiannually, on either January 1 or July 1.

*Funding Policy*

The employer shall, within the time period and manner permitted by the Internal Revenue Code, remit to the trustee an amount equal to the sum of the elective deferral contributions and the employer contributions.

**A. DESCRIPTION OF PLAN (Continued)**

*Contributions*

The Plan allows participants to make voluntary contributions to the Plan, by entering into a salary reduction agreement with the Company for up to 100% of their pre-tax or after-tax annual compensation, as defined, subject to the maximum permitted by the Internal Revenue Service (IRS). The Plan also allows participants who have attained age 50 before the end of the plan year to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For 2023 and 2022, as required by the Plan, the Company matched 50% of voluntary 401(k) contributions up to 6% of participants' eligible compensation, as defined. In addition, the Company made qualified non-elective contributions of 3% of eligible gross wages to all participants and required profit sharing contributions to certain eligible groups of employees, as defined, ranging from 5% to 6% of eligible compensation, as defined. All contributions are subject to the limitations imposed under Internal Revenue Code (IRC) Section 404(a)(3)(A). Participants direct the investment of their contributions into various investment option offered by the Plan.

As of May 8, 2020, the Company amended the Plan to change employer matching contributions from non-discretionary to discretionary.

*Investment of Contributions*

Participant contributions and employer contributions are invested by the Plan's trustee as directed by each participant, in one or more of the Plan's investment options, which are stated separately in the accompanying supplemental schedule. Earnings, interest, and dividends received from investments in each fund are allocated to participants' accounts based on the participants' account balance in relation to the entire fund balance and are reinvested in the fund.

*Vesting*

Participants in the Plan are 100% vested in their contributions, all employer contributions, and any earnings thereon.

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan transactions are treated as a transfer to (from) the investment funds from (to) the participant's loan receivable. Loan terms generally range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate commensurate with local prevailing interest rates as determined by the Company. The interest rates on loans ranged from 4.25% to 7.25% at June 30, 2023. Principal and interest is paid ratably through payroll deductions.

*Payment of Benefits*

Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum distribution. If the participant's account balance is between \$1,000 and \$5,000, the plan administrator may direct the trustee to make an automatic rollover of the account balance to a qualified individual retirement account if the participant has not designated an account. If the participant's account balance is less than \$1,000, the plan administrator may direct the trustee to make a lump sum distribution. Participants terminated for reasons other than death, disability, or retirement, are entitled to receive their benefits as soon as administratively feasible. Distributions of a participant's 401(k) account balance may be authorized at any time by the plan administrator under certain hardship conditions.

*Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant would have a non-forfeitable right to his or her total account balance as of the date of termination.

*Merger*

On March 23, 2023, the Board of Directors of Vibrantz Color Solutions Inc., formerly, Chromaflo Technologies Corporation, approved the merger of this Plan into the Ferro Corporation 401(k) Plan (the "Ferro Plan"), effective July 1, 2023. As a result, all investments were transferred from the Plan into the Ferro Plan on June 30, 2023.

**B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The accompanying financial statements and supplemental schedules are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Investments*

All of the Plan's assets were held in trust by the Plan trustee, Fidelity Management Trust Company for the six month period ended June 30, 2023 and year ended December 31, 2022. Mutual funds are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year-end. The Plan's interest in the collective trust is based on the contract value of the collective trust's underlying investments as based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation or depreciation in the fair market value of its investments which consists of any realized gains or losses and any unrealized appreciation or depreciation on those investments. All Plan assets were transferred to the Ferro Plan before close of business on June 30, 2023.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based on the terms of the Plan document.

*Administrative Expenses*

Certain expenses incurred in connection with the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits.

*Risks and Uncertainties*

The Plan invests in various investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the dates of the financial statements and the reported amounts of changes in net assets available for plan benefits during the reporting periods. Accordingly, actual results may differ from those estimates.

*Benefit Distributions*

Benefit distributions are recorded when paid to participants.

**C. INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule has been certified to the Plan administrator by the Plan's trustee: statements of net assets available for benefits – investments at fair value, investment at contract value, and notes receivable from participants; statement of changes in net assets available for benefits – net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants; and Schedule H, Line 4i - Schedule of Assets Held at June 30, 2023 – all information. As directed by the Plan administrator, no auditing procedures have been performed on this information except to compare such information to the information included in the accompanying financial statements and the supplemental schedule.

**D. INVESTMENT CONTRACT**

As of December 1, 2019, the Plan has entered into a benefit-responsive investment contract with Fidelity Management Trust Company (Fidelity). Fidelity maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value.

Contract value as reported to the Plan by Fidelity represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the trustee. Such events include the following: amendments to the plan documents (including complete or partial plan termination or merger with another plan), changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, participant communication that is designed to influence participants not to invest in the Fund, plan sponsor withdrawals without the appropriate notice to the Fund and/or issuer, and failure to meet certain tax qualifications. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include; an uncured breach of the Plan's investment guidelines, a material amendment to the contract without the issuer's consent, a violation of a material obligation under the contract, or a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit Fidelity to terminate the agreement prior to the scheduled maturity date.

**E. FAIR VALUE MEASUREMENTS**

ASC Topic 820 provides a definition of fair value which focuses on an exit price rather than an entry price, establishes a framework for measuring fair value which emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and requires expanded disclosures about fair value measurements. In accordance with FASB ASC 820-10, the Plan may use valuation techniques consistent with the market, income, and cost approaches to measure fair value. As a basis for considering market participant assumptions in fair value measurements, ASC Topic 820 establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair values. The hierarchy gives the highest priority to Level I measurements and the lowest priority to Level III measurements. The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level I: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 and December 31, 2022.

*Collective trust fund:* Valued at the net asset value (NAV) of shares held in the collective trust divided by the number of trust units outstanding, or net asset value per share.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Financial instruments are defined as cash, evidence of ownership interest in an entity, or a contract that creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the estimated fair value would be calculated based upon the market price per trading unit of the instrument.

Investments in mutual funds, common/collective trusts, notes receivable from participants, and contributions receivable would be considered financial instruments. At June 30, 2023 and December 31, 2022, the carrying amounts of these financial instruments approximate fair value.

**F. TAX STATUS**

Effective December 1, 2019, the Plan is based on a volume submitter document provided by Fidelity Management Trust Company. The IRS has ruled on March 31, 2014, that the volume submitter document is in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**G. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts in the statements of net assets available for benefits.

**H. PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are mutual funds in which Fidelity Management Trust Company is the advisor of the funds and trustee to the Plan. Transactions in these investments are allowable party-in-interest transactions under Section 408 of ERISA.
