Report on the Audit of the Financial Statements

Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of the CCMSI Holdings, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

CCMSI Holdings, Inc. (the Company) established the Plan effective January 1, 1990. The Plan was restated effective July 1, 2014 to adopt provisions of EGTRRA and to conform to tax legislation and was most recently amended effective December 11, 2023. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC).

The Plan covers all employees of the Company who have completed the eligibility requirements including the completion of one year of service (1,000 hours of credited service), and attainment of age 21. An eligible employee will begin participation on the December 31st or the June 30th following the completion of the eligibility requirements.

The Plan is designed to invest primarily in securities issued by the Company and is authorized to borrow money for such investments. It is subject to the provisions of ERISA, as amended. The Plan is administered by a Board of Trustees comprised of persons appointed by the Company's Board of Directors. The Board of Trustees also acts as the Plan's Trustee.

As of June 30, 2024 and 2023, the Plan had no outstanding loans used to acquire Company stock. As a result, all stock held by the Plan is allocated to Plan participants.

Contributions

Each year, the Company may contribute to the Plan in such amounts (or under such formula) as may be determined by the Company's Board of Directors. Contributions may be in the form of shares of common stock or cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations, without regard to whether some or all of such contribution may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of Company contributions, a participant must complete 1,000 hours of service and be employed on the last day of the Plan year unless termination is due to death, disability, or retirement (age 62). Contributions by Plan participants are not permitted by the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account, repurchases from terminated participants, repurchases from participant diversifications, and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on the source of funds (Company contributions, earnings attributable to Company contributions and cash dividends) from each participant's account used to make payments on the acquisition loan or repurchased shares. Plan earnings and administrative expenses are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Vesting

Vesting of participant's accounts is based on years of credited service with the Company. A participant's account becomes fully vested after six years of credited service with the Company, under a graded vesting schedule. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Payment of Benefits

Upon termination of service, a participant will receive a lump-sum distribution of their account balance if their balance is less than \$25,000. The distribution will be paid in the Plan year after the close of the Plan year in which the participant terminates employment.

A participant will receive a lump-sum distribution of their account balance without the participants consent if their balance does not exceed \$1,000. If the balance of the terminated participant's account is between \$1,000 and \$7,000, the Trustee may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

For accounts of more than \$25,000 but not more than \$50,000, the distribution will be made in substantially equal annual installments over a period of five years with the first installment being paid in the Plan year after the close of the Plan year in which the participant terminates employment.

For accounts of more than \$50,000, the distribution will be made in substantially equal annual installments over a period of five years with the first installment being paid five years after the close of the Plan year which is the sixth Plan year following the Plan year in which the participant terminates employment.

The amount to be distributed is based upon the account valuation date immediately preceding the distribution. Distributions are to be made in cash.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares. During 2024 and 2023, the Company repurchased 17,006 and 16,705 shares, respectively, at prices determined from an independent appraisal.

Forfeited Accounts

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants at June 30, 2024 and 2023 were \$445,845 and \$283,863, respectively. There were no balances in forfeited nonvested accounts at June 30, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds and interest-bearing cash are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and the trustees. The shares of Company common stock are valued at estimated fair value based on an independent third-party appraiser. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividend income is accrued on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through April 1, 2025, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS

The Plan's investment in Company securities consists of 282,853 shares of the outstanding common stock of CCMSI Holdings, Inc. The shares were acquired on various dates for an average of \$47.16 per share, which was the estimated fair market value, as determined by independent appraisals, as of the period purchased. The estimated fair market value, as determined by independent appraisal as of June 30, 2024 and 2023 was \$358.46 and \$321.64 per share, respectively.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at June 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-Bearing Cash: Valued based on fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

Company Common Stock: Valued at fair value based on an independent third-party appraisal. This appraisal is based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The Board of Trustees determines the fair value measurement policies and procedures. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Trustee shall pay all liabilities and expenses of the trust fund and, if applicable, sell shares of financed stock held in the loan suspense account to the extent it determines such a sale to be necessary in order to repay the loan were such a loan be outstanding. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 PLAN TAX STATUS

The IRS has determined and informed the Company by a letter dated March 26, 2015, that the Plan and related trust are designed in accordance with the applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Trustee believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities including the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with certain investment securities and uncertainties inherent in the estimations and assumption process of the Company's common stock, it is at least reasonably possible that changes in the value of the investment securities and Company's common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets, which consist primarily of Company common shares, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, who invests cash received, interest and dividends income, and makes distributions to participants.

The Plan invests in Company common stock, which is considered a party-in-interest transaction. As the Company is the Plan Sponsor, transactions involving Company common stock qualify as party-in-interest transactions. As of June 30, 2024 and 2023, the Plan held 282,853 shares of Company common stock. In addition, the Company Board of Directors authorized discretionary Company contributions amounting to \$5,900,000 and \$5,000,000 for the years ended June 30, 2024 and 2023, respectively. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain Plan investments are managed by Merrill Lynch and its affiliates. Merrill Lynch acts as an investment advisor to the Plan. Therefore, the investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to Merrill amounted to \$10,706 and \$6,912 for the years ended June 30, 2024 and 2023, respectively.
