- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about KIPP TEAM and Family Schools, Inc. 403(b) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF PLAN

The following description of KIPP TEAM and Family Schools, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a 403(b) defined contribution plan covering all eligible employees of KIPP TEAM and Family Schools, Inc. (the School) (the Plan Sponsor). The Board of Directors is responsible for the oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Beginning July 1, 2014, certain employees from three related organizations, TEAM Academy Charter School, Inc., KIPP: Cooper Norcross Academy, Inc., and KIPP Miami, Inc., who applied for and were subsequently hired by the School, became eligible to participate in the Plan. Periodically, there are participants that will change employment to or from a related organization. Accordingly, eligible participant balances are transferred to (from) the Plan concurrent with the participants' employment with the School or the related organizations and are reflected as plan transfers in the accompanying statement of changes in net assets available for benefits.

#### b. Eligibility

Participants are eligible to start contributing to the Plan upon being hired. Employees who are scheduled to work less than 20 hours per week are excluded from the Plan. Other than the exclusion noted, all employees are eligible on the first day of employment with the Plan Sponsor. Effective January 1, 2025, long-term part-time employees who worked 500 hours of service in the previous two consecutive years are eligible to participate in the Plan.

Participating employees are also immediately eligible for any Plan Sponsor discretionary matching and discretionary non-elective contributions. Hourly employees, interns, and temporary employees expected to work less than 1,000 hours during the eligibility computation period are excluded from discretionary matching and non-elective contributions.

#### c. Contributions

Each year, participants may contribute a percentage up to 100% of pre-tax annual compensation, subject to annual Internal Revenue Service (IRS) limitations as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective July 1, 2023, the Plan allows for participants to make post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor may also make discretionary non-elective and discretionary matching contributions as determined by the Plan Sponsor's Board of Directors. For the year ended June 30, 2024, the discretionary matching contributions were up to 3% of gross compensation not to exceed employee deferrals, and the discretionary non-elective contributions were 3% of gross compensation. The Plan Sponsor made discretionary matching contributions of \$417,093 and discretionary non-elective contributions of \$496,999 for the plan year ended June 30, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions and the Plan Sponsor's discretionary matching and non-elective contributions, plus an allocation of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or losses or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions and actual earnings or losses thereon. Participants become vested in the Plan Sponsor's discretionary matching and non-elective contributions following a three-year cliff vesting schedule. A participant's vesting percentage increases to 100% while still employed upon reaching normal retirement age or upon death or disability.

#### f. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. Upon termination of service, a participant receives a lump-sum amount equal to the value of their account, or as annual or more frequent installments over a period that does not extend beyond the life expectancy of the participant. There are also retirement benefits available upon disability and death. Beneficiaries are entitled to receive benefit payments on behalf of the participant upon the death of the participant. In addition, the Plan allows the Plan Administrator to automatically distribute to terminated participants their entire vest balance which does not exceed \$5,000. Effective January 1, 2024, the Plan Administrator adopted the optional SECURE Act 2.0 provision to increase the limit of involuntary force-out distributions from \$5,000 to \$7,000.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to Section 403(b) of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### g. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have up to two loans outstanding at a time. The maturities of these loans may not exceed five years, unless the loan is used to acquire a principal residence, in which case the maturity of the loan may be up to fifteen years. The loans are secured by the balance in the participant's account. Interest is due on the outstanding principal balance at a fixed interest rate of 1% above the prime interest rate. Principal and interest are paid ratably through payroll deductions.

#### h. Forfeitures

Forfeitures represent non-vested Plan Sponsor contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeited non-vested accounts may be used to reduce future Plan Sponsor discretionary matching contributions. The Plan had \$59,840 and \$6,844 of unallocated forfeitures as of June 30, 2024 and 2023, respectively.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Presentation**

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institution. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of mutual funds includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of June 30, 2024, there were no defaulted loans.

#### **Due to Broker for Investments Purchased**

Amounts related to investments purchased by the qualified institution prior to the plan year-end in advance of receiving the last contribution of the plan year-end, which is recorded as a liability in the accompanying financial statements as these were funded into the Plan after year-end. The Plan had investments that were purchased in advance of \$185,943 and \$86,429 as of June 30, 2024 and 2023, respectively, presented in the accompanying statements of net assets available for benefits.

#### **Contributions**

Contributions from plan participants and the discretionary matching and non-elective contributions from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from compensation.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to recordkeeping, the administration of notes receivable from participants and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of mutual funds.

#### Subsequent Events

Subsequent events have been evaluated through March 27, 2025, which is the date the financial statements were available to be issued. Except as disclosed in Note 1b, there were no other events that met the criteria for recognition for disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A., a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of June 30, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### 4. FAIR VALUE MEASUREMENT (Continued)

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investments measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at June 30, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated March 31, 2017, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

### **6. TAX STATUS (Continued)**

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### **7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions. During fiscal year 2024, the Plan paid the qualified institution administrative expenses totaling \$37,073.

### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect the amounts reported in the statements of net assets available for benefits.
