Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Out-of-Door Academy Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Out-of-Door Academy Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Out-of-Door Academy Tax Deferred Annuity Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Out-of-Door Academy Tax Deferred Annuity Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE A – DESCRIPTION OF PLAN

The following description of The Out-of-Door Academy Tax Deferred Annuity Plan (the Plan) provides only general information. Participants and readers of these financial statements should refer to the Plan agreement for a more complete description of the Plan's provisions. The Out-of-Door-Academy of Sarasota, Inc. (the School) is the Plan sponsor.

General

The Plan is a defined contribution plan covering all regular employees of the School. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may enter into salary reduction agreements to defer a portion of their compensation to the Plan. Participants may defer into the Plan up to the maximum amount allowed by the Internal Revenue Service.

The School may elect to make a matching contribution based on a formula as determined by the School. For the year ended June 30, 2024, the matching contribution was based on the number of years of service completed, up to a maximum of 10%. In order to be eligible for the matching contribution, participants must defer at least 1% into the Plan.

Participants above the age of 50 are eligible to make additional catch-up contributions.

Participant Accounts

Each participant's account is credited with the participant's share of discretionary contributions from the School and an allocation of Plan earnings on a yearly basis.

Allocation of Investment Income

The allocation of gains and losses of each investment fund is based on the average balance of each participant in each fund.

Vesting

Participants are always 100% vested in salary deferrals. Participants vest in matching contributions upon reaching normal or early retirement age, death or becoming disabled or in accordance with the following vesting schedule:

NOTE A – DESCRIPTION OF PLAN – CONTINUED

Administrative Expenses

The Plan or employer pays for significant administrative expenses. Each fund incurs the investment management expenses (if any) associated with that particular fund.

Notes Receivable from Participants

Participants may borrow from their vested accounts pursuant to the Plan's loan provisions, and subject to the final approval of the Plan Administrator. Participants may borrow up to one half of the vested account balance up to \$50,000. Interest is charged on participant loans at a reasonable rate, and repayment of principal may not extend beyond five years for a general purpose loan and fifteen years for a principal residence loan. Interest rates ranged from 2.35% – 9.50% in 2024 and 3.00% – 7.25% for 2023.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan documents. A loan is considered in default after no payments have been made between the due date and grace period as defined by the Plan documents.

Loans issued through TIAA prior to September 1, 2020 were issued as separate contracts by TIAA as contemplated under IRC Section 72(p)(5) and do not represent plan assets. They are considered Plan loans and not participant loans. These loans are collateralized using the participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. The loan is between the participant and TIAA, not the Plan. Repayments made on the loan are made by the participant directly to TIAA.

Beginning September 1, 2020, loans issued through TIAA are considered participant loans. Participant loans are issued directly from the participant's account and as such are considered plan assets. Repayments made on the loan are made by the participant directly to TIAA. For purposes of Schedule H of Form 5500 and these financial statements, the total TIAA participant loan balance is reflected as notes receivable from participants.

Loans issued through Corebridge Retirement Services (Corebridge), formerly VALIC, are between the participant and Corebridge. The participant account is not reduced, however a portion of the participant account serves as collateral for the loan. As payments are made, collateral is released in conjunction with the pay down of the loan. Repayments made on the loans are made by the participant directly to Corebridge. For purposes of Schedule H of Form 5500 and these financial statements, the amount of the loan escrow and active loan balance are reflected as loans or notes receivable from participants.

Payment of Benefits

Upon termination of service, a participant will receive an amount equal to the vested interest value of his or her account. Terminated participants may elect to receive a lump sum distribution, an annuity payment, remain invested with the Plan or a combination of both.

NOTE A – DESCRIPTION OF PLAN – CONTINUED

Payment of Benefits – Continued

Participants are eligible to take in-service distributions after reaching age 59-1/2. Participants are also eligible to take a hardship distribution pursuant to the Plan document and IRS regulation. Generally, the Plan is compelled to begin minimum distributions of vested balances for participants reaching age 70-1/2.

Forfeitures

Forfeitures of non-vested benefits may be used to reduce School matching contributions in the year the forfeiture applies. At June 30, 2024 and 2023, there were \$-0- of forfeitures available. During 2024 and 2023, forfeitures in the amount of \$9,931 and \$9,503 were used to reduce School matching contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management’s Review

Plan management has evaluated subsequent events through March 19, 2025 which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, and follow the Financial Accounting Standards Board (FASB), Accounting Standards Codification, (ASC).

Investments are stated at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the period the School makes the payroll deductions from participants. Any discretionary matching contributions made by the School are recorded in the same period.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, which is valued at the last reported sales price on the last business day of the Plan year. The Plan's investment in insurance contracts is valued at contract value. See Note C and Note E.

Realized gains and losses on investments sold during the year have been included with unrealized gains and losses for the year in the Net Appreciation (Depreciation) in Fair Value of Investments in the Statement of Changes in Net Assets Available for Benefits.

Fair Value Measurements

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* provides the framework for measuring fair value.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Change in Legislation

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in 2024 and forward, therefore there is no current impact to the Plan. The provisions include both required and optional elements. In December 2024, the Plan was amended to comply with SECURE 2.0.

NOTE C – INVESTMENTS

TIAA and Corebridge were the custodians of the Plan assets at June 30, 2024 and 2023.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividend income on investments, for the year ended June 30, 2024, was obtained by Plan management and agreed to or derived from information certified as complete and accurate by TIAA and Corebridge. The information certified includes total investments of \$19,408,031 and \$16,445,323 at June 30, 2024 and 2023, respectively, and related investment gains of \$2,260,239, and interest and dividend income of \$107,631 for the year ended June 30, 2024.

All investment gains/(losses) are included in the net appreciation/(depreciation) in fair value of investments in the Statement of Changes in Net Assets Available for Benefits. This classification is consistent with the presentation in Form 5500.

During 2024, investments in the Plan, appreciated in value by \$2,260,239, which is included in the Statement of Changes in Net Assets Available for Benefits in the line net appreciation (depreciation) in fair value of investments.

NOTE D – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value and/or contract value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth the level, within the fair value hierarchy, of the Plan's assets at fair value at June 30, 2024 and 2023, respectively. The Plan measured the fair value of the following assets using the following inputs (see Note B for definitions).

The pooled separate accounts, which include the TIAA Real Estate Fund, invests in real estate properties and related investments, and is valued based on the market value of the underlying holdings and real estate investments. Real estate holdings are valued principally using external appraisals. Securities held in the real estate fund are valued using independent pricing sources. Unit values are calculated daily. Registered investment companies include TIAA accounts and CREF accounts, as well as other mutual funds and money markets with Corebridge. These accounts invest principally in equity securities, fixed income instruments and short term instruments, all of which are generally evaluated using market quotations or prices obtained from independent pricing services.

The non-benefit responsive investment contract is not actively traded and significant other observable inputs are not available. The contract value, which approximates fair value, equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Changes in the non-benefit responsive investment contract included gains of \$56,418, purchases of \$41,151 and sales of \$17,596 during the fiscal year. No funds were transferred into or out of the plan.

NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional investment contract with TIAA and Corebridge. TIAA and Corebridge maintain the contributions in a general account. The contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. The fixed guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the fixed guaranteed annuity is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract, and as a result, the investment contract is presented at contract value on the face of the statement of net assets available for benefits. Contract value, as reported to the Plan by TIAA and Corebridge, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. As reported to the Plan, contract value approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all of a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%–3%. Such interest rates are reviewed annually for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the Issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the School has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of termination, all amounts credited to participants' accounts become 100% vested.

NOTE G – TAX STATUS

The Plan has adopted the ADMIN Partners, LLC Volume Submitter 403(b) Plan (Volume Submitter Plan) as of September 1, 2020. The Volume Submitter Plan received a determination letter from the Internal Revenue Service, dated March 31, 2017, which stated that the Volume Submitter Plan is acceptable under section 403(b) of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under 403(b). The School and the Plan's ERISA counsel believe that the Plan is being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination. The Plan administrator has analyzed the positions taken by the Plan, and has concluded that as of June 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's previous three years remain open to inspection by the Internal Revenue Service.

NOTE H – RELATED PARTY TRANSACTIONS

Certain Plan investments were shares of mutual funds managed by TIAA and Corebridge. TIAA and Corebridge qualify as a party-in-interest. The School provides accounting and administrative services to the Plan at no charge. The Plan or the School pays for significant administrative expenses.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
