INDEPENDENT AUDITORS' REPORT

To the Pension Committee of
Kern Regional Center Defined Contribution Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kern Regional Center Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kern Regional Center Defined Contribution Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Kern Regional Center Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all employees of Kern Regional Center (the "Organization"). The Plan was established on July 1, 2018 under section 401 of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is intended to qualify as a Social Security Replacement Plan.

2. Eligibility

All employees of the Organization are eligible to participate in the Plan immediately upon employment. Leased employees, residents of Puerto Rico, and employees who are non-resident aliens and who receive no earned income from the Organization, as defined, are not eligible to participate in the Plan.

3. Contributions

All employees are required to make after-tax employee contributions equal to 6.2% of their eligible compensation, as defined by the Plan, subject to limitations under the IRC. In addition, the Organization makes a nonelective contribution amount equal to 6.2% of eligible compensation.

4. Participant Accounts

Each participant's account is credited with the participant's and Organization's contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

5. Investment Options

Participants may direct employee and Organization contributions, as desired, in any of a variety of investment options offered by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively "Empower"). Participants may change their investment options daily.

6. Notes Receivable from Participants

The Plan does not allow participant loans.

NOTE A - DESCRIPTION OF THE PLAN (Continued)

7. Vesting

Participant contributions and Organization contributions and actual earnings on all such contributions are fully vested at all times.

8. Benefit Payments

Upon termination of service, death, disability, or attainment of normal retirement age of 60, a participant or the participant's beneficiary may elect to receive the total value of the participant's account in the form of a lump-sum payment, or in the form of an annuity contract, in accordance with the terms of the Plan, if the participant's account balance exceeds \$5,000. If the value of the participant's account does not exceed \$5,000, then the distribution may only be made in the form of a lump sum and does not require the participant's or the beneficiary's consent.

9. Plan Termination

Although it has not expressed such intent, the Organization has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, the net assets available for plan benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The financial statements of the Plan are prepared using the accrual basis of accounting.

2. Administration Plan

The Organization is the plan sponsor and the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and disclosures. Actual results could differ from those estimates.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

4. Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers, custodian, and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Payment of Benefits

Benefit payments are recorded when paid.

6. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

7. Recent Accounting Pronouncement

As of January 1, 2023, the Plan adopted Accounting Standards Codification Topic 326, *Financial Instruments – Credit Losses*, using a modified-retrospective approach. The standard replaces the previous incurred loss model and requires entities to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. This estimate must include consideration of historical experience, current conditions, and reasonable and supportable forecasts. The standard applies to the Plan's Employer contribution receivables. The adoption of this standard did not impact these financial statements.

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower, trustee and custodian, as complete and accurate, except for comparing such information certified by the trustee and custodian to information included in the Plan's financial statements and supplemental schedules:

- Investments reflected in the accompanying Statements of Net Assets Available for Benefits as of June 30, 2024 and 2023
- Net investment income reflected in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended June 30, 2024
- Investments reflected in the Schedule of Assets (Held at End of Year)

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

The preceding method described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan holds an investment that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals, and administrative expenses. NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

The Empower Investments Fixed Account – Series Class II (EIFA Account) is backed by Empower Annuity Insurance Company of America’s general account. Interest earned on the amounts invested in the EIFA Account is compounded daily at the declared credited interest rate, which is established by Empower at the end of each quarter and credited during the next calendar quarter. The crediting interest rate may not be less than 0% and is reset quarterly. Although plan participants generally may withdraw assets from the EIFA Account without restrictions, the custodian may impose a hold period up to 36 months or a market value adjustment on payments due to certain plan-level events. As of June 30, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the custodian and that also would limit the ability of the Plan to transact at contract value with the participants

The Organization is not allowed to offer competing funds unless mutually agreed upon by Empower and the Organization, in which case amounts withdrawn from the EIFA Account must be transferred to a noncompeting fund and remain there for at least 90 days before transferring to a competing fund.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Investments are held with Empower, the trustee and custodian of the Plan. Empower Retirement is the recordkeeper. Therefore, transactions with these entities qualify as party-in-interest transactions.

The Organization failed to remit employee contributions to the Plan on a timely basis in accordance with Department of Labor Regulations for the years ended June 30, 2022 and 2021 totaling \$30,911 and \$144,191, respectively. As a result, lost earnings totaling \$1,716 were remitted to the Plan and allocated to affected participants during 2024.

NOTE G - TAX STATUS

The Organization adopted a pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved plan is in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and operated in compliance with applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Asset Available for Benefits.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through March 27, 2025, the date the financial statements were available to be issued.
