Opinion

JUNE 30, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the U.A. Local No. 447 Pipe Trades Health and Welfare Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document and amendments for a complete description of the Plan.

A. General

The Plan provides health and welfare benefits to eligible members of U.A. Local Union No. 447 of the United Association of Journeymen and Apprentices of the Plumbing and Pipefitting Industry of the United States and Canada (the "Union") and their covered dependents pursuant to collective bargaining agreements between the Union and certain employers represented by the Associated Plumbing and Mechanical Contractors of Sacramento, Inc. (the "Employer Organization"). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA) and the Internal Revenue Code (the "Code").

B. Administration

The Board of Trustees (the "Board") is the Plan sponsor and plan administrator. The Board established a trust (the "Trust") to receive employer and participant contributions and maintain assets of the Plan for provision of benefits, and established an administrative office ("Administrative Office") to maintain participant records and carry out a majority of tasks associated with day-to-day Plan administration. The Board appointed investment managers to provide professional investment management services and delegated to the investment managers responsibility for managing Plan investments subject to the Plan's investment policy and Board approval. Costs of Plan administration are paid by the Plan.

C. Eligibility

Coverage for continuous benefits within any six-month period commences the second calendar month following completion of 375 hours of employment. Eligibility continues for each month a participant is credited with a minimum of 135 hours of service. Hours in excess of the minimum monthly service requirement are credited to a participant's reserve hour bank, upon which a participant may draw during months when the minimum hours requirement is not met. Participating employers may sign participation agreements providing coverage for non-bargaining unit employees and retirees.

Eligibility terminates at the end of a month where actual hours worked after consideration of the participant's reserve hour bank is less than 135 hours. Participants whose benefits would otherwise be terminated due to a lack of reserve hours may continue benefits by paying the required premiums on a self-pay basis.

Participants who are covered under the Plan immediately preceding retirement and who are eligible for benefits under the U.A. Local No. 447 Pension Fund may qualify for retiree benefits on meeting age and service requirements, as defined in the Plan. Eligibility for retiree benefits for non-collectively bargained participants is based on age and service. The eligible spouse and dependents of retirees participating in the Plan qualify for coverage. Retirees share in the cost of coverage.

D. Funding Policy

During 2024 and 2023 employers made monthly contributions of \$12.40 and \$12.15, respectively, per hour for each hour of service in covered employment worked by Union members as determined under collective bargaining.

E. Benefits

The Plan provides health and welfare benefits including medical, dental, vision, prescription drug, life and accidental death and dismemberment insurance benefits for eligible participants and their covered dependents. Benefits include of the following for the years ended June 30:

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - INCOME TAX STATUS

The Trust established under the Plan is intended to qualify for tax exempt status pursuant to Section 501(c)9 of the Code. The plan administrator and Plan legal counsel believe the Plan is designed and operated in compliance with Code requirements, and the Trust qualifies for exemption from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - EXPENSES

A. Administrative Expenses, Net

The Plan pays direct administrative costs. Certain other costs of operating the Plan and related pension plans maintained for Union members are apportioned to the Plan. Net administrative expenses paid by the Plan were as follows for the years ended June 30:

NOTE 5 - BENEFIT OBLIGATIONS

A. Premiums and Claims Payable and Claims Incurred but Not Paid

Plan obligations at June 30 include premiums payable, claims payable and claims incurred but not paid. Premiums payable, if any, are amounts due to insurance carriers for coverage prior to June 30 but paid after that date. Claims payable represent claims incurred and approved for payment before June 30 but paid after that date. Claims incurred but not paid represents an estimate at June 30 of claims incurred prior to June 30 to be submitted to the Plan for payment and paid after June 30. Premiums and claims payable are based on actual amounts paid subsequent to year end. Claims incurred but not paid is estimated by the Plan's actuary based on data submitted by the administrative office.

B. Hour Bank

Hours worked in excess of the 135 hour per month minimum required for continuing eligibility are accumulated in an hour bank. A member may bank a maximum of 810 hours. Based upon a 135 hour per month eligibility requirement, a maximum accumulation of 810 bank hours provides six months of continuous eligibility for benefits under the Plan.

Continuation of benefits under the hour bank provision is available to members during months they do not meet the minimum 135 hour service requirement. The estimated liability for benefit continuation is based on participants' bank hours accumulated at year end and the monthly cost of coverage.

C. Lag Month Liability

In order to properly match the eligibility earned for hours worked in the last two months of the fiscal year to the estimated benefit costs of eligibility to be incurred by the Plan in the subsequent two-month period, a liability is estimated based on the monthly cost of coverage for active members of \$1,983 and \$2,032 at June 30, 2024 and 2023, respectively.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

A. Record keeping and Administrative Services

The Administrative Office provides recordkeeping and administrative services to the Plan and other related pension plans maintained for Union members. Administrative Office expenses were as follows for the Plan years ended June 30:

The Administrative Office maintains a bank checking account in the name of U.A. Local No. 447 Trust Funds where all employer contributions are deposited. The Administrative Office transfers receipts from employers to the plans in accordance with terms of the collective bargaining agreements between the Union and the Employer Organization. The Plan recorded receivables of approximately \$46,000 and \$47,000 from the Administrative Office at June 30, 2024 and 2023, respectively.

The Administrative Office leases facilities in a building owned by the Union and pays rent to the Union. The Administrative Office receives fees for certain administrative services it provides to the Union. Fee revenue is offset against administrative service costs allocated to the plans.

B. Administrative Office Employee Benefits

Administrative Office employees participate in this Plan, the U.A. Local No. 447 Defined Contribution Plan and Trust and the U.A. Local No. 447 Pension Fund, related pension plans. The total cost of providing health and welfare and retirement benefits to Administrative Office employees for the years ended June 30 was as follows:

C. Multiemployer Pension Plans

The Plan’s Administrative Office contributes to the U.A. Local No. 447 Pension Fund. The U.A. Local No. 447 Pension Fund is a multiemployer defined benefit pension plan provided under terms of collective bargaining agreement. Contributions to the U.A. Local No. 447 Pension Fund are based on represented employee hours worked and rates from contractual arrangements. The risks of participating in the multiemployer defined benefit plans is different from single employer plans in the following respects:

- Assets contributed to the plan by one employer may be used to provide benefits to employees of other participating employers.
- If a participating employer stops contributing to the plan, unfunded obligations may be borne by remaining participating employers.
- If the Administrative Office ceased participation in the plan, it may be required to contribute an amount based on the underfunded status of the plan, referred to as a withdrawal liability.

The Plan’s participation in the plan for the years ended June 30, 2024 and 2023 is outlined in the following table. The information included in this table is as follows:

- The “EIN/Pension Plan Number” column provides the employer identification number (“EIN”) and the three-digit plan number.
- The Pension Protection Act of 2006 (“PPA”) zone status is based on information that the Plan received from the plan and is certified by the plan’s actuaries. Among other factors, plans in the red zone are generally less than 65% funded, plans in orange and yellow zones are less than 80% funded or are projected to become insolvent within 7 years, and plans in the green zone are at least 80% funded.
- The “FIP/RP Status” column indicates plans for which a funding improvement plan (“FIP”) or a rehabilitation plan (“RP”) is either pending or has been implemented.
- The column “Surcharge Imposed” indicates whether the Plan was required to pay a surcharge to the plan.
- The last column lists the expiration date of the collective bargaining agreement to which the plan is subject.

NOTE 7 - CONCENTRATIONS, RISKS AND UNCERTAINTIES

Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments in the near term could materially affect the amounts reported in the financial statements.

Contributions from one employer accounted for 11% and 15% of total contributions in 2024 and 2023, respectively.

The Plan's bank deposits are held by a financial institution the Board believes is credit worthy. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per financial institution. At June 30, 2024, the Plan had approximately \$1,994,000 of deposits in excess of FDIC insured limit.

The estimates for claims incurred but not paid, accumulated eligibility credits and postretirement benefit obligations are based on certain assumptions pertaining to interest rates, health care trend inflation and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 8 - POSTRETIREMENT BENEFIT OBLIGATIONS

The postretirement benefit obligation represents the actuarial present value of projected claims and expenses under terms of the Plan for employees' service rendered to the financial statement date, reduced by the actuarial present value of employer contributions expected to be received on behalf of active participants in future years and retiree self-pays. Postretirement benefits include future benefits expected to be paid to or for (1) current retirees and their beneficiaries and covered dependents, (2) active participants and vested terminees who are fully eligible for benefits and (3) participants who are not yet fully eligible for benefits. The postretirement benefit obligation represents the amount that is to be funded by contributions from participating employers and Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by actuaries and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money through discounts for interest and the probability of payment by means of decrements such as those for death, disability, withdrawal or retirement between the valuation date and the expected date of payment.

For measurement purposes, the assumed trend in health care cost trend rates used in the 2024 valuation ranges from 4.00% to 5.50% depending on the type of coverage and trends downward to 4.00% by 2030. These rates were revised from 4.00% to 5.75% used to measure benefit obligations at June 30, 2023 while also trending downward to 4.00% by 2030.

Health care cost trend rate assumptions have a significant effect on the obligations reported. A 1% increase in trend rates would increase benefit obligations at June 30, 2024 and 2023 by approximately \$8,479,000 and \$8,543,000, respectively.

The costs of postretirement benefits are shared by the Plan's participating employers and retirees. In addition to deductibles and copayments, retirees on average paid 49% and 50% of the estimated cost of post-retirement benefits provided by the Plan in 2024 and 2023, respectively.

The following significant assumptions are used in the valuations at June 30, 2024 and 2023:

Retirement Rates:	5% at 53 trending upward to 100% at age 65

The valuation at June 30, 2024 includes some actuarial assumption changes, the most significant being the increase in the discount rate to 5.25% from 5.00% reflecting the change in available rates of return from the prior year.

Retirement rate, mortality, turnover, and disability rate assumptions in the June 30, 2024 and 2023 valuations conform to assumptions used to estimate accumulated benefits in the U.A. Local No. 447 Pension Fund.

NOTE 9 - FAIR VALUE MEASUREMENTS

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions market participants would use in pricing the asset or liability.

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end based on closing market prices. Fair values of U.S. government securities are based on trading prices of similar securities with comparable rates and durations. Fair values of certificates of deposit are based on amortized cost. The following tables summarize Plan investments at June 30 based on the inputs used to value them:

NOTE 10 - PLAN TERMINATION

In the event of termination of the Plan, the funds of the Plan will be used for the exclusive benefit of participants under the Plan. At the expiration of the Trust, the Union and the employers may agree to the disposition of the portion of the Plan which is in excess of that required to pay all unpaid expenses and accrued benefits. Until such agreement is reached, the Trustees shall continue, after the expiration date, to carry out the provisions of this Plan (except with respect to the collection of future contributions) on the following basis:

1. All participants, then eligible for benefits, shall continue to remain eligible for benefits.
2. Benefits shall be paid out in accordance with the terms of the Trust.
3. The scale of benefits then in effect will be frozen and such benefits will be paid out to qualified individuals until, in the judgment of the Trustees, the available assets of the Plan are too small to warrant continuation of those benefits. In this case, residual monies shall be disbursed in accordance with provisions of existing law.

NOTE 11 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through March 25, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that require recognition or additional disclosures in the Plan's financial statements.
