We have performed audits of the accompanying financial statements of The Gillen Brewer School Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## 1. Description of Plan

The following description of The Gillen Brewer School Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined-contribution plan designed to meet the requirements of Section 403(b) of the Internal Revenue Code (the "Code") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### **Eligibility**

The Plan covers substantially all eligible employees of the Gillen Brewer School (the "School" or "Employer"). Employees are eligible to participate in the Plan after completion of three consecutive months of service and attainment of age 21. Effective July 1, 2023, employees who normally work less than 20 hours per week are not eligible to participate.

### **Contributions**

Participants may rollover amounts from other qualified plans. Each year, the Employer may make a discretionary nonelective contribution to the Plan. For the year ended June 30, 2024, the Employer made the discretionary nonelective contribution to each eligible participant equal to 4% of eligible compensation.

### **Participant Accounts**

Each participant's account is credited with employer contributions and the investment earnings thereon. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

### **Vesting**

Effective July 1, 2023, a active participants is 100% vested in his or her accounts including allocated earnings thereon at all times. For a participant terminated prior to July 1, 2023, the below vesting schedule will be applicable:

### **Forfeitures**

In the event that a participant terminates before becoming fully vested in his or her account balance, the non-vested portion of the participants' account balances will be forfeited as of the termination date. Forfeitures of terminated non-vested accounts will be used to reduce future employer contributions made to the Plan or used to pay any administrative expenses of the Plan. As of June 30, 2024 and 2023, unapplied forfeitures totaled \$16 and \$0, respectively. During 2024, \$22,040 forfeitures were used to reduce employer contributions.

## 1. Description of Plan (*continued*)

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account, in the form of a lump sum distribution, installment payments or an annuity distribution. A participant may request an in-service distribution once they have reached age 59 ½. A participant may also request for a hardship distribution. Effective July 1, 2023, the plan was amended to allow in-service and hardship distributions.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs relate to assets or liabilities that have little or no pricing observability as of the measurement date and are measured using management's best estimate of fair value.

### ***Investment Valuation and Income Recognition***

The TIAA Traditional Annuity Account is an unallocated contract. The account is segregated into non-benefit and fully benefit-responsive categories. The Plan only has the non-benefit-responsive investments contracts. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). Fair value approximates contract value for non-benefit-responsive categories of the account. Fair Value is derived from a discounted cash flow analysis and other factors. See note 4 for the valuation method. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded. The pooled separate account is valued at the NAV of units held by the Plan. The NAV, as provided by Teachers Insurance and Annuity Association of America ("TIAA"), is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### ***Investment Valuation and Income Recognition (continued)***

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Expenses relating to investment management are paid directly by the respective investment vehicle and are included as a reduction to net appreciation in fair value of investments. Other administrative expenses of the Plan are generally paid by the School.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 4, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends on investments for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and College Retirement Equities Fund ("CREF"), qualified institutions.

### ***TIAA Real Estate Account***

The TIAA Real Estate Account generally invests in real estate properties and real estate-related investments. The TIAA Real Estate Account's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. While redemptions from the TIAA Real Estate Account may occur daily, transfers out are limited to one per calendar quarter. There are no unfunded commitments as of June 30, 2024.

#### *TIAA Traditional Annuity*

The TIAA Traditional Annuity Account is comprised of six types of contracts. The fully benefit responsive contracts are: the Group Supplemental Retirement Annuity, the Supplemental Retirement Annuity, and the Retirement Choice Plus contracts. The non-benefit responsive contracts are: the Group Retirement Annuity, Retirement Annuity and Retirement Choice ("RC") contracts. The Plan utilizes the RC contract, which is reported at fair value. Unobservable inputs include the risk-adjusted discount rate applied and the range of significant input values are as follows: RC – 3.80%-6.75%.

Under the RC contract, lump-sum withdrawals are available only within 120 days after termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers under the RC contract must be paid in 84 monthly installments (7 years).

The contracts use the vintage method to credit interest to the TIAA Traditional Annuity Account. Vintages are time periods that represent when money was initially invested in the TIAA Traditional Annuity Account and corresponding interest rate during that distinct time period. The vintage method recognizes the fact that the level of prevailing interest rates available on new long-term investments will vary over time and that as the long-term investments in a specific vintage mature, they will be reinvested at different rates. When funds flow into the TIAA Traditional Annuity Account, they are immediately invested at the prevailing pay-in-rate for new money. The funds earn interest at the prevailing vintage rates. The vintage will always consist of two parts: the guaranteed portion and the discretionary portion. The guaranteed portion is 3% and represents the minimum amount of interest that will be credited to an account, regardless of the economic environment. The discretionary portion represents interest earned over and above the guaranteed rate.

The TIAA Traditional Annuity Account represents approximately 1% of the Plan's net assets available for benefits as of June 30, 2024 and 2023 and represents an obligation of TIAA to repay as amounts come due. The credit risk of the issuer, at June 30, 2024, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (Aa1 as of October 24), Standard and Poor's (AA+ as of July 2024), A.M. Best Company (A++ as of July 2024), and Fitch Ratings (AAA as of August 2024).

### 5. Plan Termination

Although it has not expressed any intention to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

### 6. Tax Status

On August 7, 2017, the Internal Revenue Service issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions however, there are currently no examinations for any tax periods in progress.

### 7. Party-in-Interest

Certain investments are managed by TIAA and CREF, the Plan's record-keeper and investment custodian. Accordingly, these transactions are considered party-in-interest transactions.

Certain employees of the School may also be participants in the Plan and perform administrative services to the Plan at no cost to the Plan.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to June 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
