INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hope Orthopedics of Oregon 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of August 29, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period ended August 29, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 29, 2024 and December 31, 2023, and for the period ended August 29, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 10 to the financial statements, the governing body of Hope Orthopedics of Oregon 401(k) Profit Sharing Plan approved a plan of liquidation effective December 31, 2023, and management determined liquidation is imminent. As a result, the Plan's financial statements for the period ended August 29, 2024, and year ended December 31, 2023 have been presented using the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Hope Orthopedics of Oregon 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan’s provisions.

General – The Plan was first established effective January 1, 1997 as The Willamette Orthopedic Group Retirement Plan. Effective January 1, 2016, which followed previous amendments and restatements, the Plan was amended and restated, and is now known as the Hope Orthopedics of Oregon 401(k) Profit Sharing Plan. The Plan is a defined contribution plan, which is qualified as a cash or deferred arrangement under Section 401(a) and 401(k) of the Internal Revenue Code (the “Code”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan covers all employees of Willamette Orthopedic Group, LLC (doing business as Hope Orthopedics of Oregon) and Willamette Surgery Center, PC who have completed one year of service and are age 21 or older. Notwithstanding the general eligibility requirements, these requirements shall be waived for eligible employees who are considered exempt employees under the Fair Labor Standards Act. The 12 owner members of Willamette Orthopedic Group, LLC are adopting employers. Willamette Orthopedic Group, LLC is the sponsoring employer and will be referred to hereafter as the Plan Sponsor. Employees governed by a union contract, independent contractors and certain certified athletic trainers are not eligible to participate in the Plan. Eligible employees can enter the Plan as a participant on the semi-annual entry dates of January 1 or July 1, upon meeting eligibility requirements.

The Plan was terminated effective December 31, 2023. See Notes 7 and 10 for additional information.

Contributions – The Plan provides for automatic enrollment by means of an Eligible Automatic Contribution Arrangement (an “EACA”). Covered Participants under the EACA will have 3% of eligible compensation automatically withheld and deposited as a pretax contribution into the Plan. EACA contributions are 100% vested at the time of contribution. Participants may also elect to contribute up to 100% of their compensation as a pretax or post tax (Roth) contribution, as defined in the Plan document, not to exceed statutory limits. Participants may also contribute amounts representing distributions from other qualified plans. Notwithstanding the catch-up provisions, the statutory limit on each participant’s contributions for calendar year 2024 was \$23,000.

The Plan provides a Safe Harbor non-elective contribution equal to 3% of eligible compensation. The Plan Sponsor may also contribute a discretionary non-Safe Harbor, non-elective contribution that is determined annually by its Board of Directors. For the period ended August 29, 2024 and the year ended December 31, 2023, the Board approved discretionary contributions totaling \$0 and \$892,949, respectively. These were allocated based on eligible participants’ allocation class as prescribed by the Plan documents.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Investment Elections – The Participants may choose any combination of investments as presented in Plan documents, which include options to choose from funds that are designed for specific risk tolerances. Participants can change investment combinations as often as permitted under the particular investment vehicle.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contributions, (b) Plan earnings (losses), (c) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

At August 29, 2024 and December 31, 2023, there were no unallocated employer profit sharing contributions nor unclaimed property amounts held by the Plan. When applicable, such amounts are subsequently allocated to participant accounts after each respective year-end. When applicable, the Great West Investments EI Fixed Account – Series I (Note 4) will hold unallocated employer profit sharing contributions and unclaimed property amounts.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Plan Sponsor's safe-harbor non-elective contributions plus actual earnings thereon. Vesting in the Plan Sponsor's non-safe harbor, non-elective contribution portion of their accounts is based on years of credited service. After two, three, four, five, and six years of credited service, the Plan Sponsor's contribution portion becomes 20, 40, 60, 80, and 100 percent vested, respectively, to the participant. Participants shall become 100% vested upon attainment of normal retirement age of 65, death, or disability.

Notes Receivable From Participants – Participants may qualify to borrow a portion of their vested account balance as specified in the Plan Agreement. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one to five years. The loan is secured by the vested balance in the participant's account and bears interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions for a period not to exceed five years, unless loan proceeds are used to purchase a principal residence. A loan will be in default as of the last day of the calendar quarter following the calendar quarter in which an unpaid installment payment was due.

Outstanding participant loans as of December 31, 2023, were repaid in full or deemed distributed as of the date of liquidation, August 29, 2024.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, rollover their account balance to another qualified plan or individual retirement account, or receive an annuity, as specified by Plan provisions. Qualifying hardship distributions may only be requested through the Plan Sponsor, are subject to administrative approval, and must comply with applicable IRS regulations.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Hardship distributions can be taken from the Plan by participants before being required to request a loan. Participants are required to prove financial need, and the extent of the distribution cannot exceed the financial need. Qualifying hardship distributions may only be requested through the Plan Sponsor, are subject to administrative approval, and must comply with applicable IRS regulations.

Mandatory force-out distributions can only be made if a participant's vested aggregate account on or after the date of termination of employment does not exceed \$5,000, which will be determined by including the participant's rollover contribution account. These will be treated as a lump sum or rollover as designated by the participant. If the participant makes no designation, the distribution will be made in a lump sum.

Forfeited Accounts – At August 29, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$75,125, respectively. Forfeitures may be used to pay administrative expenses of the Plan with any remaining amounts used to reduce employer contributions. During the period ended August 29, 2024 and year ended December 31, 2023, respectively, \$65,985 and \$5,422 forfeitures were used to reduce employer contributions or pay administrative expenses.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the liquidation basis of accounting. This included accruing estimated income and expenses of the Plan through liquidation, as well as estimated expenses and expected payments upon liquidation.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Shares of registered investment companies are valued at fair value based on published market rates. The collective trust fund is valued using the Net Asset Value Practical Expedient. See Note 3 for further discussion of fair value measurement.

Fair value of investments of the Plan are certified by the custodian (Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants – Notes receivable from participants are measured at amortized cost, which represent unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

Payment of Benefits – Benefits are recorded when paid. As of August 29, 2024, there were no distributions requested by participants, but not yet processed, that would require disclosure in these financial statements.

Expenses – Certain administrative activities are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Significant expenses paid for by the Plan were for recordkeeping, investment advising and custodial services. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of the fair value of investments.

Date of Management’s Review – Subsequent events were evaluated through January 31, 2025, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at August 29, 2024 and December 31, 2023.

Registered Investment Companies (Mutual Funds) – Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The following tables disclose the fair value hierarchy of the Plan’s assets by level as of August 29, 2024, and December 31, 2023:

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuations methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. GUARANTEED INVESTMENT CONTRACT

The Plan includes a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company of America (Empower), which is called the EI Fixed Account – Series I. Empower maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

NOTE 4. GUARANTEED INVESTMENT CONTRACT (CONTINUED)

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) Plan termination, (3) plant closings, (4) bankruptcy, (5) layoffs, (6) mergers, and (7) early retirement incentives. The Plan may cease contributions and participation in the contract by written notice to the issuer 90 days ahead of the contribution cessation date. The Plan will then elect a cessation option to transfer at contract value the holdings in the contract. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants. As of August 29, 2024, the contract was fully liquidated, and to the Plan Administrator's knowledge, assets were released at contract value (Note 10).

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average and actual yield earned by the Plan for the period ended August 29, 2024, and year ended December 31, 2023, was 1.45% and 1.23%, respectively.

NOTE 5. INFORMATION CERTIFIED BY THE CUSTODIAN

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, have certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits (in liquidation) as of August 29, 2024 and December 31, 2023, and related investment activity reflected in the statement of changes in net assets available for benefits (in liquidation) for the period ended August 29, 2024.

NOTE 6. PARTIES-IN-INTEREST

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged. Fees paid during the year to third party administrators or the trustees for services rendered by parties-in-interest were based on customary and reasonable rates for such services. These transactions qualify as exempt parties-in-interest transactions.

NOTE 7. PLAN TERMINATION

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts. See Note 10 for a description of the Plan termination effective December 31, 2023.

NOTE 8. TAX STATUS

On March 31, 2014, the Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401. The Plan has not received a determination letter specific to the Plan itself and the Plan has been amended since its adoption of the prototype plan for subsequent changes in applicable tax laws and regulations. However, the Plan administrator and the Plan's tax counsel believe that the Plan as designed was and continues to operate in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 29, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10. PLAN LIQUIDATION

Effective December 31, 2023, Plan management terminated the Plan after ceasing operations. Employees of the Plan Sponsor were offered continued employment with Salem Health as of the business closing date, September 28, 2023.

NOTE 10. PLAN LIQUIDATION (CONTINUED)

Participants were notified of the Plan termination and provided information regarding the Plan operations and distribution options. Those who had an account balance as of December 31, 2023, were allowed to take a lump-sum distribution of their account balance, rollover their balance to another eligible retirement plan, or rollover to an IRA of their choice. Responses from participants were required by August 9, 2024. Those who did not respond were subject to the force-out provision as described in Note 1 or had their funds transferred into a traditional IRA held in trust by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

During the period January 1, 2024 through August 29, 2024, lump sum and rollover distributions totaling \$23,829,253 were initiated, distributing the Plan's net assets available for benefits (in liquidation) and satisfying all of the Plan's accumulated plan benefits. As of August 29, 2024, the Plan had no remaining net assets available for benefits.
