Opinion

1. DESCRIPTION OF THE PLAN:

The following description of the Iron Workers Local No. 55 Profit Sharing Annuity Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a multi-employer defined contribution retirement plan which provides benefits for eligible participants who are members of Iron Workers Local No. 55 of the International Association of Bridge, Structural and Ornamental Iron Workers (Union). The contributing employers are primarily located in Northwest Ohio. Therefore, the plan is affected by the economic conditions of the region. Employees of participating employers may enter the Plan after meeting the eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Contributions are made by employers pursuant to terms and conditions of collective bargaining agreements with the Union, based upon negotiated rates per hour paid. Participants may also make elective deferrals in addition to the base contribution rate set forth in the collective bargaining agreement, up to the maximum percentage allowable not to exceed the limits of the applicable section of the Internal Revenue Code (IRC).

Vested participants may make rollover contributions to their accounts.

Participant accounts

Each participant's account is credited with the employer contributions earned by the participant and received by the Plan plus the participant's elective deferrals, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in the portion of the participant account that is attributed to employer contributions upon completion of at least 350 hours of service per year for two plan years with a contributing employer. Participants are immediately 100% vested in the portion of the participant account attributed to the participant's elective deferrals and any rollover contributions. The plan year is defined as a fiscal year beginning July 1 and ending June 30. There were no forfeited account balances available to offset administrative expenses at June 30, 2024 and 2023.

Investment options

Once participants become vested, they have the option to direct their investments based on the investment options established by the fund.

Benefits

Upon termination of services due to death, disability, retirement or termination of employment where benefits are vested, the participant may elect to receive one of the standard forms of payment: a joint and survivor annuity, an annuity contract or a lump sum distribution.

1. DESCRIPTION OF THE PLAN (CONTINUED):

Notes receivables from participants

Participants may borrow from the Plan within certain limits established under the Plan. The notes bear interest at rates fixed by the Board of Trustees, but in no event will the interest rate be less than the prime rate.

Notes are to be repaid within five years except for loans used to acquire a principal residence of the participant which may be repaid over up to a ten-year term. A participant's loan will be in default if the required payment is not made within 90 days of the date that it is normally due. This 90-day grace period is called the "Cure Period." If the participant fails to make-up the missed payment, plus all other outstanding payments, by the end of the Cure Period, then the outstanding balance will be considered a deemed distribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Reciprocity contributions

Participants of the Plan and participants of the benefit plans of other affiliated local unions may have temporary employment assignments outside the jurisdiction of their local union. Therefore, the Plan has entered into reciprocity agreements with other affiliated locals to ensure that employers contributions are forwarded to the benefit plans of the participants local union. Reciprocal contributions received and reciprocal contributions paid have been recorded on the statements of changes in net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Contributions

Contributions are accrued based upon employers' reporting of hours paid to participants. Contributions are net of reciprocity to other plans. Reciprocity contributions received were \$1,544,845 and \$1,012,163 for the years ended June 30, 2024 and 2023, respectively. Reciprocity contributions paid to other plans were \$66,484 and \$102,444 for the years ended June 30, 2024 and 2023, respectively.

Benefits

Benefit payments to participants are recorded upon distribution.

Employer and participant contributions receivable

Employer and participant contributions receivable represents amounts due from employers including those related to participant deferrals made prior to year end that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate revenue recognition for amounts due but erroneously unreported by employers.

Employer and participant contributions receivable from NWOA

Employer and participant contributions receivable from Northwest Ohio Administrators, Inc. (NWOA), administrative manager for the Plan, represents contributions received by NWOA and maintained in NWOA's cash concentration account until such time as they are transferred to the Plan's cash account. Interest is earned on amounts maintained in the cash concentration account.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Subsequent events

The Plan has evaluated subsequent events through March 19, 2025, the date the financial statements were available to be issued.

3. PLAN TERMINATION:

In the event the Plan is terminated, any obligations of the Plan would be paid and all remaining assets would be distributed to participants in the manner specified in the Plan document.

4. TAX STATUS:

The Internal Revenue Service has determined and informed the Plan by a letter dated January 21, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and related trust is tax-exempt.

5. INVESTMENTS:

The Plan's investments are held and administered by a bank trustee, John Hancock Trust Company, LLC, in accounts under agreements which grant discretionary power as to investment decisions (by the bank as investment manager) within prescribed limits designated by the Board of Trustees. Vested participants may direct the investment of their account balances into one of the available fund options providing for varying degrees of risk and expected returns.

6. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

6. FAIR VALUE MEASUREMENTS (CONTINUED):

Registered investment companies: Valued at the net asset value (NAV) of shares held by the Plan at year end. The funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the net asset value per share or unit. The NAV, as provided by the investment manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the partnership will sell the investment for an amount different from the reported NAV.

7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

This Plan is related through common management and trustees with Northwestern Ohio Administrators, Inc., which provides administrative and depository services to the Plan. Payment for these services (principally for salaries and operating expenses) are reduced by collections for liquidated damages and certain interest income. Included in the statements of changes in net assets available for benefits are gross administrative fees charged by Northwestern Ohio Administrators, Inc.

The Plan pays fees for several arrangements with service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
