### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Center for Family Support, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended June 30, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

### 1. Description of the Plan

The accompanying financial statements are those of the Center for Family Support, Inc. Retirement Plan (the Plan). The brief description of the Plan contained herein is provided solely for the purposes of general information and interested persons should refer to the Plan agreement for a complete description of the Plan's provisions. A copy of the Plan agreement can be obtained from the Center for Family Support, Inc. (the Center or Employer), which is the administrator of the Plan.

#### *General*

The Plan is a defined contribution plan designed to meet the requirements of Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan covers substantially all employees of the Center.

#### *Eligibility for Participation*

*Employee Elective Deferrals* - Employees are eligible to participate in the Plan immediately upon their employment. Non-resident aliens, employees subject to a collective-bargaining agreement, and independent contractors are excluded from participation in the Plan.

*Employer Contributions* - The Plan account of any employee who is 21 years of age and has 1,000-plus hours of employment each year, and who has attained one year of service, is eligible to receive Employer contributions from the Center.

#### *Contributions*

*Employee Elective Deferrals* - A participant of the Plan may elect to contribute from 1% to 100% of their eligible annual gross compensation, subject to limitations, as set forth by the IRC. Catch-up contributions are permitted under the Plan if a participant attains the age of 50 before the end of the Plan year. In no event may a participant's pre-tax contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). After-tax (Roth) contributions are allowed. The Plan includes an auto-enrollment provision in which participants have their deferral rate set at 2% of eligible compensation. Effective July 1, 2023, automatic escalations of 1% will be added to a participant's deferral percentage, up to 5%.

*Employer Contributions* - Employer contributions are determined on an annual basis at the discretion of the Board of Directors of the Center and are allocated to participants based on eligible compensation. The Center is not required to make contributions, and all contributions are subject to certain limitations. The total contributions to the Plan may not exceed the dollar limit for tax deferred contributions set by the IRC.

Employer contributions of \$1,729,124 were contributed to the Plan for the year ended June 30, 2024.

#### *Contributions Receivable*

The Employer contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Investment Options*

All of the Plan's investment options are fully participant-directed. Participants may direct the investment of their account balances into any of the Plan's available investment options with Mutual of America Life Insurance Company (Mutual of America).

### *Participant Accounts*

Participants are vested immediately in their contributions, plus actual earnings thereon. The activity in each participant's account includes (i) the participant's contribution, (ii) the Center's contributions, (iii) benefit payments or withdrawals, (iv) allocations of the earnings or losses on Plan assets, and (v) allocated administrative expenses, if any. Allocations are based on participant earnings, account balances, or eligible compensation, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Vesting in the Center's Employer contribution is based on years of credited service, as follows:

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. A participant may borrow a minimum of \$1,000 from the Plan in an amount that either (i) does not exceed the lesser of \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans from the Plan during the one-year period, as defined; or (ii) equals ½ of the participant's vested interest in the Plan. Repayments are made through payroll deductions, with payments to be made not less frequently than quarterly. A participant may have up to two loans outstanding. Generally, the term of the loan may not exceed five years. However, if the loan is for the purchase of a principal residence, the Center, as Plan administrator, may permit a longer repayment term up to ten years. Loans are secured by a participant's account and bear interest at a rate that is commensurate with current interest rates charged on similar loans by persons in the business of lending money at the time the loan is granted. As of June 30, 2024 and 2023, interest rates on loans outstanding range from 4.25% to 9.50% and 4.25% to 8.75%, respectively.

### *Payment of Benefits*

On termination of employment due to death, disability, termination, or retirement, a participant may elect to receive either a lump-sum amount or a joint or survivor form of annuity payment. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

### ***Forfeited Accounts***

At June 30, 2024 and 2023, forfeited non-vested accounts totaled \$113,029 and \$158,790, respectively. Forfeitures resulting from non-vested terminations are allocated subsequent to year-end to the remaining participants' accounts in the same manner as Employer contributions. The forfeiture account earned \$4,988 and had \$1,414 of forfeitures during the year ended June 30, 2024. During the year ended June 30, 2024, \$50,749 was reallocated to participant accounts.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements and supplemental schedules have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for the fully benefit-responsive guaranteed interest contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments, which consists of realized gains or losses and unrealized appreciation or depreciation on investments.

### ***Benefit Payments***

Benefit payments to participants are recorded when paid.

### ***Notes Receivable from Participants***

Notes receivable from participants are stated at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance

is reduced, and a benefit payment is recorded. There was \$134,475 of deemed loans during the Plan year.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Center. Expenses that are paid by the Center are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **3. Risks and Uncertainties**

The Plan is invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, credit, liquidity, and market perception risks. Due to the level of risk associated with any investment, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **4. Information Certified by Mutual of America**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of June 30, 2024 and 2023, net appreciation in fair value of investments, interest income, and interest income on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

### **5. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

*Pooled Separate Accounts* - These accounts are valued at their accumulation unit value (AUV) as a practical expedient that approximates fair value. The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund and the separate account charges (i.e., the daily asset charge). The Plan's investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments. The underlying funds of the pooled separate accounts are generally invested in registered investment companies whose investment strategies are to seek capital appreciation through investment in common and preferred stocks and debt securities.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments in pooled separate accounts have not been classified in the fair value hierarchy in accordance with Accounting Standards Update (ASU) 2015-07, *Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent)*.

The Plan had no financial assets that were measured at fair value on a non-recurring basis during the year.

### **6. Fully Benefit-Responsive Guaranteed Interest Contract**

The Plan entered into a fully benefit-responsive guaranteed interest contract with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan) and (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed interest contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Center, as the Plan administrator, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **8. Related Party and Party-in-Interest Transactions**

Plan investments are units of a general account and pooled separate accounts managed by Mutual of America, the custodian and recordkeeper of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. Such transactions, while considered party-in-interest under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Additionally, certain employees of the Employer, who are also participants in the Plan, perform administrative services for the Plan at no cost.

### **9. Tax Status**

The Plan relies on the opinion letter dated November 30, 2020 for the Mutual of America Life Insurance Company Non-Standardized Pre-Approved Profit Sharing/Money Purchase/Cash or Deferred Arrangement Plan, in which the Internal Revenue Service (IRS) stated that the form of the prototype plan is acceptable under the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is also subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **10. Late Remittances**

During the years ended December 31, 2021 and 2023, employee deferrals and loan repayments in the amount of \$197,733 were not remitted within the appropriate time period by the Plan sponsor.

These transactions constituted prohibited transactions, as defined by ERISA. The Plan sponsor is in the process of self-correcting these delinquent contributions and does not expect the lost earnings to be material.

The Center is responsible for any fines, excise taxes, and/or penalties or actions brought by the affected participants or regulatory authorities.

### **11. Subsequent Events**

The Plan has performed subsequent events procedures through April 3, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustment to the financial statements.
