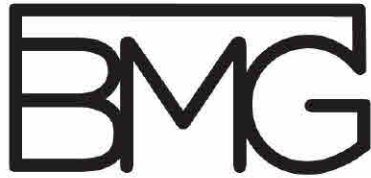

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Village South, Inc. Profit Sharing Plan

Opinion

We have audited the accompanying financial statements of Village South, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2024 and 2022, and the related statements of changes in net assets available for benefits for the year ended June 30, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Village South, Inc. NOTES TO THE FINANCIAL STATEMENTS
JUNE 30, 2024

1. PLAN DESCRIPTION

The following description of the Village South, Inc. Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are age eighteen or older. New participants may be admitted to the plan at the beginning of the Plan year on July 1st. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Company's Board of Directors can decide to contribute to the plan a discretionary amount it determines, which cannot exceed three percent of the total annual compensation. No discretionary contribution was made for the year ended June 30, 2024.

Participant Accounts - Each participant's account is credited with an allocation of (a) the company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting – On January 22, 2016, the governing body of the Village South, Inc. Profit Sharing Plan approved a plan of termination, see Note 3. As of that date, Plan participants became 100% vested in their account balances.

Payment of Benefits - Upon termination of service, a participant may be entitled to receive a distribution from the Plan as soon as administratively feasible following the Plan's next valuation date. Participants with account balances in excess of \$5,000 may elect to receive either a lump-sum payment equal to the value of the participant's vested account balance, or annual installments payments over a fixed reasonable period of years, not exceeding thirty (30). Any non-vested balances will be forfeited. Distributions may be made in cash or rolled over to an IRA or another qualified plan. The Plan also allows for hardship distributions under certain circumstances.

Forfeitures – Forfeitures of non-vested Company contributions are allocated to remaining active Participants based on the Participant's total annual compensation. There were no forfeitures allocated to Participants for the year ended June 30, 2024.

Plan termination – On January 22, 2016, the governing body of the Village South, Inc. Profit Sharing Plan approved a plan of termination, see Note 3. As of that date, Plan participants became 100% vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared under the liquidation basis of accounting.

Investment valuation and income recognition – All investments in equities, mutual funds and ETF's are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at the end of the year, as determined by the Trustee. The net increase or decreases in fair value in investments for the period reflected in the statement of changes in net assets available for benefits is the change between the fair value of investments held at year-end and cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

Investment income allocation – The Plan's investment income is allocated to participants' accounts on a pro-rata basis based on the individual participant's account balance at the end of each quarter.

Expenses – The Company pays all administrative expenses, except certain audit, investment and third-party administrator fees, which are paid for by the Plan.

Concentrations – All of the Plan's assets are held by its Trustee, Schwab Institutional.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Trustee to make estimates and assumptions that affect reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and uncertainties – The plan invests in various investment securities, primarily mutual funds, real estate investment trusts and real estate partnerships. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible those changes in the values of investments will occur in the near term and that these changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

3. PLAN TERMINATION

The governing body of the Village South, Inc. Profit Sharing Plan approved a plan of termination on January 22, 2016, and management determined liquidation is imminent. Final distributions will be determined based on all participants being 100% vested and will be made as soon as possible after the termination date. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting financial statements dated prior to June 30, 2016 to the liquidation basis used in presenting the 2024 and 2023 financial statements.

4. TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Internal Revenue Service Code Section 4975 and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan Sponsor believes that the Plan continues to qualify and to operate as designed.

The following tax years are open for examination by the Internal Revenue Service: June 30, 2024, 2023, 2021 and 2020.

5. FAIR VALUE MEASUREMENTS

The Plan accounts for its investments at fair value according to FASB Accounting Standards Codification (ASC) 820. The framework established by ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the Plan assets;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the Plan assets have a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

7. CONCENTRATIONS

As of June 30, 2024, the Plan held investments in four securities that totaled approximately 48% of Plan net assets. A significant decrease in the value of these securities would have an adverse effect on the Plan's net assets available for benefits.

The trustees have performed an evaluation of subsequent events up to the date the financial statements were available to be issued, which was March 19, 2025, and had determined that there were no events, other than those already disclosed, that would require modification of the financial statements or disclosure in the notes to the financial statements.
