### Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Reporting on Supplemental Information**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE FUND

The following brief description is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

*General*

Iron Workers Local 401 Supplemental Welfare Fund (the Fund) is a multiemployer defined benefit welfare plan. The Fund and related trust were established July 1, 2002 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. It was created to provide supplemental welfare benefits to retired members of Local Union 401.

The primary purpose and objective of the Fund is to provide reimbursement to eligible participants for medical premium payments under any self payment provisions of another plan of benefits or COBRA. The Plan also provides long term disability benefits to all eligible members.

The Plan document provides that upon the termination of the Fund, any monies remaining after the payment of all expenses and obligations shall be used in a manner best able to effectuate the purposes set forth in the trust agreement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The financial statements of the Fund have been prepared on the accrual basis of accounting.

*Contributions*

The trust agreement provides that employers make weekly contributions to the Iron Workers Supplemental Welfare Fund based on hours paid as set forth in the Collective Bargaining Agreement. Effective rates were \$1.00 per hour from July 1, 2022 through June 30, 2023 and \$1.40 per hour July 1, 2023 through June 30, 2024.

Employer contributions are based on remittances received during the year plus those received during the normal cut-off period. No provision has been made for delinquent employer contributions based on the uncertainty of collection.

*Cash and equivalents*

All highly liquid debt instruments with a maturity of three months or less are considered to be cash for the purposes of the statement of cash flows. The Fund maintains cash balances in a financial institution which is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At certain times, the amount of deposit exceeds the insured amount.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

*Property and Equipment*

The Fund follows the practice of capitalizing all significant expenditures for property and equipment at cost. Maintenance and repairs are charged to expense as incurred while major renewals and improvements are capitalized. Depreciation is provided over the estimated useful lives of these assets using the straight-line method.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues. Accordingly, actual results could differ from those estimates.

*Tax Status*

The Internal Revenue Service has determined and informed the Fund that the Fund is qualified and the trust established under the Fund is tax-exempt, under the appropriate sections of the Code. The Plan administrator and outside counsel believe that the Fund is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Fund was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

*Benefit Obligations*

The Plan's obligations for estimated claims incurred but reported is estimated based on historical percentages applied against current benefits paid.

*Subsequent Events*

Management has evaluated events and transactions occurring subsequent to year end for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue.

**3. INVESTMENTS**

The Plan's investments primarily consist of registered investment companies (mutual funds) and certificates of deposit. The following table presents the fair value of investments that represent 5 percent or more of total plan assets.

During the year ended June 30, 2024 and 2023 the plan's investments (including investments bought, sold and held during the year) appreciated (depreciated) in fair value by \$47,703 and \$43,580.

**4. SPECIAL EVENTS CONTRIBUTIONS**

Excess contributions collected by the Fund at special events are used for benefits payable to sick and injured participants.

**5. FAIR VALUE MEASUREMENTS**

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. An asset's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The three levels of the fair value hierarchy under ASC 820 are as follows:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets.

Level 2: Quoted prices in markets that are not active, or inputs that are observable either directly or indirectly, for substantially the full term of the asset.

Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e. supported with little or no market activity).  
The following table provides further detail of the Level 3 fair value measurements.

The Plan's investments are reported at fair value on a recurring basis in the accompanying statement of net assets available for benefits.

Administrative services are allocated in accordance with a formula adopted by the Trustees of the Supplemental Welfare Fund. For the years ended June 30, 2024 and 2023, expenses for clerical wages and fringe benefits were reimbursed to the General Fund in the amounts of \$61,829 and \$30,438, respectively.
