Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 10 to the financial statements, the Horizons for Homeless Children, Inc. 403(B) Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statements of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Horizons for Homeless Children, Inc. 403(B) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Horizons for Homeless Children, Inc. 403(B) Plan in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Horizons for Homeless Children, Inc. 403(B) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements related to our audits.

Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4a – Schedule of Delinquent Participant Contributions for the year ended June 30, 2024 and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of June 30, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to, and we do not express an opinion on the supplemental schedules referred to above.

Notes to Financial Statements

June 30, 2024 and 2023

1. *Description of Plan*

The following description of the Horizons For Homeless Children, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan covering substantially all employees of Horizons for Homeless Children, Inc. (the Agency). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Agency is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Participant Contributions

Each year upon hire, participants may contribute a percentage up to 100% of pre-tax annual compensation, subject to annual limitations, and become eligible for any Agency matching contribution after rendering three months of service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Agency may make matching contributions on behalf of eligible participants of the Plan on a discretionary basis. For 2024 and 2023, the Agency matched 50% of employee deferrals not to exceed 2% of compensation, or 1% of compensation for employees with deferrals greater than or equal to 2% of compensation. The Agency will decide each year whether or not to contribute and is not required to make matching contributions for any Plan year.

Participant Accounts

Participants direct the investment of their contributions and any Agency matching contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, the Agency's matching contribution, an allocation of the Plan earnings or losses, and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, Agency matching contributions, and actual earnings thereon.

1. *Description of Plan – continued*

Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65. Upon termination of service, a participant receives a lump-sum amount equal to the value of his or her account. There are also retirement benefits available upon late retirement, disability and death.

The Plan allows in-service withdrawals upon attainment of age 59 1/2. A participant may also request a withdrawal upon demonstration to the plan administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or his/her delegate.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their account, up to an amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the amount of their account balance. Interest is due on the outstanding principal balance at a rate commensurate with local prevailing rates and is credited back to the participant's account. As of June 30, 2024 and 2023, loans bear interest at 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions.

2. *Significant Accounting Policies*

Basis of Presentation

The financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Agency determines the Plan's valuation policies using information provided by investment advisors and the custodian. See Note 4 for discussion of fair value measurements.

2. *Significant Accounting Policies – continued*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator determines the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions are charged directly to the participant's account and are included in administrative expenses. The Plan's investment transaction fees are netted with investment return and are allocated to the individual participant accounts.

3. *Information Prepared and Certified by Custodian (unaudited)*

Certain information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Matrix Trust Company (the Custodian) as of June 30, 2024 and 2023.

4. *Fair Value Measurement*

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy give the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The mutual funds are measured using Level 1 inputs.

4. Fair Value Measurements – continued

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in changes in net assets available for benefits for the years ended June 30, 2024 and 2023, are reported in net appreciation/(depreciation) in fair value of investments.

For the years ended June 30, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers in or out of Level 3.

5. Party-in-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with the custodian are considered party-in-interest transactions. During the years ended June 30, 2024 and 2023, the participants paid the Custodian \$15,189 and \$15,350, respectively, consisting of loan and benefit payment processing fees.

6. *Group Annuity Contract with CMFG Life Insurance Company*

The Plan's CMFG Life Stable Value 424 contract (the Investment Contract) is a fully benefit responsive group annuity contract issued by CMFG Life Insurance Company (CMFG). CMFG maintains the contributions in a general account. The Investment Contract is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. CMFG is contractually obligated to repay principal and a specified interest rate that is guaranteed.

The Investment Contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the Investment Contract at June 30, 2024 and 2023, was \$218,324 and \$316,092, respectively. The interest rates are reviewed periodically but are guaranteed to equal or exceed the minimum guaranteed interest rate (not to be less than 1% annually) and not to change more frequently than is permitted under the contract.

Certain events limit the Plan's ability to transact at contract value with CMFG. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan, (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The Investment Contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

7. *Plan Termination*

Although it has not expressed any intent to do so, the Agency has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

8. *Income Tax Status*

The Plan, as a 403(b) plan, currently is not required to be submitted to the Internal Revenue Service (IRS) for determination. However, the Plan has been designed as a prototype plan from the Plan's third party administrator to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax exempt status for plan participants under Section 403(b).

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax provisions taken by the Plan and has concluded that there are no uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examinations for fiscal years prior to 2021.

9. *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

10. *Excluded Contracts*

The Plan's financial statements do not present information regarding certain investments in annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Management has elected to exclude those contracts and accounts and the related activity from the Plan's financial statements for purposes of the annual reporting requirements of ERISA in accordance with the transition relief provided by Department of Labor Field Assistance Bulletin 2009-02, *Annual Reporting Requirements for 403(b) Plans*. Presentation of this information is required by GAAP. The effects of this departure from GAAP on these financial statements are not reasonably determinable.

11. *Delinquent Participant Contributions*

During the years ended 2024 and 2023, employee contributions and participant loan payments were made through payroll withholdings according to the biweekly payroll schedule of the Plan Sponsor. Remittances of these amounts were made each pay period to the Plan. During 2024, the Plan Sponsor corrected delinquent contributions and participant loan payments totaling \$28 outside the voluntary fiduciary correction program.

12. *Subsequent Events*

The Plan has performed an evaluation of subsequent events through April 2, 2025, which is the date the financial statements were available to be issued. No material subsequent events have occurred since June 30, 2024 that require recognition or disclosure in these financial statements
