Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of Pathfinder Services Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pathfinder Services Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pathfinder Services Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pathfinder Services Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



1. DESCRIPTION OF THE PLAN

The following description of Pathfinder Services Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan sponsored by Pathfinder Services (Organization) that covers substantially all employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee oversees governance of the Plan, determines the appropriateness of the Plan's offerings, and monitors investment performance.

Contributions

Each year participants may contribute not greater than 100 percent of eligible compensation, as defined in the Plan. Participants may also make Roth contributions as defined in the Plan. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified plans. The employer may contribute to the Plan a discretionary matching contribution. For 2024 and 2023, the employer contributed dollar for dollar of each participating employee's elective contributions up to a maximum of 5 percent of each employee's eligible compensation. Additionally, the employer may contribute to the Plan an employer match contribution in the amount determined by the employer at its discretion. The allocation of the employer discretionary contribution is based on the ratio of a participant's compensation to total eligible compensation for the year. The Company may make discretionary contribution to the Plan but is not required to do so. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Forfeitures will be used to reduce future employer contributions. Additionally, the employer absorbs certain costs of plan administration.

Participant's Accounts

Each participant's account is (a) credited with the participant's contribution, an allocation of the Company's contribution and Plan earnings and, (b) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF THE PLAN (continued)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

On termination of service because of death or disability, participants are considered fully vested in their account and will receive a lump-sum payment equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Investment Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily. The Plan assets are invested in various accounts offered by Charles Schwab Trust Bank.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to 50 percent of their vested account balance with a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates based upon the prime rate. Principal and interest are paid ratably through payroll deduction.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of Plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of June 30, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Minimum Funding Requirements

Contributions to the Plan have been funded in accordance with the minimum funding standards of ERISA.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan's management has evaluated subsequent events through April 2, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the years presented and there were no changes in the methods used to measure fair value at June 30, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on the net asset value (NAV) provided by the transfer agents for the funds. The fair value of interest bearing cash is based on quoted market prices.

Gains and losses included in changes in net assets available for benefits for the years ended June 30, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended June 30, 2024 and 2023, there were no transfers of investments into or out of Level 3.

5. DEFERRED VESTED BENEFITS AND FORFEITED ACCOUNTS

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at June 30, 2024. There were unallocated assets of \$8 at June 30, 2024. Forfeitures will be used to reduce future employer contributions.

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at June 30, 2023. There were unallocated assets of \$987 at June 30, 2023.

6. PLAN TERMINATIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan terminations, participants will become 100 percent vested in their accounts.

7. TAX STATUS

The Plan has obtained a favorable tax determination letter from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

8. REPORTABLE TRANSACTIONS

There were no single transactions or series of transactions within the plan year in excess of five percent of the current value of the Plan assets that are required to be reported on the Form 5500.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of investment funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services in the amounts of \$1,604 and \$2,806 for the years ended June 30, 2024 and 2023, respectively. The Plan also paid investment advisory fees in the amounts of \$32,813 and \$17,393 and third party administrator fees in the amounts of \$15,788 and \$29,415 for the years ended June 30, 2024 and 2023, respectively.
